The Standardized File Structuring for the GOC

1.1 Welcome to the UN-SFS. This file is intended to replace the old *Standardized Research & Development* system, which was designed for use under the *Combined Research Program* that was recently nullified. The UN-SFS system is a massive overhaul to the previous CRP-SR&D system, with increased requirements placed on each File created by the UN, including the GOC.

1.2 Stated in 1.1, the requirements for each individual File created by the GOC have increased requirements. This means that each File is to have the following:

- Updated Headers & Footers.
- Proper Control Blocks.
- Proper Classification Bars.
- Proper Classification Reason & File Control Number(FCN).
- File Restriction Designation.
- Labeled Revisions
- Paragraph, and Statement Markings

Phonetic Alphabet Levels System(PALS)

2.1 The Phonetic Alphabet Levels System(PALS) is utilized by the United Nations GOC to classify documents. It is intended to be a 2-stage system, consisting of a descriptor, and a severity level between 1 and 9. This system is intended to be simplistic, vague, but allow much needed description of file contents before the individual begins reading.

File Classification Bars

3.1 The UN utilized the NATO Standard Document Classification System. The NATO SDCS has a simplistic method to classify documents, utilizing a “Classification Bar”, with a few different levels that can describe the severity of a file’s contents if leaked to the public, or rival OOI. These classification levels are based on how damaging the information presented could be if unauthorized disclosure occurs. It uses the following Classification Levels:

Unrestricted	UR	No-Threat, automatically Civilian accessible information.	#ffffff on #007a33
Restricted	RS	Limited-Threat, restricted to OOI / GOC only.	#ffffff on #00a300
Confidential	CF	High-Threat, potential to de-stabilize regional secrecy / stability.	#000000 on #fce83a
Secret	SC	Sub-Extreme-Threat, will de-stabilize regional secrecy / stability.	#ffffff on #ff8c00
Top Secret	TS	Extreme-Threat, potential to de-stabilize world secrecy / stability.	#ffffff on #c8102e
Clandestine	CD	Zenith-Threat, can cause total de-stabilization of world stability.	#ffffff on #222222

3.2 The Control Markings utilized by the UN is aimed at defining the use of a given document, who can see it, or if it has additional dissemination requirements. Control Markings are added onto a Classification Bar with // separating the classification and additional markings. (E.G Top Secret // NOFORN // SCI).

3.3 The following Control Markings are in active service:

SCI-XXX	<i>Sensitive Compartmentalized Information. Used for marking TS+ intranet electronic materials.</i>		
EYESONLY	<i>UNGOCC Eyes Only. Used for internal materials only.</i>	SCI-SI	<i>Special Intelligence.</i>
NOFORN	<i>No Foreign Dissemination. Used for Regional files.</i>	SCI-VRK	<i>Very Restricted Knowledge.</i>
FOUO	<i>For Official Use Only. Used for training files.</i>	SCI-SFO	<i>Sensitive Field Operation.</i>
NODIS	<i>Non-Disclosure Agreement.</i>	SCI-OCS	<i>Occult Cover Story</i>
SAP-XXXX	<i>Special Access Program-Abbreviation for SAP.</i>	SCI-TI	<i>Internal Information Information</i>

Authority & Command-Blocks

4.1 UN files are structured with a few distinct methods to identify official GOC files, increase efficiency while reading, and allow greater comprehension of a given topic. The GOC does this as other organizations may or may not read or review certain files, such as peace treaties, Parathreat information, or similar topics.

4.2 All UN files that are created are required to utilize the “Authority-Block” and “Command-Block”. These “blocks” are intended to describe a multitude of things, listed below:

- Which UN Region created the File
- Who Classified, and Declassified the File
- When the File was Classified, and when to Declassify a File
- The PALS Classification Level
- The reason for Classification
- Restrictions placed on the File
- The general contents of the File
- The general target of the File

4.3 The Authority Block is displayed on every page, either as a header, footer, or fit somewhere onto the page. The Command Block is displayed only on the first page, and has more detailed information and is to act as a cover-page description, essentially. The US, and UK servers use different GOC Regional codes; 7862 for the US, 6257 for the UK.

4.4 The Command Block is to describe the following information in this format; You may use a 8x2 table for it:

Classification-Declassification Reasons List

5.1 The United Nations utilizes a number of reasons as to why certain files are classified. These reasons are intended to protect the public, occult organizations, and the information itself from direct, or indirect harm. This begins our various types of generalized “classified reasons”. This list includes security programs, which an individual must be sworn into in order to access and read files marked with said information. For more information on why things are classified, read this [supplemental file](#) created & hosted graciously by the SCP Foundation:

EL	“ENDSEAL” Military Plans, Weapons Systems, or Operations
TK	“TALENT KEYHOLE” Imagery, Signal, or Measurement and Signature Intelligence Systems
SW	“STELLAR WIND” Unwarranted Surveillance Intelligence Systems
TZ	“TIER ZERO” Exoatmospheric Plans, or Operations
AG	“ARGON” Parathreat Information or Surveillance Systems
BV	“BELL VIEW” Special Observation or Assessment Team Information
BW	“BLACK WATCH” Strike Team Information
CY	“CANYON” Occult or Proliferation Group Security Program or Information
DU	“DAUNT” Reality Manipulation Security Program or Information
SW	“STORMY WEATHER” Infectious Parathreat Security Program or Information
FL	“FLAT LIQUID” Cybernetic, Mechanical, and Clockwork Security Program or Information
HP	“HOLLOW POINT” Computer or Digital Security Program or Information
SI	“SIMULACRUM” INSEX / EXSEC Operation Security Program or Information

File “GOC Wording” Format

6.1 The UN GOC utilizes a separate system of classifying paranormal, or anomalous entities. They use different words, description methods, etc., and as a result a properly written GOC document should be read differently to Foundation documents.

6.2 Obviously the UN GOC calls anomalies “Parathreats” or “Threat Entities”, there are classifications to these as well. The most base-line classification for a Threat Entity is as follows:

<i>Known Threat Entity</i>	<i>KTE</i>	<i>Known Entity, with on-going liquidation efforts(if possible).</i>
<i>Potential Threat Entity</i>	<i>PTE</i>	<i>Potential Threat Entity, with on-going Assessment efforts.</i>
<i>Unknown Threat Entity</i>	<i>UTE</i>	<i>Threat Entities whose existence can be inferred, but has not been directly found.</i>
<i>Liquidated Threat Entity</i>	<i>LTE</i>	<i>Threat Entities that have been liquidized, or have had their paranormality stabilized.</i>
<i>Spurious Threat Entity</i>	<i>STE</i>	<i>Threat Entities that have never existed within our dimension, or universe.</i>
<i>Non-Threat Entity</i>	<i>NTE</i>	<i>Non-Paranormal Entity, usually after further assessment or scientific breakthrough.</i>
<i>Person of Interest</i>	<i>POI</i>	<i>Non-Paranormal Person-of-Interest, wanted due to involvement with Parathreat(s).</i>

6.3 The above classifications are usually followed by additional markers, with certain words used to describe an entity further, such as if it’s a humanoid, what powers it has, etc. Those Threat Entity Markers(TEMs) are as follows:

Type-White	<i>Pre / Post-natural Mutation. Those that receive powers during or after birth</i>	Type-Pink	<i>Human-hybrid with another species, paranormal or otherwise.</i>
Type-Silver	<i>Infectious Hazard. Those that host and spread disease easily.</i>	Type-Purple	<i>Soul Manifester. Those who summon spirits. Necromancers.</i>
Type-Beige	<i>Paranormal Dismembered Body Parts.</i>	Type-Cyan	<i>Spectral Entity, such as a ghost or spirit.</i>
Type-Yellow	<i>Shapeshifter. Those that can change their appearance, at will or otherwise.</i>	Type-Blue	<i>Thaumalogies, or Thaumaturgist. Wizards or Witches.</i>
Type-Ochre	<i>Narrative Manipulator, and / or pataphysical entity.</i>	Type-Indego	<i>Cyborg, those that modify their body with advanced technology, paranormal or otherwise.</i>
Type-Red	<i>Regenerator. Those that can regenerate themselves.</i>	Type-Grey	<i>Re-Animated, post-mortem entity, such as Zombies or Skeletons.</i>
Type-Green	<i>Reality Bender, or those with ontokinesis.</i>	Type-Black	<i>Demigod or Deity. Hyper-ontokinesis link or ability to control it extraordinarily well.</i>

Field Document Writing

7.1 The In-Game document system is very finicky, and generally makes writing proper, aesthetically pleasing documents quite difficult. I highly recommend following my in-game document format, however you may make your own format as long as it contains the Command Block on the first page, and has a File-Control Number or Public-Control Number(depending on who should be reading it).

7.2 The main reason I give this freedom is because it's extremely annoying spending 5 to 10 minutes formatting a document, only for it to get scrapped anyway. I recommend not deleting any already formatted document drafts, and instead turning them into "templates" for later use. You will thank me.
