**RE:** Overview of the Upcoming Vote-a-rama

---

**STATE OF PLAY:**

Last night, the text of Republicans' One Ugly Betrayal bill was released. You can read the text [HERE](#).

Over the past two weeks, the bill has undergone the Byrd Bath process, where both sides were given a chance to litigate specific provisions within the bill. Throughout this process, we were handed quite a few victories, and were able to get multiple provisions knocked out of the bill. In an attempt to salvage many of these provisions, Republicans hastily re-wrote many of their provisions to make them compliant with the Byrd rule.

Now that the Senate substitute text has been released, we are waiting on a vote on the motion to proceed to the bill **at a time to be determined**. Once the Senate votes on this procedural motion, there will be 20 hours of debate, equally divided, between both sides. Senate Democrats will use up our 10 hours of debate while Republicans are likely to give back most of their time. During the debate time, we will highlight the following themes:

- **Attacks on Healthcare**
- **Skyrocketing Prices & Gutting Good-Paying Jobs**
- **Tax Cuts for the Wealthy**
- **Corruption & Chaos of the Trump Administration**
- **Exploding the Debt**

During this vote-a-rama, members will introduce substantive amendments, which will seek to make changes to the bill. Remember that reconciliation is a majority driven process, so even if an amendment were to pass during vote-a-rama, Majority Leader Thune can propose a wraparound amendment that strips it from the final bill before final passage. As a result, our goal is to put Republicans on the record for the harm that they are looking to cause with this bill.

During the amendment process, we will focus on five key themes:

- **Attacks on Healthcare**
- **Skyrocketing Prices & Gutting Good-Paying Jobs**
- **Tax Cuts for the Wealthy**
- **Corruption & Chaos of the Trump Administration**
- **Exploding the Debt**

From the start of the vote-a-rama, you will be receiving updates from me, that will include timely floor information, as well as amendment tracking in real time. - Motion to invoke cloture on the nomination of Paul Dabbar, to be Deputy Secretary of Commerce **(56-42)**.
- Confirmation of the nomination of Paul Dabbar, to be Deputy Secretary of Commerce **(56-40)**.
- Motion to invoke cloture on the nomination of Kenneth Kies, to be an Assistant Secretary of the Treasury **(53-44)**.
- Confirmation of Kenneth Kies, to be an Assistant Secretary of the Treasury **(53-45)**.
- S.J.Res.59, to direct the removal of United States Armed Forces from hostilities against the Islamic Republic of Iran that have not been authorized by Congress **(47-53)**.
