

Privacy Policy

If a user submits a refund request for an in-app purchase, we reserve the right to share relevant consumption data with Apple. This may include: the time elapsed since installation, total time spent using the app, an anonymous account identifier, whether the refunded purchase was fully used, whether it included a trial period, the total amount spent, and the total amount previously refunded.

This Privacy Policy explains how we collect, use, disclose, and protect your information when you use our mobile application. This app is developed by Maika Kulnaru. By using the app, you agree to the collection and use of information in accordance with this policy.

Information We Collect

We may collect certain information from your mobile device, including but not limited to:

Device and Usage Information:

This may include details specific to your device such as:

Device make and model

Operating system and version

Advertising identifiers (e.g., IDFA or Android Ad ID)

Device language and region settings

Mobile network information

App usage data (e.g., features used, session length, interaction frequency)

Notification interaction data

Signal strength (WiFi or Bluetooth), temperature, battery level, and other technical metrics

Location Information (if permission is granted):

We may collect location data to provide location-based features or services. You can enable or disable location services at any time through your device settings.

How We Use the Information

We use the information collected to:

Operate, maintain, and improve the app and its features

Provide personalized content and user experience

Offer customer support and respond to inquiries

Notify users about app updates, new features, or policy changes

Support business operations, including analytics and security

Facilitate relevant communications based on your interaction with the app

Display localized content and services based on your location

Comply with legal obligations and protect legal rights

We only use your information for the purposes described in this policy or as otherwise disclosed to you and to which you provide your consent.

Retention of Data

We retain your information for as long as the app is installed on your device or as necessary to provide services to you.

If you uninstall the app, we will remove your personal data within a reasonable timeframe, except where retention is legally required or necessary for dispute resolution, auditing, or enforcing our agreements.

Cookies and Tracking Technologies

We do not use cookies or similar tracking technologies within the mobile application.

However, our third-party partners may use similar technologies in connection with services they provide (e.g., analytics or advertising), subject to their own privacy practices.

Information Sharing

We may share collected information with trusted third-party service providers and business partners who help us operate the app and deliver related services. These partners are contractually obligated to

use the data only in compliance with applicable laws and for authorized purposes.

Third parties may also use the data for purposes such as:

- Enhancing their own services or platforms
- Serving tailored ads and recommendations based on your interactions and location
- Conducting analytics or performance metrics
- Supporting additional services with your consent

We do not sell, trade, or otherwise transfer your personal data to outside parties without your consent, except as required by law or as outlined in this policy.

Children's Privacy

The app is not intended for use by children under the age of 13. We do not knowingly collect personal information from children. If we become aware that such data has been collected, we will take steps to delete it promptly.

Security

We take appropriate technical and organizational measures to protect the confidentiality, integrity, and availability of your data. However, no method of transmission over the Internet or electronic storage is completely secure. We cannot guarantee absolute security.

Your Rights and Choices
