1. Stages of Development

After a commission has been accepted, these are the following stages:

- **Stage 1:**
 - 50% of the agreed price must be paid.
 - The client is presented with composition and character sketches and has to choose which one to go forward with. Big alterations are okay at this stage.
- **Stage 2:**
 - After the client has agreed on the direction, the commission is further developed.
 - The client will receive *at least* 3 shows of progress and is able to request small alterations.
 - Big alterations will be individually priced in addition to the total agreed price. Price is discussed by both parties and is in accordance with individual cases. Big alterations can be: change of clothing, change of pose, change of expression, change of background/scene (if applicable), etc.
 - After corrections, the piece is polished.
- **Stage 3:**
 - The client is sent a preview of the final product.
 - The remaining 50% of the total price (+ any priced alterations) must be paid.
 - The client receives the full-quality commission in the desired format.

3. Payment

- Prices are established before work begins.
- Payment is accepted through:
 - Revolut @yanaz70hq
 - PayPal yanigma.nova@gmail.com
 - Bank Transfer details upon request
- 50% of the agreed price must be paid before start of work.
- The remaining 50% + cost of agreed additional alterations (if applicable) is paid before the final product is sent.
- Prices are listed in the agreed currency and do not include any applicable taxes.
- Currency exchange must always amount to the listed value.
- Platform taxes (Paypal and Bank Transfer) are not included in the price and must be paid additionally from the client.
- Payment in any alternative form, such as gift cards, is not encouraged but can be considered.

4. Alterations

- Alterations are accepted during [Stage 1](#).
- Significant changes after approval of the sketch during [Stage 2](#) may incur additional fees, as described in [Prices](#).
- Requests that substantially alter the original concept may not be accepted, or may be priced according to [Prices](#).

5. Turnaround Time

- Standard Turnaround Time is **two weeks**.
- Estimated completion times vary depending on the complexity of the commission and current workload, all of which will be communicated.
- Delays may occur due to illness, emergencies, or unforeseen circumstances. If significant delays occur, I will communicate them as soon as reasonably possible.
- Rush commissions are accepted and priced according to [Prices](#), if the desired deadline is reasonable.

6. Copyright, Ownership and Commercial Use

Unless otherwise agreed in writing:

- I retain the copyright to all artwork I create.
- The client receives a non-exclusive license to use the commissioned artwork for personal purposes.
- The client may not claim authorship of the artwork.
- The client may not alter the artwork in a way that misrepresents it as my work.
- The client may not involve the artwork with any AI service.

Unless the client requests confidentiality beforehand, I reserve the right to:

- Display commissioned artwork in my portfolio.
- Post the artwork on social media and create content.
- Include the artwork in promotional materials and self-promotion.

Commercial rights are **not** included unless explicitly purchased or agreed upon in writing.

If artwork is intended for commercial use (including merchandise, advertising, branding, streaming assets, publications, games, or monetized content), commercial licensing must be discussed and agreed upon before work begins.

Commercial pricing will differ from personal-use pricing.

7. Refunds and Cancellation

- **Before Work Begins**

The client may cancel the commission for a full refund *if work has not yet started*.

- **After Work Has Started**

If the commission is canceled after work has begun, there will be no refund. If commission is in a late development stage, the client is obliged to pay 75% of the remaining total.

- **Artist Cancellation**

If I am unable to complete a commission that has been *fully prepaid*, I will issue either:

- a full refund (if little or no work has been completed), or
- a partial refund based on completed work.

8. AI Policy

My artwork may NOT be used to train, fine-tune, or improve artificial intelligence or machine learning systems without my explicit written consent.

The artwork may NOT be uploaded to AI image-generation services for replication, style training, or similar purposes without permission.
