Issue of Emphasis: Public Education

Enhance and protect all levels of funding for public schools (including through associated tax policy), provide civics education, oppose shifting public dollars to vouchers for private schools.

How have the positions been changed?

- The Fiscal Policy/Tax Policy position has dropped references to policies that have been adopted.
- The Public Education position re-ordered statements and reduced duplication in order to achieve clarity and brevity.

Positions in brief:

FISCAL POLICY TAX POLICY The League of Women Voters of North Carolina believes that a state and local system of taxation should provide for adequate funding of needed services, be broad-based, and incorporate standards of equity, adequacy, collectability, economic effect, transparency, and consistency.

PUBLIC EDUCATION The League of Women Voters of North Carolina aims to promote quality public education for all students through the secondary level. The LWVNC supports the Leandro Comprehensive Remedial Plan priorities. The LWV opposes shifting public dollars from public schools to private and for-profit school entities.

NC Tax Policy Fails Public Education

North Carolina's current tax policy undermines public education. By favoring low/flat income tax rates, reducing/eliminating corporate tax contributions, and relying heavily on sales and property taxes, the state has created a regressive system that disproportionately burdens low-income families—and fails to deliver the investment needed to educate the next generation.

This approach leaves our schools underfunded and our children underserved. More than **43%** of NC households earn less than a living wage (<u>myFutureNC.org</u>), yet our tax system asks them to contribute more, proportionally, than the wealthiest. Meanwhile, critical investments in teacher pay, school facilities, and student support go unmet.

Research consistently shows that **increased state education funding leads to better outcomes**—higher test scores, graduation rates, college attendance, and long-term earning potential. North Carolina has a roadmap for progress: the **Leandro Comprehensive Plan** (NCBudget.org/EveryChildNC.org)., a court-ordered solution rooted in equity and effectiveness. But until the state fully funds this plan, those benefits will remain out of reach.

The **Opportunity Scholarship Program** (school vouchers) worsens the situation by siphoning public dollars into private education—without public oversight. This is especially harmful in rural and small districts, where private alternatives are scarce and public schools lose resources without any real "choice" created.

It doesn't have to be this way. North Carolina must:

- Halt further cuts to individual and corporate income tax rates.
- Restore a graduated income tax structure based on ability to pay.
- Reinvest in public education at levels that match our aspirations for economic growth and social equity.
- Reform the school funding formula to ensure that low-wealth districts get the resources they need.

A regressive tax system that underfunds education is not pro-growth—it's self-defeating. Prosperity begins in the classroom. A strong public education system benefits every student, strengthens our workforce, and drives a healthy economy for all.
