JUDGE INFORMATION

Thank you for being here! We cannot run this tournament without you. Sincerely, we appreciate you giving your time and talents to these students---especially during a trying season, to say the least. We hope you have a great experience. Here a few key reminders:

RESOLUTION

The United States federal government should enact substantial criminal justice reform in the United States in one or more of the following: forensic science, policing, sentencing.

COACHES: Review the protest protocol procedures (OSDA web site) before trying to address an issue with Tournament Officials. To raise awareness of a particular issue, first discuss the issue with the Ombudsperson (Rich Kawolics, Cleveland). Ombuds will have its own Utility Room via SpeechWire/NSDAC.

Coaches, if your competitor has an issue outside the realm of OSDA protocol or tournament operations, we do have equity liaisons who will have access to a SpeechWire/NSDACampus utility room throughout the tournament. If a student needs to contact said individual/s, the student should notify someone in the "Technical Assistance/Issues Room."

NON-COACH JUDGES: Refer any complaints/concerns from competitors to the proper coach for that/those competitor(s).

ALL JUDGES: While your decisions are subjective, remember to judge all competitors by the same objective standards to determine your winner. Don't be the third debater in the round, so to speak, and do not favor the competitor whose suit you like better, or whose position you agree with personally (unless, of course, that individual happens to have fairly earned the victory). While presentation style can be influential to your decision, we ask you to judge on the merits equitably and objectively, for every speaker, keeping in mind that students are doing their best with what they have. Thank you.

A FEW NOTES:

Judges, please be aware of the fairness-in-judging language on each round's ballot before the round begins.

If you would like to hear more about implicit bias and its potential effect on judging rounds, a link to the video shown by the Cleveland District (before tournaments) can be found on the OSDA State Finals page. Some students may list pronoun preferences in their ZOOM screens; this is not required for students or judges, and not everyone will do this. Please avoid negatively judging a student for not having pronouns listed; similarly, please avoid negatively judging a student for having pronouns listed. On your ballots, if you prefer to avoid pronouns altogether, you can just stick to terms like "A" and "N," or "Pro" and "Con," or "Speaker 1" and "Speaker 2," etc.

JUDGES AND COACHES: Refer to the OSDA Online Tournament recommendations for further guidance, if needed; but keep in mind that these merely are recommendations; these are not protestable violations.

For this tournament, OSDA voted to allow debate judges (2P, PF, LD) to grant up to 15 minutes of technology-related grace for the round, regardless of speaker, if the judge deems it necessary. Ultimately this falls under judge discretion, but try to be fair and equitable with grace in such circumstances. Once the 15 minutes have expired, time should not be stopped for further technological issues, regardless of circumstance. HOWEVER, judges should not end a round due to technical issues; if you a feel a round cannot continue because of technical issues, please contact the tab room to resolve this matter.

Evidence controversies are up to judge discretion. If you need to discuss with another judge in the round, after competitors have left the room, avoid discussing your decision itself. OSDA officials reserve the right to sanction violating schools.

DO NOT DISCLOSE YOUR DECISION OR RATIONALE TO COMPETITORS (or to anyone else!) AFTER THE ROUND. After the tournament concludes, feel free to discuss particular rounds with coaches/competitors---but not during the tournament.

Do NOT ask students to disclose their school affiliation. And if you know it already, do not publicize it to other judges.

On your SpeechWire e-ballots, try to explain at least 1-2 reasons why you're voting the way you are, and remember to assign points. (Remember to submit points first; then you can finish your comments.)

Speaker point values should not dip below 20. At this level, everyone is worthy of at least a 20. Be mindful of 30s, too, especially in early rounds.

Make sure you justify your Low Point Win on the e-ballot IF you have one; and don't have one unless it's an absolute necessity.

Please stay in the virtual Judge Lounge after postings until a Tab Staff member announces that the round is complete, just in case we need to plug you for another judge.

Also, if you receive a blast to judge a round, do not wait for the originally scheduled time; go to your round immediately.

Please do not leave the tournament without first alerting/clearing your departure with Tab Room \rightarrow your school/team could be fined otherwise.

TIPS FOR COMPLETING THE BALLOT OPTIMALLY:

- 1.) Please DO click the start round button as soon as you have confirmed that everyone is present and tech-ready. DO NOT click that button if anyone is missing or if there is a tech issue. Tab staff will be popping in during the round to make sure all is well. We will do so discreetly. There is no need to acknowledge our presence. We will prioritize rounds that have not started as indicated by your not clicking the start round button, but we will get to all rooms.
- 2.) Once the round has begun, be encouraged to write constructive comments on the ballot throughout the round. Writing a "reason for decision" (RFD) is vital on the ballot. Please start that RFD with one of these phrases: "The Affirmative [and code] won because . . . " or "The Negative [and code] won because . . . " or "The PRO [and code] won because . . . "

- 3.) Once you have written comments, speaker points, AND an RFD, then click the "submit ballot" button. If you do not submit the ballot, the tournament will grind to a halt as we wait for you to do that. You are able to go back to the ballot later to edit comments (not the rfd).
- 4.) As soon as you have submitted your ballot, please return to the judge's room. Do not forget to check your email for the next round assignments).
- 5.) If you have submitted your ballot and have not yet received an assignment for the next round, please stay in the judges' lounge. In case of a missing judge or a judge conflict, we will need to find unassigned judges to take those rounds. We can only find you in the judges' lounge.

STUDENT INFORMATION

Congratulations on making it this far!

Get to your rooms ASAP once you receive your notification/rounds have been posted and blasted. Do not wait for the scheduled time; head to your round immediately unless otherwise notified. (NOTE: If you have not signed up yet for SW blasts, do so NOW.)

Remember proper electronic device etiquette:

- o No recording during rounds. Do not record your screens or your audio.
- o You may time yourselves. Don't make distracting noises while opponents are speaking, which includes you speaking to a partner.

If you have not yet, check the OSDA web site for paradigm sheets. Go to the State Finals page to find these.

Do not disclose your school affiliation to your judges.

Judges should NOT disclose their decisions after a round, and they're being told not to do so. DO NOT ASK THEM TO DISCLOSE. OSDA Tab Staff reserves the right to sanction individuals and schools who violate these terms.

Be mindful of when rounds begin, and be on time. Be early, if you can.

If an opponent does not arrive immediately, STAY IN THE COMPETITION ROOM. Tab Staff constantly will monitor rooms once rounds are posted, and will enter rooms to rectify any issues, if necessary. Thank you for your patience.

If a Tab Staff member enters the competition room at any point, you do not need to acknowledge her or his presence. It may just be to check that the round has started. If there is an issue that needs attention, the Tab Staff representative will initiate conversation when deemed appropriate under the given circumstances.

If you have a complaint or concern, tell your coach. Your coach then can decide whether or not to protest to our Ombudsperson, who then can consult Tab Staff/OSDA officials.

Also, if you have an issue that is outside the realm of OSDA protocol or tournament operations, we do have equity liaisons who will have access to a SpeechWire/NSDA Campus utility room throughout the tournament. If a student needs to contact said individual/s, the student should notify the "Technical Assistance/Issues Room."

GENERAL INFORMATION

Time limits for session length shall not be altered by students, scorers, or parliamentarians for any reason.

An agenda of legislation will be set under the guidance of the Congressional Debate State Tournament staff.

In order to begin debate on a piece of legislation, there must be an authorship or sponsorship speech. As legislation is district-sponsored, authorship speeches will be awarded by District. If no one chooses to be recognized for authorship, a sponsorship speech may be delivered by any member of the chamber, provided this recognition follows the recency guidelines where more than one person volunteers. Should no student seek recognition for the authorship or sponsorship, the chamber should move to lay the legislation on the table until such time that a student is prepared to introduce it.

Authorship or sponsorship speeches and the first negative/opposition speech are allotted up to three minutes, followed by two minutes of direct questioning (in 30 second increments) by other delegates. Subsequent speeches shall be called for following an alternating PRO then CON rotation with a one minute direct questions period. This cross-examination shall be a factor in the scoring of a speech.

Following the first two speeches on legislation, the presiding officer will alternately recognize affirmative and negative speakers, who will address the chamber for up to three minutes followed by one minute of direct questioning by other delegates. If no one wishes to oppose the preceding speaker, the presiding officer may recognize a speaker upholding the same side. When no one seeks the floor for debate, the presiding officer may ask the chamber if they are "ready for the question," at which point, if there is no objection, voting may commence on the legislation itself. There is no "minimum cycle" rule; however, if debate gets "one-sided," the chamber may decide to move the previous question.

In the event a student speaks on the wrong side called for by the presiding officer and the error is not caught, the speaker shall be scored and the speech shall count in recency, but the speaker must be penalized at least three points for not paying close attention to the flow of debate. In the event a student speaks on an item of legislation not currently being debated, said speech shall count in recency, but zero points shall be awarded.

Speaking order shall be determined by precedence and then recency which remain in place for the entire session and are reset for each subsequent round.

Each speech and each Presiding Officer performance shall be scored on the basis of one (1) through six (6) points by the Official Scorers (a rank of six points is the best). These scores will be used to award students with NSDA competition points.

No scorer may be placed into a chamber that has one of her/her students. The goal of placing scorers into chambers is to vary the scorers to represent the OSDA Districts as best as possible.

Visual aids are permitted in Congressional Debate, provided that they do not require electronic retrieval devices in the chamber.

The length of the preliminary, quarterfinal, semifinal and/or final sessions may be adjusted by the Board of Directors if the time constraints of the Tournament require.

State Tournament chambers are closed. Legislators should ask permission (by moving a personal privilege) to leave and enter the chamber while it is in session, but should not interrupt a speaker who is addressing the chamber.

Preliminary sessions

There shall be two preliminary sessions. The first session shall last two and one-half hours. The second session will last two hours. During the first half hour of the first session, Presiding Officers shall be elected. For the preliminary sessions, two Presiding Officers shall be elected by each chamber for each session to serve for approximately one hour each. The candidate receiving the most votes shall have priority over which session he/she shall preside. The candidate receiving the next highest votes shall have the next priority, and so on. The Presiding Officer shall be scored for his/her performance in his/her session in the same manner as the other legislators in his/her chamber.

Twelve legislators in each preliminary session chamber is the maximum number.

There shall be four (4) scorers in each preliminary session chamber in addition to the parliamentarian who will score. All scorers shall remain in one chamber for preliminary sessions.

At the conclusion of the preliminary sessions, judges' preferential ranking (1-10) shall be used to advance, in equal numbers, the top legislators from each chamber, so that up to ninety-six (96) legislators shall advance to the quarterfinal session. Legislators shall be placed into quarterfinal session chambers using the "snake" method, based on preliminary session ranks.

Quarterfinal Session

There shall be one quarterfinal session. This session shall last two and one-half hours. There shall be no more than ninety-six (96) legislators in the quarterfinals. Quarterfinalist legislators shall be apportioned equally in each of 8 quarterfinal chambers.

For the quarterfinal session, three (3) Presiding Officers shall be elected by each chamber to serve for approximately fifty minutes each. The candidate receiving the most votes shall have priority over which hour he/she shall preside. The candidate receiving the next highest votes shall have the next priority, and so on. The Presiding Officer shall be scored for his/her performance in his/her hour in the same manner as the other legislators in his/her chamber.

There shall be five (5) scorers in each quarterfinal session chamber and a parliamentarian who also scores.

At the conclusion of the quarterfinal session, judges' preferential ranking (1-8) shall be used to advance, in equal numbers, the top legislators from each quarterfinal chamber, so that up to forty-eight (48) legislators shall advance to the semifinal session. Legislators shall be placed into semifinal session chambers using the "snake" method, based on quarterfinal ranking.

Semifinal Session

There shall be one semifinal session. This session shall last three hours. There shall be no more than forty-eight (48) legislators in the semifinals. Semifinalist legislators shall be apportioned equally in each of four semifinal session chambers.

For the semifinal session, three (3) Presiding Officers shall be elected by each chamber to serve for approximately one hour each. The candidate receiving the most votes shall have priority over which hour he/she shall preside. The candidate receiving the next highest votes shall have the next priority, and so on. The Presiding Officer shall be scored for his/her performance in his/her hour in the same manner as the other legislators in his/her chamber.

There shall be five (5) scorers in each semifinal session chamber and a parliamentarian who also scores.

At the conclusion of the semifinal session, judges' preferential ranking (1-8) shall be used to advance, in equal numbers, the top legislators from each semifinal chamber, so that the top sixteen (16) semifinal legislators shall advance to the final session.

Final Session

There shall be one final session chamber. The length of this session shall last three hours. There shall be no more than sixteen (16) legislators in the final session.

For the final session, three (3) Presiding Officers shall be elected by the chamber to serve for one hour each. The candidate receiving the most votes shall have priority over which hour he/she shall preside. The candidate receiving the next highest votes shall have the next priority, and so on. The Presiding Officer shall be scored for his/her performance in his/her hour in the same manner as the other legislators in his/her chamber

A Best Presiding Officer Award shall be voted upon by the legislators of the final session and presented at the Awards Assembly.

There shall be six (6) scorers in the final session chamber and a parliamentarian who also scores. If all seven districts are represented in the final chamber, there will be seven (7) scorers and the parliamentarian.

At the conclusion of the final session, judges' preferential ranking (1-8) will be used to determine the final order of placement. Ties shall be broken as follows:

- a. Judges' preference
- b. Reciprocals
- c. Parliamentarian scoring.

The top six (6) in the final session shall receive OSDA awards at the Awards Assembly. All other finalists shall receive medallions in the final session chamber.

SCORER INSTRUCTIONS

Congressional Debate asks students to act as if they are legislators at the federal or state level. Students offer legislation, debate it, make motions, ask questions, and vote. Throughout, they follow parliamentary procedure. The Congressional Debate chamber should resemble a real congress or state legislative chamber.

Unlike regular debate, you need not organize and run the room. The tournament has enlisted the efforts of an experienced adult to serve as parliamentarian. This person ensures that all members are observing rules. He or she settles disputes with reference to official Congress documentation.

The first order of business will be to elect presiding officers. The presiding officer is a member of the chamber elected to run the chamber. This member manages the legislation docket, hears motions, and handles votes. This person runs the room. The parliamentarian settles disputes, but good rooms rarely see them.

The docket (or agenda of legislation) is set before the sessions begin in the preliminary rounds. In the "break rounds," the parliamentarian will take a quick vote on which piece of legislation students want to speak on. The piece with the most votes will be debated first and so on. Students may motion to table legislation, but they may not suspend the rules to consider legislation in a different order.

When all of the speakers and judges have arrived in the round, click the button in Speechwire that says "start the round"

As a judge, your primary responsibility is judging speeches. Speakers deliver speeches alternating in support or opposition to a piece of legislation. This speech lasts for three minutes and includes an additional questioning period. You will use the rubric to evaluate the speeches. You will judge from the time the speaker begins to the time he or she finishes answering questions. Do not score based on any activity outside of this speech time.

Each time a speech is given, you will assign a score on a scale of one to six. Higher scores are better. Reserve scores of two or below for speeches demonstrating serious weaknesses. If a representative speaks on the wrong side of the legislation, you should deduct at least three points from their score. If a representative speaks on the wrong piece of legislation, the score earned is a zero. Reserve scores of 6 for speeches that advance debate with new information or arguments, that refute opponents' arguments, and that are delivered extemporaneously with reference to but not reliance on notes.

Each time a speech is given, record the score on the seating chart. Judge the presiding officer based on his or her ability to run the chamber smoothly according to parliamentary procedure, treat all members fairly, and reduce conflict as much as possible. Assign a score for each hour of presiding, using the presiding rubric.

At the end of each session, You will rank the contestants from 1-10 in the preliminary sessions and from 1-8 in the quarterfinal, semifinal, and final sessions. A rank of "1" is best. There can be no tie in rank. Enter your ranking in Speechwire.

When ranking, consider the following elements and comment accordingly in the spaces provided: ORIGINALITY OF THOUGHT (extent to which speech advances debate or merely repeats previously stated ideas; whether speaker refutes opposing arguments); ORGANIZATION AND UNITY (while speeches that respond to other arguments advanced in the session are often spontaneous and extemporaneous, the speaker should attempt cohesiveness); EVIDENCE AND LOGIC (cites credible sources and warrants claims accordingly); DELIVERY (extemporaneous vs. reading a manuscript, seriousness of purpose, style and poise). How well the speaker ANSWERS QUESTIONS for each speech should be considered.

When you are not judging, please stay in the Judges' Room.

PARLIAMENTARIAN INSTRUCTIONS

Thanks for serving as the parliamentarian today! Your help is vital to keep the debate flowing smoothly. Your role is to ensure that all members are observing rules of parliamentary procedure. You will settle disputes with reference to official Congress documentation.

The first order of business will be to elect presiding officers. Plan to have one presiding officer per hour of the session. Each presiding officer should have the same amount of time to preside.

The docket is set before the sessions begin in the preliminary rounds. In the "break rounds," the parliamentarian will take a quick vote on which piece of legislation students want to speak on. The piece with the most votes will be debated first and so on. Students may motion to table legislation, but they may not suspend the rules to consider legislation in a different order.

When all of the speakers and judges have arrived in the round, click the button in Speechwire that says "start the round."

Debate on a piece of legislation begins with an authorship or, if one is not available, a sponsorship speech. Authorship is granted by district. Any member of a district may ask for the authorship speech, but if more than one student asks for it, it should be granted based on precedence and recency. Sponsorship should be handled the same way if no one from a district wants to give the authorship speech. If no one is willing to give the authorship or sponsorship speech, a motion should be encouraged.

You will use the rubric to evaluate the speeches. You will judge from the time the speaker begins to the time he or she finishes answering questions. Do not score based on any activity outside of this speech time.

Each time a speech is given, you will assign a score on a scale of one to six. Higher scores are better. Reserve scores of two or below for speeches demonstrating serious weaknesses. If a representative speaks on the wrong side of the legislation, you should deduct at least three points from their score. If a representative speaks on the wrong piece of legislation, the score earned is a zero. Reserve scores of 6 for speeches that advance debate with new information or arguments, that refute opponents' arguments, and that are delivered extemporaneously with reference to but not reliance on notes.

Following authorship or sponsorship speeches, there is a two minute questioning period where representatives will each pose individual questions (with no follow-up question unless recognized again) and receive answers. Following all other speeches, the questioning period is one minute long.

Each time a speech is given, record the score on the seating chart. Judge the presiding officer based on his or her ability to run the chamber smoothly according to parliamentary procedure, treat all members fairly, and reduce conflict as much as possible. Assign a score for each hour of presiding, using the presiding rubric to guide you.

At the end of each session, rank the competitors from best to worst (1 is best). There can be no ties in rank. Type your ranking into Speechwire.

When ranking, consider the following elements and comment accordingly in the spaces provided: ORIGINALITY OF THOUGHT (extent to which speech advances debate or merely repeats previously stated ideas; whether speaker refutes opposing arguments); ORGANIZATION AND UNITY (while speeches that respond to other arguments advanced in the session are often spontaneous and extemporaneous, the speaker should attempt cohesiveness); EVIDENCE AND LOGIC (cites credible sources and warrants claims accordingly); DELIVERY (extemporaneous vs. reading a manuscript, seriousness of purpose, style and poise). How well the speaker ANSWERS QUESTIONS for each speech should be considered.

Each scorer independently (without collaborating) awards 1 to 6 points for each speech. Each speaker has up to three minutes to present arguments followed by a questioning period of one minute.

Substantial written comments and description of specific incidents should accompany such scores.

OSDA CAMERA GUIDELINES:

- A.) Cameras should be stationary.
- B.) Students should remain in frame for the entire performance.
- C.) Cameras should NOT be used as part of the performance: the camera should be viewed as the eyes of the judge(s).
- D.) If you cannot do it in a live in-person setting, you should not do it for the camera.

TIME CONSIDERATIONS:

There are no minimum time limits for any category.

The maximum time limits are (please do NOT stop any student's performance, even if they go beyond their 30 second grace period):

DEC, DUO, DI, HI, INF, OO, POI: 10 minutes PLUS a 30 second grace period

IX and USX: 7 minutes PLUS a 30 second grace period.

For IX and USX, please ensure that one of the judges provides the speakers with the applicable time signals:

Hold up 2 fingers at the end of 5 minutes (2 minutes remaining)

Hold up 1 finger at the end of 6 minutes (1 minute remaining)

Hold up half a finger at the end of 6 ½ minutes (30 seconds remaining)

Hold up a fist at the end of 7 minutes.

Penalties for going overtime are at the judge's discretion. Students do not have to be ranked lower for going overtime.

SUBMITTING RANKS

Please submit your ranks (1 = best, no ties) shortly after the round concludes. Once you submit your ranks, you cannot revise them. If you submit your ranks and later notice an error, please check in with the Speech Judge room. Please do not disclose your ranks to anyone until after the awards ceremony.

COMMENTS NOT REQUIRED

Speech Judges do NOT need to provide any written comments for students at the 2021 OSDA State Finals.

PRESENTATION INTERRUPTED

If a student loses connection during their speech, or if one of the judges loses connection during the student's speech, once both the student and judge return, the student must resume where they left off when the connection was lost. *** Students cannot completely restart their presentation. ***
