# HEALS Academy, L.L.C. Privacy Policy

Introduction

HEALS Academy, L.L.C. ("Company" or "We" or "Our") respects your privacy and is committed to protecting it through compliance with this policy.

By purchasing or accessing any of our products, services, or programs, you ("User" or "you") agree to be bound by this Policy as well as our <u>Terms & Conditions</u>, <u>Earnings Disclaimer</u> and <u>Refund & Fulfilment Policy</u>.

The Company develops, operates, and distributes software applications, including web applications, hosted applications, and applications for mobile devices.
