COURSE DESCRIPTION

Ethical considerations based on social and human services standards. Includes comparison of ethical codes, confidentiality, dual relationships, guidelines for web counseling, ethical considerations dealing with broadcast media, diversity and multiculturalism.

COURSE RATIONAL

This course is designed to help students gain an understanding of the ethical issues surrounding the Human Service profession in preparation for employment.

Please Note: the grading system is a simple point system. Add up your points from your assignments, compare your point total to the grade scheme above, and that is your grade.

Quizzes: There are 10 quizzes each worth 20 points (the orientation quiz does not count for a grade). You are allowed to re-take each quiz once before the deadline for a total of 2 attempts. The highest score will count for your grade. Total possible points for quizzes is 200. Late quizzes are worth half the scored value (max of 10 points). The Blackboard system automatically grades the quizzes, but I will make a note in my paper gradebook of any quiz that is late and will deduct half the points. I do not change the grade in Blackboard so you must be responsible for noting your own late quizzes. The same holds true if I "throw out" a quiz question and award points to everyone – it will not show up in Blackboard but I note the change in my paper gradebook. The paper gradebook supersedes Blackboard. If you are ever concerned about your grades, contact me early in the semester.

Discussion Boards

Students are required to participate in each lesson's discussion board. The topics for the discussion boards vary depending on the lesson. You are required to post your response to the question(s) posed, and then **respond to at least 2 other students**. The IDB counts for up to 10 points. While you are welcome to continue posting past the deadline, only posts made by the deadline will be read by the instructor and counted for points. **Total possible points are 100**. Guidelines for posts include:

- Minimum of 3 posts. One post should be substantive and respond to the discussion questions with a minimum of 50 words including one APA citation to your assigned readings. The other two posts must be substantive responses to your classmates. Your initial post (IDB) must be submitted by the Sunday preceding the lesson deadline (7pm CST). You then have until 7pm Tuesday of the lesson deadline to respond to two other students' posts. Missing the Sunday IDB deadline automatically reduces your grade by 5 points. Missing the deadline to post to classmates results in no points being awarded.
- Your comments are expected to thoroughly respond to the discussion question(s) and make at least one academic citation in your IDB. Your comments to other students should expand on what they wrote and offer additional thoughts/insights. Posts such as "I agree" will not earn any points.
- Posts must be written with proper grammar, spelling and citations. If you do not know
 how to cite using APA, contact a librarian or tutor. Points are lost for poorly written posts
 and post that do not include a specific reference to the assigned readings. Just saying
 "Corey, 2019) is not a specific reference. Tell me what in your post is substantiated from
 your readings. There is a tutorial for APA at https://library.austincc.edu/help/apa/

Discussion Board Etiquette

- Never post, transmit, promote, or distribute information that is known to be illegal.
- Never post harassing, threatening, or embarrassing comments. If you disagree with someone, respond to the subject, not the person.
- Never post content that is harmful, abusive; racially ethnically, or religiously offensive, vulgar; sexually explicit; or otherwise potentially offensive.
- Do not use curse words in your posts and do not use all capital letters or color fonts other than black/white.
- Spell and grammar check your postings.

- Never share anything that you are concerned about becoming public knowledge. The College does not guarantee the confidentiality of information shared by participants in the course.
- The instructor reserves the right to remove any postings that are deemed inappropriate.
- Postings that are removed are not given any grade points.

Lessons: There are 10 lessons for the course. Lessons consist of reading assignments from the text and online articles. There are also supplemental assignments, quizzes and a discussion board.

Supplemental Assignments: There are 5 supplemental assignments built into some of the lessons. Each supplemental assignment is due at the lesson deadline and will NOT be accepted late. Assignments should be submitted through the Assignment button in Blackboard. Be sure your name is on your papers if you submit them in any other form. Academic papers are double spaced, 12-point font, 1-inch margins. If you do not know how to format papers, please review APA guidelines. The assignments are described in the lessons and are worth 20 points each: No late assignments are accepted.

Final Exam – Toward the end of the semester I will post an ethical case that will serve as your final exam. Your responsibility is to write a paper analyzing the case (most exams end up around 5 pages long). The paper must include at least 5 different academic citations from the various readings we completed during the semester (use at least 5 different reference materials), and include references to the Code of Ethics you selected to help you resolve the dilemma(s). Complete instructions will be included with the exam. The exam deadline is posted on the Course Outline and NO LATE exams are accepted. **The exam is worth 100 points**.

ADDITIONAL EXPECTATIONS

For this course, students found guilty of academic dishonesty will be administratively withdrawn with a grade of "F".

This course does not use the Testing Center.

Students are expected to have regular participation in the course. Students who do not complete the orientation quiz by the first Friday of the semester will be marked as "Never Attended" and withdrawn. Those who do not complete the first lesson quiz and discussion board by the deadline will be withdrawn. Missing 2 lesson deadlines in a row, or more than 4 lesson deadlines total, may result in a withdrawal from the course. Communication is important not only in this class, but in this profession--I cannot stress how available I want to be should you need me, but you MUST communicate your needs for them to be heard and met. Please reach out should something come up that prevents you from meeting any of these deadlines. In most cases alternate arrangements can be made.

Withdrawal Policy

<u>Students who do not complete the orientation quiz by the first Friday of the semester will be marked as "Never Attended" and withdrawn</u>. Those who do not complete the first lesson quiz and discussion board by the deadline will be withdrawn. Missing 2 lesson deadlines in a row, or more than 4 lesson deadlines total, may result in a withdrawal from the course.

The College defines withdrawals as occurring after the official reporting date of the semester, typically the 12th class day. In addition, the Legislature has mandated the Rule of Six (see below). There may also be financial aid issues.

It is the responsibility of each student to ensure that his or her name is removed from the roll should they decide to withdraw from the class. The instructor does, however, reserve the right to drop a student should he or she feel it is necessary. If a student decides to withdraw, he or she should also verify that the withdrawal is recorded <u>before</u> the Final Withdrawal Date. **The Final Withdrawal Date for this semester is [insert date here]**. The student is also strongly encouraged to keep any paperwork in case a problem arises.

Students are responsible for understanding the impact that withdrawal from a course may have on their financial aid, veterans' benefits, and international student status. Per state law, students enrolling for the first time in Fall 2007 or later at any public Texas college or university may not withdraw (receive a "W") from more than six courses during their undergraduate college education. Some exemptions for good cause could allow a student to withdraw from a course without having it count toward this limit. Students are strongly encouraged to meet with an advisor when making decisions about course selection, course loads, and course withdrawals.

NOTE: It should be understood it is the student's responsibility and not the instructors to drop a course. A student that discontinues coming to class and fails to drop a course is subject to receiving a final, permanent grade of "F".

MISSED EXAM AND LATE WORK POLICIES

Quizzes submitted after the deadline are worth half the scored value shown on Blackboard. No points are given for late Discussion boards. No late papers or exams are accepted.

Incompletes

An incomplete ("I") will only be given in cases of emergencies after the last day to withdraw has passed and if the student has completed all assignments in Lessons 1-9 and earned enough points for a "C".

An incomplete (grade of "I") will only be given for extenuating circumstances. What constitutes "extenuating circumstances" is left to the instructor's discretion. If a grade of "I" is given, the remaining course work must be completed by a date set by the student and professor. This date may not be later than two weeks prior to the end of the following semester. A grade of "I" also requires completion and submission of the Incomplete Grade form, to be signed by the faculty member (and student if possible) and submitted to the department chair.

Students may request an Incomplete from their faculty member if they believe circumstances warrant. The faculty member will determine whether the Incomplete is appropriate to award or not. The following processes must be followed when awarding a student an "I" grade.

- 1. Prior to the end of the semester in which the "I" is to be awarded, the student must meet with the instructor to determine the assignments and exams that must be completed prior to the deadline date. This meeting can occur virtually or in person. The instructor should complete the Report of Incomplete Grade form.
- 2. The faculty member will complete the form, including all requirements to complete the course and the due date, sign (by typing in name) and then email it to the student. The student will then complete his/her section, sign (by typing in name), and return the completed form to the faculty member to complete the agreement. A copy of the fully completed form can then be emailed by the faculty member to the student and the department chair for each grade of Incomplete that the faculty member submits at the end of the semester.
- 3. The student must complete all remaining work by the date specified on the form above. This date is determined by the instructor in collaboration with the student, but it may not be later than the final withdrawal deadline in the subsequent long semester.
- 4. Students will retain access to the course Blackboard page through the subsequent semester in order to submit work and complete the course. Students will be able to log on to Blackboard and have access to the course section materials, assignments, and grades from the course and semester in which the Incomplete was awarded.
- 5. When the student completes the required work by the Incomplete deadline, the instructor will submit an electronic Grade Change Form to change the student's performance grade from an "I" to the earned grade of A, B, C, D, or F.

If an Incomplete is not resolved by the deadline, the grade automatically converts to an "F." Approval to carry an Incomplete for longer than the following semester or session deadline is not frequently granted.
