Use of Images

Photographs and video content may be taken at the Event by and/or on behalf of Chelsea Football Club Limited ("**Chelsea FC**"). The Event Content may be used in promotional information and materials, in any format, by Chelsea FC and our group companies. By attending the Event, you acknowledge and agree that you and, if applicable your child, may feature in the Event Content.

We rely on our legitimate interests in operating our business and promoting Chelsea FC and its partners as our legal basis to process your and/or your child's personal data in this way under data protection law. Please read our Privacy Policy (www.chelseafc.com/privacy) to learn more about Chelsea FC, our group companies, how we use your information and how to contact us if you have any concerns.

Risk of injury

If you and/or your child (as applicable) participate in a football coaching session, please ensure that you and/or your child (as applicable) bring suitable equipment for the activity, including correct footwear, shin pads, appropriate clothing, hats, sunscreen and medication (if applicable). The football session is physically challenging and carries with it risks that we cannot entirely eliminate. These include the risk of personal injury.

We are not qualified to express an opinion as to whether you and/or your child (as applicable) are fit to safely participate in the Event. You should obtain advice from a doctor or other qualified medical professional before participating. You and/or your child must not participate in the Event (or part of it) if you have been advised not to do so by a doctor or other qualified medical professional.

Medications

You confirm that you will bring with you any medications that you and/or your child (as applicable) may require during the Event in sufficient quantities to cover the maximum doses which may be required for the duration of the Event. You acknowledge that you and/or child (as applicable) may not be permitted to participate in the Event if you do not have the medications required.

Treatment

In the event that you and/or your child (as applicable) suffer any injury or illness during the Event, you consent to Event staff providing you and/or your child (as applicable) with first aid, medical treatment and/or care. You acknowledge and agree that Chelsea FC is under no obligation to administer any first aid, medical treatment or care to you or your children at any time and that any decision to provide

such first aid, medical treatment or care shall be made by Chelsea FC in its absolute discretion. You acknowledge and agree that you shall be responsible for any first aid, medical treatment or care not provided by Event staff.

Further information

You understand that you are responsible for disclosing to Chelsea FC any information that may be relevant to you and/or your child's (as applicable) participation in the Event and agree to promptly inform Chelsea FC of any change in respect of any of the information you have previously provided.

You confirm that all information that you have provided Chelsea FC in relation to you and/or your child (as applicable), including but not limited to factual information in relation to allergies and medication, is true, accurate and not misleading and does not omit any material information.

Liability

In the absence of any negligence or other breach of a legal duty by us, participation in the Event is entirely at your risk and you understand that, to the fullest extent permitted by law, Chelsea FC is not responsible for, and excludes any liability in respect of, you and your child's (as applicable) participation in the Event and in connection with use of the Event Location facilities, including without limitation any injury suffered as a result of such participation and any theft, damage, destruction or loss of your or your child's property or belongings in connection with the Event or on our property. Please note that this paragraph does not exclude Chelsea FC's liability for personal injury or property theft, damage or destruction which is caused by its negligence or other breach of a legal duty.

Your data
