Heya everyone, Jakizon here

This document is about the recent expose document that **Valdi Bee** has written against me, and the purpose of this response document is to explain everything properly that has happened and correct all **misinformation** posted in the expose document **(there's a lot)**.

I will be going with everything one by one to make sure every single piece is explained and corrected carefully

Firstly, I am currently 19 years old, will turn 20 in 16 days (at the time when im writing this) and my birth date is **3rd of August 2005**


Ichiko is currently 17 years old, and will turn 18 in 77 days (less than 3 months) and his birth date is **3rd of October 2007**

And I, **Jakizon** am from **Poland** and by Polish law the age of consent there is **15** (this is surprisingly low as fuck and I don't even agree with this in the slightest but it is how it is)


Ichiko is from **Venezuela** and by that country's law the age of consent there is **16** (slightly better than Poland but I still wouldn't agree with this anyway tbh)

and my relationship with **Ichiko** is purely romantic, **ZERO** sexual behavior

2. Age Difference Laws (Romeo and Juliet Laws):

- Many jurisdictions have laws that account for age differences, often called "Romeo and Juliet" laws. These laws might allow for a smaller age difference between two individuals who are both minors or close to the age of consent, but still criminalize a significant age gap between an adult and a minor, even if the minor is above the general age of consent. 
- For example, in some places, a 17-year-old and an 18-year-old might legally be able to engage in sexual activity, while a 25-year-old and a 16-year-old would not, even if the age of consent is 16.

5. Non-Sexual Relationships:

- In general, there is no law against an adult "dating" a minor if there is no sexual activity. However, even non-sexual relationships can draw scrutiny, especially if there's a significant age gap or if the adult's intentions are questionable. Child protection services may investigate if there are concerns about exploitation or abuse. 

So my relationship with Ichiko is completely legal and fine, some people might raise their eyebrows and I completely understand that, it looks weird seeing an adult date a minor, but since Ichiko is so close to becoming an adult, I didn't see any harm in forming a relationship with him, on top of that Ichiko feels completely safe and comfortable around me, I ask him almost everyday if he's happy because I really care to keep my relationship with him as healthy as possible and he always responds positively

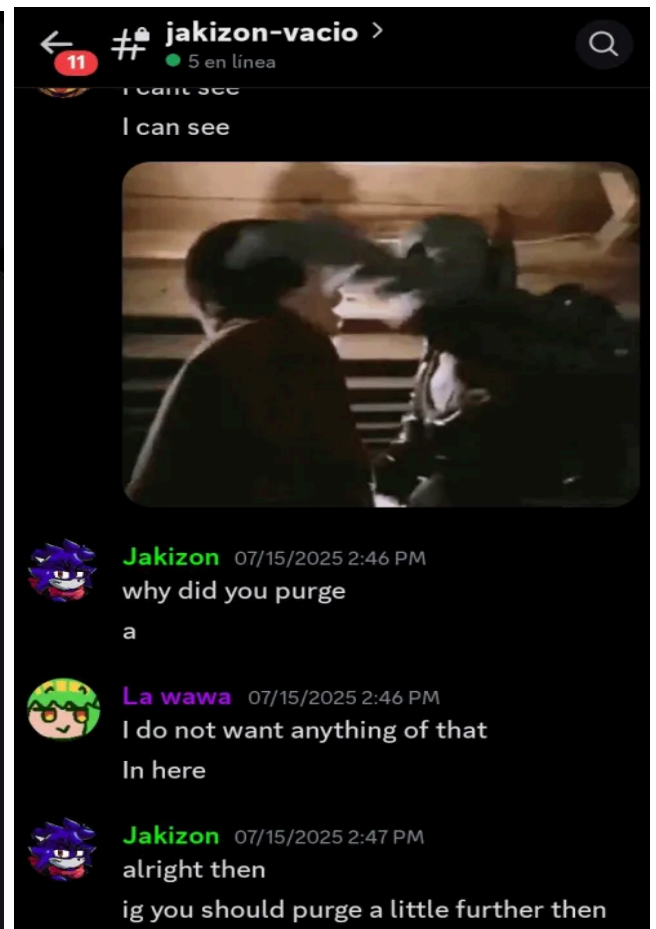
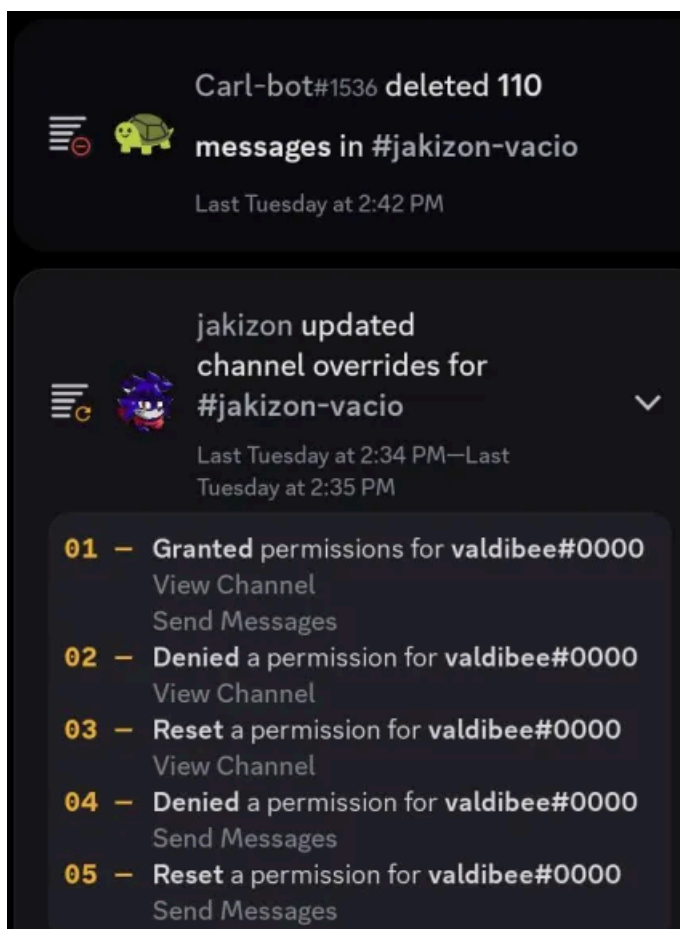
Valdi's argument is that just because the relationship is legal in my and Ichiko's country doesn't mean that it's okay because it's not legal in his country (This topic is continued further in page 13-14 followed by many screenshots)

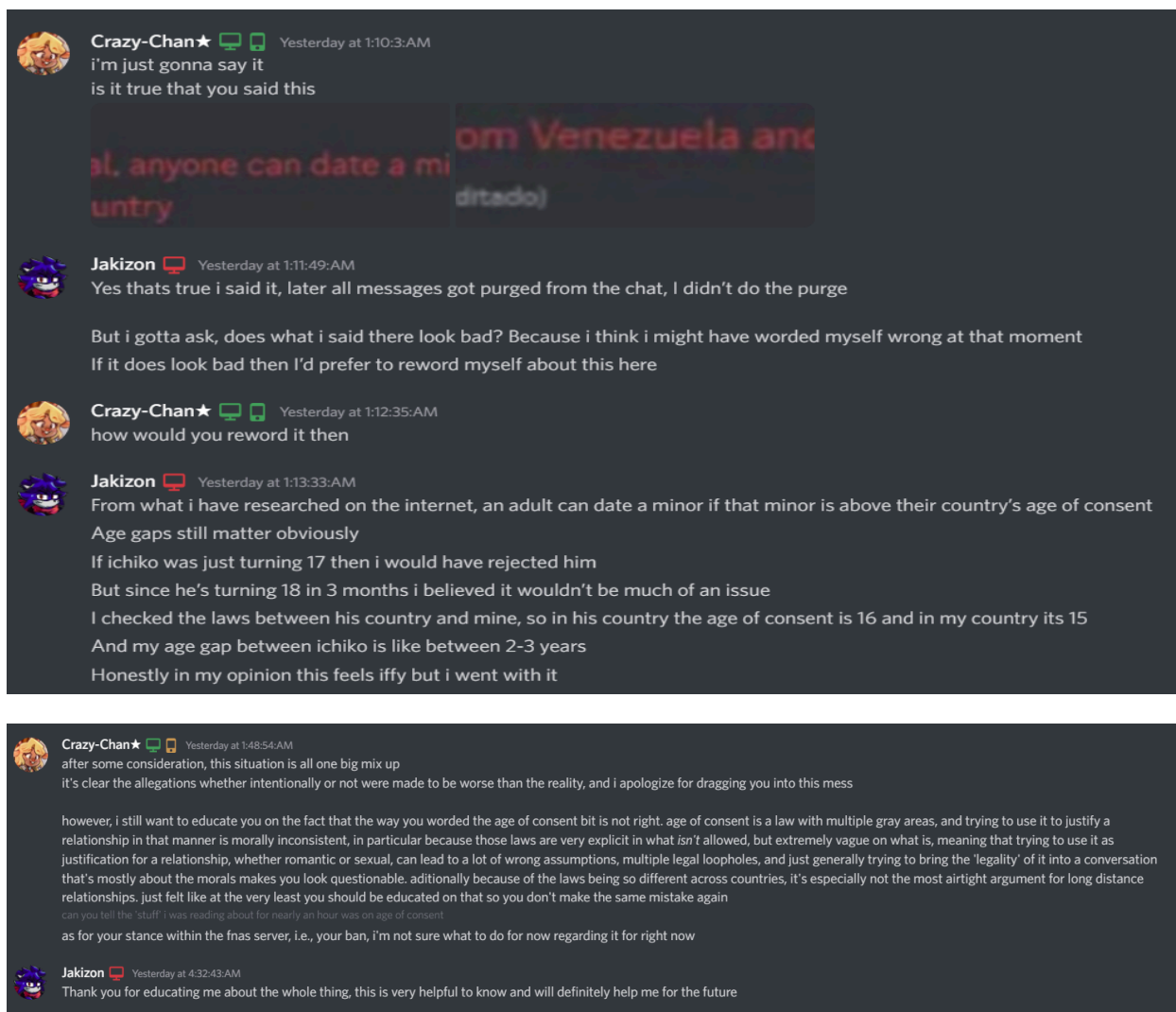
He ain't in my or Ichiko's country, my relationship with Ichiko isn't happening in his country so it doesn't matter, he can say whatever he wants, but it just doesn't work like that man

The “fight” in my channel

The fight went on for several minutes, and I was banned from accessing the channel and all messages were deleted — with the excuse of “Avoiding Fights” (because of that reason, the texts are in red, since they were recovered with Vencord's Log Messages plugin).

All messages were deleted by **Ichiko** by using the purge function from a **bot**, I did not tell him to do this, it was **Ichiko's** own decision, the excuse was not about “Avoiding fights”, the excuse was that **he** didn't want to see the whole thing anymore





There was a few errors in the "fight" screenshots from my side so Crazy-Chan educated me a lil about how things work here (By the way the screenshots between me and Crazy-Chan were before the doc and it was about a serious convo of me explaining myself about things Valdi has shared with some people)

I got rid of his permissions to see my channel because I was fed up with him and didn't feel comfortable with him being able to write or see my channel anymore as well as because he started threatening to "expose" me, knowing that he barely had anything to expose me with I started thinking that he might want to collect some out of context information and shape it into lies

After finding out that I was planning to expose him — Jakizon started sending me threats and insulting me for "telling lies about him", the guy went far enough to get me banned for no reason on some guy's (involved) server, the guy went far enough to ask my informant and many people to block me and keep me away from their projects since I was "manipulating" information.

I didn't send **Valdi** any threats, and even if I had, **he** never shown any proof of that anyway, I was only calling **him** Insane, but yes, insults were thrown at **him** at some point

I got **Valdi** banned from all servers I could when I was given enough information about **his** attempts of **falsely accusing** me of many things mentioned in **his** document, I very well knew **he** was not going to back out of it, because I was even shown a screenshot of **him** confirming that **he won't stop**, so I'd say pretty reasonable

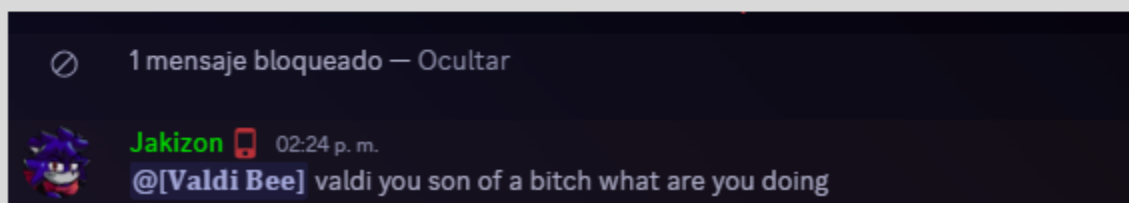
I was asking people what they knew about what **Valdi** was trying to do to learn what options I could have, after I learned about what **he** was doing I asked people to **stop interacting** with **Valdi** because he was clearly trying to turn people against me with false proof

Here's a little question,

If Jakizon was really innocent as he says — why does he delete and get rid of evidence?

- In his point of view: because I tried to “manipulate” people and yet, he threatened me.

(He, who owes nothing, shouldn't be afraid of anything).



I didn't delete any evidence, and **he** hasn't even shown any evidence of me deleting any evidence, the only deleted thing that you could call evidence is the **"fight"** that happened in my channel which wasn't even deleted by me

He is literally trying to justify **his** manipulation because I "threatened" **him**

"Valdi you son of a bitch what are you doing" is not a threat, just a throwaway insult with a serious question, I was getting scared about what **he** could be doing since I was getting hints from **Marineblue**

The FNaS Sexualized Recode

- Controversial game

Out of the topic of his relationship, Jakizon has also worked modifying and making unpleasant content of a game called FNaS Sexualized (game banned in the community for its content).


Days ago, he was working with his friends on a recode of the game where he was modifying assets to make them certainly horrible and uncomfortable to look at.

Firstly I would like to congratulate **Valdi** for revealing the game link in **his** doc to the WHOLE DARN SERVER FULL OF MINORS, YOU ARE AMAZING, ACTUAL GENIUS

Anyway yes, I have been developing a **fnas sexualized** recode, the game was completely private between friends, it was being made for fun and as a form of practice it was never MEANT to be PUBLIC in any way, there was no malicious intent behind it

Some assets were planned to be modified, only one asset was modified, which was that golden sonic sitting on the desk sprite, which was edited by me, the rest of what was shown in **Valdi's** doc of golden sonic wasn't even drawn by me, like at all, an unrelated friend did those edits

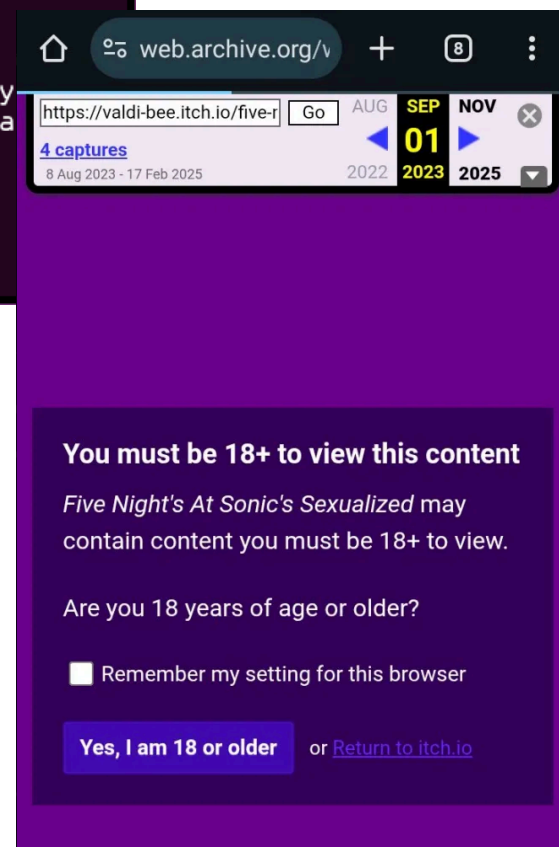
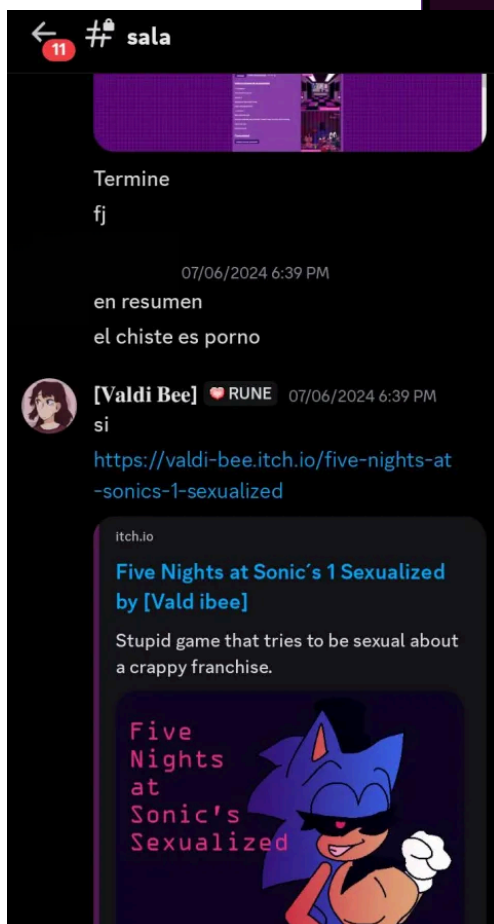
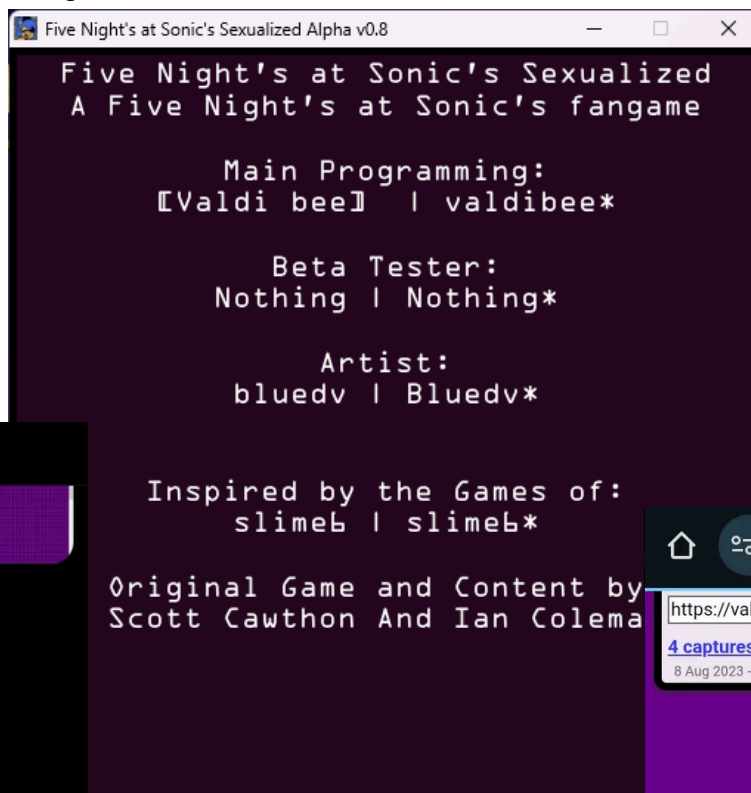


This is not the real Valdi Bee as shown in the screenshots, this is one of my friends Marineblue who just changed their name to Valdi's name, from what he said he told Valdi that the golden sonic jumpscare sprite was not edited by me, but Valdi added it to the doc anyway and didn't say anything about it (more about this in page 11-12)

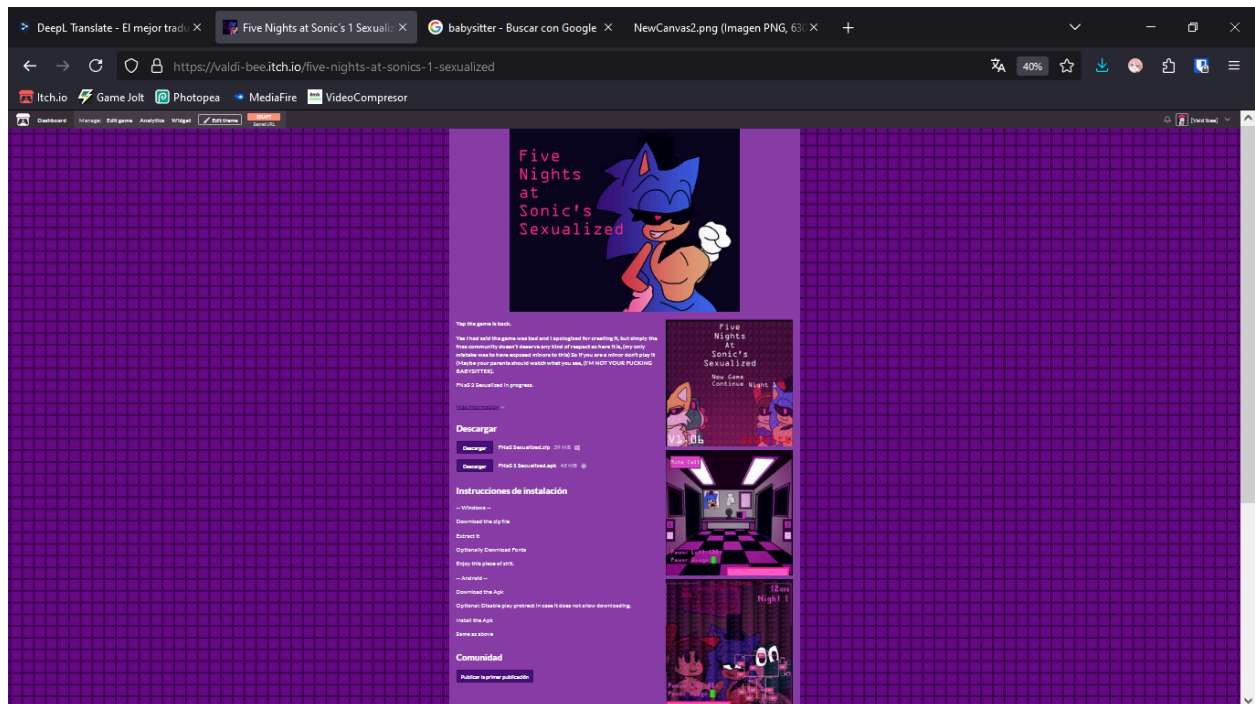
Let's start with the fact that that **he** actually **didn't even bother to ask if it was a joke or not**, why the hell would I even have to specify that anywhere if the game was private, that would ruin the point of it being private

Kinda funny how **Valdi** brought up fnas sexualized and is trying to expose me for making a recode of it and say **all that**, since like **he is the one who created fnas sexualized**, **he owns it, he programmed the game**, he uploaded it to the internet and there is clean screenshots to prove that, **so I'd say it's pretty hypocritical for him to say all that like he's done nothing wrong**

Here's all screenshot proof needed to show that this **fnas sexualized** was indeed created by **Valdi**, and some of it is even still accessible on the internet archive, even shown in the original game credits screen



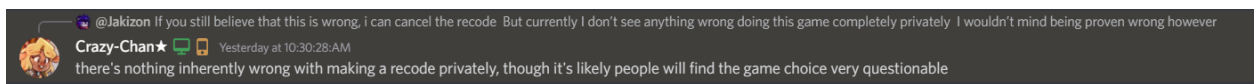

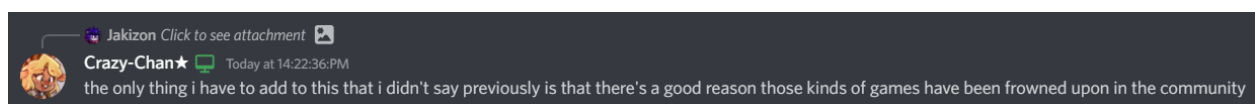
because this kind of content is Not welcome in this community, even the people who produce it are criticized for such behavior.

Ok. I knew about this rule of this content not being welcome in the community but I genuinely had no idea that it applies to private projects like that, I can take full fault for this, this is valid

But not long ago I've talked with **Crazy-Chan** about this before the exposing doc was released



Screenshot below is an addition to the first one



So after that I thought that I was in the clear and was allowed to continue making this, but apparently not long ago I was shown a screenshot of the fnas server of where **sunrose** started talking about this and **apparently me working on a game like that is enough to get me offed out of the community**

So honestly I don't know who to listen anymore and I'd prefer if this was made more clear to me as soon as possible, **but also if necessary I am willing to cancel the recode to avoid problems**, I don't want to be removed from the community because of this

Below, you will see screenshots where it's evident that this does in fact exist, and also the build in case you want to check the veracity of it.

Also the build was resubmitted by me, since I don't doubt that he deleted it to hide evidence.

I actually cannot believe that **Valdi** was this dumb to include a build link in his document, **he gave minors access to a game that was made for adults**, that was incredibly stupid as hell, only like a day after his doc was released I was able to finally disable the link because earlier I wasn't on my pc and I didn't remember my dropbox password to log in on my phone

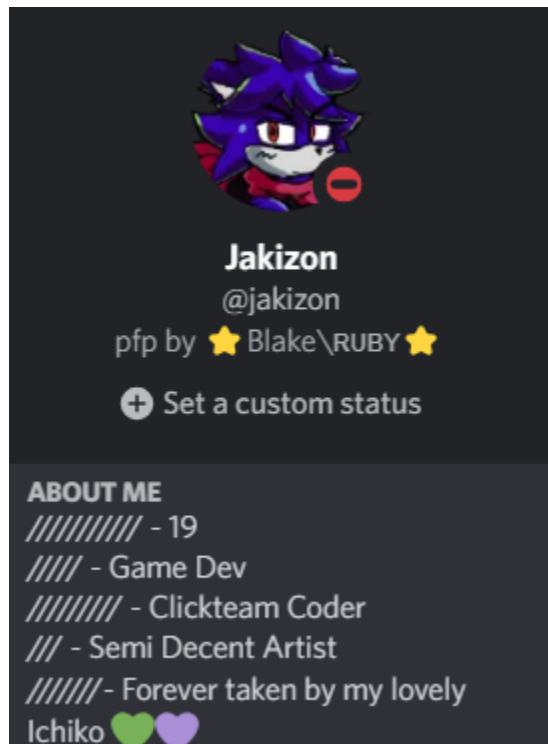
Like dude. The screenshots of the previews of the game in the discord server could have been enough to prove it that I was making this, sharing the actual game exe was so unnecessary, I think deleting the link would have been quite smart after **Valdi** leaked it to everyone, but I guess **he** never figured that out

So I wouldn't call that deleting evidence, I just didn't want minors getting hands on the game, that was not the plan, not the goal, I never wanted any minors involved and **he** ruined it

Valdi's Conclusion

With all the evidence shown here, I hope it is more than clear what kind of person Jakizon is — a person who is driven by his emotions and makes decisions without thinking, he knew that a minor like Ichiko is Not old enough to be in a relationship with a guy who's already in his 20's, he should be aware that this isn't right, even if there is nothing sexual, a grown adult has the responsibility to Not make these kind of mistakes.

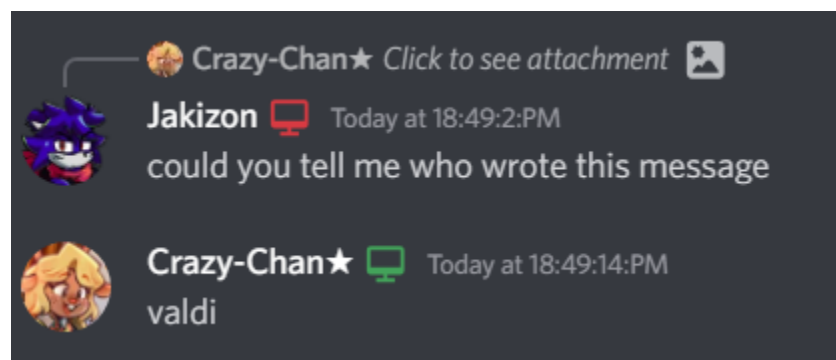
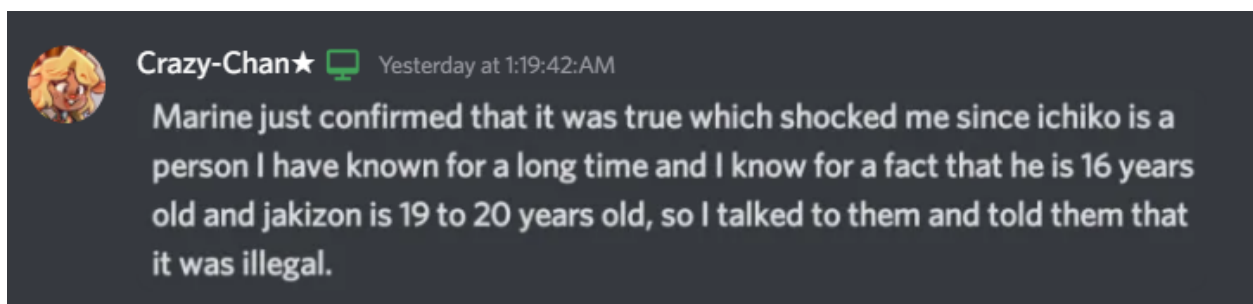
Sure, I do make some decisions without thinking, and that's why I need help from people, there's no doubt about that, however I believe that **Ichiko** has been ready to be in a relationship with a guy NEARLY, NOT ALREADY in his 20's (I'm 19, stated at the beginning), **Valdi** knew that I'm 19, I revealed it in many places too, It's even in my bio on Discord, it's been there for years always regularly updated each year, so it's safe to say that **he quite literally completely lied that I'm already in my 20's**



As for the victim (Ichiko), I hope that someday you can grow up and realize that your happiness isn't entirely in relationships and that your happiness does Not depend on a person who doesn't seem to be mentally stable.

Doesn't seem to be mentally stable? Dude, I AM (slightly) mentally unstable, this is nothing new, however my mental problems are under control and constantly monitored, a lot of people know about this already and my mental stability has nothing to do with this situation, and also I believe Ichiko is old enough to know what he wants, he's already well grown and he would definitely say the same thing as I said right here

Some additional information I'd like to add on (below is a screenshot of a screenshot, this is not written by Crazy-Chan)



Valdi has stated that they have known Ichiko for a long time and they knew that apparently he is 16 which completely doesn't match with what Ichiko has told me back in 2024 and what anyone else has told me





Since **Valdi** has lied about me being already in my 20's while im not even 20 yet, I will believe what **Ichiko** has told me instead of that screenshot of **Valdi** saying that **he's** 16, I believe that **Valdi** has lied about **Ichiko's** age to make ME LOOK BAD

I have contacted **Marineblue**, the person who has provided **Valdi** with most of the screenshots, and **he** even said himself to **Valdi** that I didn't draw these edits of the golden sonic jumpscare from **fnas sexualized**, further proving that **Valdi** did this on purpose to make me look bad






Next up is a conversation between **Someguy** and **Valdi** where **Valdi** keeps throwing **his** own logic towards how **he** thinks the law between countries should work the same when it comes to age of consent and also confirming that **they** will keep trying to expose me further **even after being proved wrong multiple times**


At the very end **Valdi just out of nowhere insults Someguy**



My Conclusion

This is a list of things **Valdi** has done while trying to expose me

Many types of false accusations

Intentionally manipulating people with false evidence and pressuring people into turning against me and Ichiko

Attempted gaslighting Ichiko into lying

Lying about ages

Insulting or harassing few people who are against him (Me and Ichiko included)

Assuming about certain acts that have never happened

Playing Innocent while clearly being wrong

Exposing minors to adult content

It is pretty clear what **Valdi's** intentions are, and it's definitely not good intentions at all. **His actions have caused me and Ichiko unbelievable amounts of stress and anxiety, so much that I actually almost passed out when I first found out about this, I had to endure mostly almost everything that was thrown at me and it was genuinely one of the worst days of my life**

With all the evidence shown here, I hope it is more than clear what kind of person **Valdi** is — a person who is driven by the need to falsely accuse to be satisfied with **their** terrible logic and harmful decisions, **he** knew that a minor like **Ichiko** is old enough to be in a relationship with a guy who's 19, **he** was aware that this is legal and **didn't turn back even when proven wrong multiple times**, a grown adult like **Valdi** (**He's** 20 years old by the way, **his** birthday was in April) has the responsibility to not make these kind of massive mistakes.

As for those who defend this person, I recommend you a good rub around your eyes and read this doc again, **Valdi** is not a good person and I believe something should be done about **him**, If **he** is capable of pulling off something like this then nobody knows what else **he** could try doing next, this community doesn't need people like **him**, **so to the fnas devs that are reading this**, please do something about **Valdi**, I don't believe **he** should be around fnas because of this or **at least be heavily limited to what he could do in the community**

And now, I think that would be everything I could cover from **Valdi's** document, If there is anything I missed then please let me know, and thank you for reading this important response document

Oh also please don't harass **Valdi** for this, nobody wants to be harassed and generally people don't deserve that

This doc was written on 18/07/2025 and finished on 20/07/2025 (Any updates don't count to the finished date)

Doc Update

I'm updating this doc a couple hours same day after release as a way to respond to Valdi's gamejolt response which you can see here below

Me and Valdi shortly after that response talked in dm's one last time and thats what came out of it

Well, to get to the point.

I propose that we leave this drama behind and forget about it. I will delete my document and apologize for it, and you delete yours and cancel whatever sexualized content you made.

I admit it was my mistake to make the post and all those things. I act very impulsively because deep down I care about Ichiko and her safety, which is why I didn't want to talk about this. But Marine sent me some screenshots and other things, and in the end, I exploded and did it. I admit it was wrong to let myself be influenced by those screenshots and create this circus. I should have had the full context and calmed down. Now, what I want is to put an end to this since these past few days have been really hard for me. In part, I also didn't like that they wouldn't let me speak on the FNAs dev server and clarify things, among other things; but well, that's not the point. I apologize to you and Ichiko for what I did based on screenshots without context, and I hope everything can be resolved.

Apologizing barely changes anything between me and you, you've done Irreparable damage, but I appreciate your attempt, at least Ichiko forgives you

You didn't even bother to try to settle or fix this earlier, you quickly jumped to accusations and blocked me, people kept telling you that everything was okay but you were too stubborn

You pressured Marine into sending you **private** screenshots which were taken completely out of context, because of this my friendship with Marine went downhill and he kept refusing to talk about it and was behaving like a dick towards me for the past few days

My whole friend group found out that i'm a gooner because of this, and i never wanted them to know that because i wouldn't feel comfortable with my 5 year close friends knowing about that, they are very annoying when they find out about things about that, and now its gonna be a nightmare hanging out with them

You tried to apologize on gamejolt but it ended up with you continuing the drama and trying to expose me further, making the whole situation worse for both of us again

I would prefer to not cancel my recode because its really close to being done, plus crazy-chan allowed me to continue it so its fine. I never modified any code from your game, it was all rewritten from scratch, and the art edits were allowed by blue, and i don't see anything disgusting about editing that one golden sonic sprite when there's assets in the game that are a lot worse than that it was just some small corrections made for fun, i didn't mind making sexualized 2 but i only joked about it, blue made me consider it because he said that he wouldn't mind doing it, as long as everything here is private and is not encouraged in the community it seems to be perfectly fine

Deleting the documents would be a bad idea because thats just sweeping things under the rug and deleting evidence of our actions which is usually not appreciated by anyone (edited)

First of all,

I didn't pressure Blue regarding the screenshots; he gave them to me voluntarily. I have a lot of information about you thanks to that, but most of it I didn't publish because, all things considered, I don't want to get into personal lives and because Blue didn't like it either. And you know, I'd prefer not to drag him further into this, but I'll just say this: if your friendship fell apart, it's your fault. I only published what I had.

Second,

Man, it's not my fault that now everyone knows you're a gooner. It was your actions for not maturing and realizing that this doesn't serve you at all, for not listening to me and Blue when we told you to stop with the sexualized stuff. You're an adult; you should know that your actions have consequences.

I'll repeat it: my mistake was judging, and I accept the consequences that are coming my way, but the fact that your friendships fell apart and everyone knows who you are isn't my fault, it's yours. You wanted to be a better person, you sought redemption, but in the end, you never accept that you're wrong. You have a fucking need to justify yourself and blame others for your actions.

With this, I'm done with the drama. I don't plan to mention you or do anything about it. This will stand as evidence that I tried to fix things, but if your fucking ego won't let you see it, then it's not my fault.

Goodbye. (edited)

He's ignoring everything he's done and how its 100% his fault, he doesn't want to take blame for anything, making any excuse possible, and blaming me for everything

The audacity to talk about my ego and not be able to take the blame for the stuff he did is crazy

So I'd say it's pretty clear that this is just not gonna go anywhere
