In addition, when choosing keywords, it is important to consider keywords or key terms that appear in the title and abstract, avoid using abbreviations, and separate them with semicolons (;). The abstract should be written using Cambria font with a font size of 9 pt, single-spaced, and single-spaced line spacing. The abstract consists of 150 to 250 words and consists of only one paragraph.

The general problem brief related to the research conducted, maximum 1 paragraph with supporting references. The core problem that needs to be solved based on facts and/or hypothesis (if available). The problem must be objective (questioned by reputable journals or reputable research institutions, not questioned based on the author's opinion). Review of previous research (similar) to justify the novelty of this article (there must be references to journals in the last 5 years, international journals are better). There is a description of the statement of the gap (originality) or novelty between this research and previous relevant research based on the "state of the art".

How to cite (citation) using primary and direct references. It is not allowed to cite using indirect citations for example: According to Kilo in Ahmad (2023). Citation using mendeley with **APA 7th edition style** which fully shows the author's name, year of

publication. For example: The results of research conducted (Azura & Copriady, 2017) on class X MIA students of SMA Negeri Pekanbaru on chemical bonding material found that the percentage of students who experienced misconceptions was 39.90%. Arial Narrow-11 upright, with a space between lines of 1.15 lines. Each paragraph begins with a word that protrudes 5-6 digits (1 Tab), or about 1.2 cm from the left edge of each column. The paragraph spacing before and after is 0 pt.

The conclusion contains three important things, namely generalization of findings according to research problems, research limitations, and recommendations for further research.

### 6. REFERENCES

All references, quotations and citations in the article must be included in this bibliography. Reference sources are standard (primary) scientific sources in the form of articles, textbooks, translated textbooks, scientific papers / thesis / dissertation, collections of research abstracts or proceedings, and the internet. Each submitted article contains a minimum of twenty (20) references from primary sources. Articles are 80% and other literature is 20%, published in the last ten (10) years (70% = last 3 years, 30% last 10 years, preferably last 5 years). Citations obtained from books, for example; according to (Laliyo, 2021), in the form of articles (Laliyo et al., 2022), (Saija et al., 2024) in the form of proceedings (Mohamad et al., 2023), in the form of thesis/dissertation scientific work (Hasani, 2022), in the form of the web (National Education Standards Agency, 2019). Writing references systematically using the Mendeley Reference Manager application. The writing style systematically follows the writing rules (style) "American Psychological Association 7th edition (APA style)". Written in single space, between the bibliography is spaced 1 space (in Layout Spacing After 6 pt).

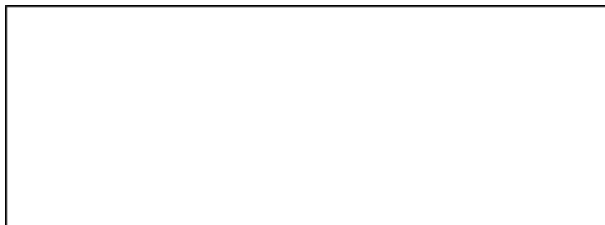


Figure 1. Capitalize the first word and lowercase the next.

Kami mencatat bahwa pada beberapa proses revisi, author mengembalikan naskah yang bukan merupakan turunan dari file terakhir yang telah diedit oleh editor. Hal ini menyebabkan:
