- A motion to approve the language of Article VI of the Budget Warning to be "To act by Australian ballot on the following proposition "Shall the voters of the school district approve the school board to expend \$45,422,241 which is the amount the school board has determined to be necessary for the ensuing fiscal year?" did not pass.

  - Abstain: Kim, Kristen (as chair)
- A motion to approve the language of Article VI of the Budget Warning to be "To act by Australian ballot on the following proposition "Shall the voters of the school district approve the school board to expend \$45,422,241 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$22,322 per equalized pupil." passed unanimously with Kristen abstaining as Chair.
- A motion to approve the Annual Meeting Warning and Budget Warning for FY2024 passed without objection or abstention.
