**Minutes**: The minutes of February 6<sup>th</sup>. 2025 were presented for review.

Motion: To approve the minutes of February 6<sup>th</sup>, as presented. Noble/Sanford. Motion approved 14-0-3.

**Executive Director's Report:** an overview of the current Association finances was presented. The March Financial Snap Shot was emailed and is in the SMAA Meeting Folder.

Current checking account balance is **\$145,325**. There were a large number of expenses in February.

Thirteen member schools have fully or partially paid their 2024-25 SMAA Assessments. (\$124,132). The SMAA 2024-2025 Assessments are past due!

Motion: To approve the Financial Report as presented. Bonny Eagle/Biddeford. Motion approved 14-0-3.

There will be very few if any assessment changes for 2025-2026. There may be some potential changes in our membership (basketball) resulting from the pending Classification changes.

Motion: To approve the Executive Director's Report as presented. Gorham/Westbrook. Motion approved 14-0-3.

## MPA Committee Reports:

**AD Advisory Meeting:** The advisory has discussed the un-evenness of soccer cards, potential Sunday Playoff Competition in Maine and lacrosse goalie conditioning week. Please also see technology report.

**Technology, Ferriera:** The MPA will be changing from r-School to an new data management program. There was a lengthy discussion of the timing of this change as well as the potential merger with "Arbiter Sports". More news on this to come soon from the MPA.

**Classification, Schwartzman:** Final Classifications for the next cycle will be voted upon at the Spring MIAAA/MPA Business Meeting at the Spring Conference in April.

There was a general discussion of various classifications, the 25% rule and various schools petitioning "up" in classification.

**Officials Fees, LeGage:** There will be a meeting this month to review the next cycle of officials' contracts. Expect an increase in the mileage fees. The Interscholastic Management Committee will ultimately vote on the contracts for the next cycle.

**Sports Medicine, Spear:** There was a lengthy discussion of the pre-season conditioning week for lacrosse goalies. Consensus: This week was pushed by the coaches' association without much input from the schools. There will likely be other activities seeking the same pre-season conditioning exemptions. Perhaps we should have considered ice hockey goalies as well as lacrosse.

The SM Committee is also seeking to add emergency contact information to the Arbiter for game officials. The NFHS will likely change the field hockey goggles to include the metal variety.

## **Winter Activities:**

Motion: To approve all the boys and girls all star and all academic teams in the March Folder. Sanford/Falmouth. Motion approved 13-0-4.

**Girls and Boys basketball, Spear, Curtis and Coffey:** There was a brief discussion of the Classification Proposal. Likelihood is that our Association will have only SMAA schools and the KVAC schools will opt out after the Classification Proposal is finalized

**Cheering, Lemelin:** The Bonny Eagle Scots are SMAA Cheering Champions. There was an increase in cheering participation this year. MLK Day was suggested as our SMAA Cheering Championship date in future years.

**Ice Hockey, Walton:** SMAA All-Academic Hockey teams are in the folder.

**Indoor Track, Lawrence:** The SMAA Champions are the South Portland boys and the Cheverus girls. There was a brief discussion of Championship Trophies.
