Introduction

The body of paper must be elaborated between 4000 - 7.000 words (maximum) including abstract, references and footnotes, written in font: Cambria, size: 12, line spacing: multiple (1.15).

The introduction must contain (shortly and consecutively) a general background and a literature review (state of the art), the main research problems and research method. In the final part of the introduction, the purpose of the article writing should be stated.

Please explore in more words the background of your paper and your current research position among other research on related themes. You should discuss here as well

your research's relations with those of other researchers; literature review, especially on most relevant, newly academic works published in high reputation journals, is a must.

The First Aspect of the Discussion

Sub-Section

This part consists of the research results and how they are discussed. The results obtained from the research have to be supported by sufficient data.

The research results and the discovery must be the answers, or the research hypothesis stated previously in the introduction part.

The following components should be covered in the discussion: How do your results relate to the original question or objectives outlined in the Introduction section (what/how)? Do you provide interpretation scientifically for each of your results or findings presented (why)? Are your results consistent with what other investigators have reported (what else)? Or are there any differences?

Closing

Conclusion should answer the objectives of the research and the research discoveries. The concluding remark should not contain only the repetition of the results and discussions or abstract. You should also suggest future research and point out those that are underway.

Note

The literature listed in the References contains only the sources referenced or included in the article. Please use Reference Manager Applications like **EndNote** (Shihab, 2020, hal. 12), **Mendeley** (Abdurahman, 2018), **Zotero** (Nisa, 2018), etc. Referral sources should provide 80% of journal articles, proceedings, or research results from the last five years. Writing techniques bibliography, using the APA Style 6th edition.
