- V. CAPC Scholarships Report: Executive Committee Approval

One item was submitted to the CAPC Executive Committee for approval during the month.

Good Morning Executive Committee Members, Berg, Shields, Barnes, Grinstein and Taniguchi:

#### Item One

At our September 13, 2010 meeting the CAPC continued our commitment to provide training opportunities to build the capacity within the county to reduce the incidence of child abuse, the council, after discussion agreed to commit \$500 per conference that will provide 10 scholarships for each conference. The Domestic Violence Coordinating Council Conference scheduled for October 15th has generated a much greater response for seats than anticipated.

At that September 13, 2010 meeting "It was moved by Harpster/Barnes that the CAPC approve the purchase of a maximum of ten scholarships each for the Eliana Gil Training, the Domestic Violence Coordinating Council Conference and the Child Forensic Interview training with the goal of building the capacity of Monterey County to help child victims of abuse and neglect. Funding for these three trainings is not to exceed \$1350 and should be drawn from KIDSPLATE account. It passed unanimously."

Please consider the following motion:

"As a member of the Executive Committee I am approve authorizing the Director to reserve twelve (12) additional seats at \$50 per seat for the Domestic Violence Coordinating Council Conference scheduled for October 15th. The total cost of these seats will be \$600. Funding for this request is pre-approved by DSES Finance and will be drawn from the KIDSPLATE reserve (\$69,429.14).

The final vote was Berg, Grinstein and Barnes voted yes with member Taniguchi voting no. Member Shields was on vacation. The motion passed 3-1.

Thirty six scholarships were issued for three conferences:

- Eliana Gil in San Francisco: The Impact of Childhood Trauma on Child Development, Resiliency in the Face of Adversity Friday, October 22, 2010. Ten Scholarships Awarded
- The Domestic Violence Coordinating Council: Dying to Live and Living to Die, Seaside, CA. Eighteen Scholarships Awarded
- Child Forensic Interview Training: Current Issues and Best Practices to be held on October 5, 2010 in Sacramento, CA. Eight Scholarships Awarded.

#### VI. Revisiting the Children's Project:

In December of 2009 the CAPC acted on the following motion that provided Over 1520 copies of the book "How to Raise Emotionally Healthy Children" (760 in Spanish and 760 copies in English). These books were distributed throughout Monterey County by professionals, our own parent educators, through Behavioral Health and at various libraries. But for a few, the supply of those copies has been exhausted. The original discussion:

CAPC recognizes that creating positive pro- social parent provide "parent education" can be one of the most productive support groups that evidenced based practices to reduce child abuse and neglect. Using our current trainers we can be one of the many organizations that facilitate the expansion of the information to families of Monterey County by supplying books to our trainers for distribution in their classes. The material provided in the manual "How to Raise Emotionally Healthy Children" can be one more asset to helping families through child rearing roadblocks. After discussion with the writer (and publisher) of these manuals, we have negotiated a price of \$2.45 per book (normal price \$2.95). These books will also be made available to organizations and agencies who work with CAPC in the prevention of child abuse and neglect.

Motion Required: It is moved that the CAPC purchase 760 copies of the book "How to Raise Emotionally Healthy Children" in English and 760 copies of the identical book in Spanish. The total cost of these books will be \$4191.23 including shipping and tax. CAPC recommends that this Child Abuse Prevention material be funded from the KIDSPLATE reserve. This Motion passed unanimously.

The Director requests that an identical motion be passed that will allow us to purchase the books in the same quantities as previously ordered. The current price of the books has not yet been negotiated, but at the time of this meeting, the Director will have a final price. This purchase would be funded from the KIDSPLATE Fund. (Current KIDSPLATE account \$56,125.73)
