
Captain_Plat_2258 is banned for a month by the GG this post serves to explain the rationale for that to the community

In short Kate was banned for the continued and repeated instances of t3 offences under the discord rules, baiting, abrasiveness, creating a hostile environment (tier 3 rule b) and constantly insulting others in chat (t3 rule d).

These rule violations were on reflection treated as a t2 offence of repeated t3s. In conjunction with continued and repeated mod action against Kate a one month ban is the action proscribed by the rules.

Much of the incident stems from an argument started in politics.







As far as we are considering Kate's conduct this is unacceptable and meets the threshold to be classed under multiple t3 rule violations.

Upon a consideration of the conversations, Kate's record of behaviour both recently where there have been a number of mutes in the past weeks for similar conduct and also the wider history of her last written ban;

> Kate is banned for a litany of t3 offences, spam, abrasive and toxic behaviour. We are opting to ban in this instance because of Kate's long history of such reactions to legitimately questionable comments and behaviour by other users. We are however reducing the ban from the one month term that might otherwise have been applied in light of the context of the situation and Kate having calmed down substantially subsequent to the incident.

Where she self admitted the reason for many of the previous instances where she was muted was intentional use of provocative language. Instead of a heated argument that got out of hand as we treated those instances as at the time in good faith.

To be clear, no community members need be subject to race baiting, abuse, harassment for any reason. Race baiting is not going to solve any proported problems.

This incident also followed another one earlier in the evening.

In short this is an all too common pattern of behaviour that fits the self described process of baiting other members towards some agenda.

We find that deplorable and stand behind muting Kate for a month at this point.

Winston is further at fault for his own conduct and has/will receive proportionate mod action and he will provided he does not reform may well face the same consequences as Kate of a significant ban for repeated t3 offences.
