Prahba questioned if our growth correlates with the growth of OT practitioners in Nevada. Aesa states she is working on trying to figure out what practitioners to Nevada want from the board. In the past, NOTA sent out postcards that was costly, but we did see an increase in membership. Our board is pretty much on par for all membership organizations.
- c. Judy Ishibashi states the state board is to protect members, and we serve OT practitioners, OT as a profession is collaborative.

The RA is going to go through substantial changes as with other parts of AOTA. Please refer to the Report of the AOTA Governance Enhancement Task Force:

The reasons why the RA is going to change are summarized here:

- There are some ongoing vacant RA positions.
- The RA, as a body of 50 plus voting members, is not nimble to tackle fast-changing professional issues.
- The RA Survey typically has a meager turnout of constituents' input on motions.
- The RA does not have the ability to work fluidly with the other parts of AOTA.
- There is a need to enhance the diversity and skill set representation in the RA.
- RA members are unsure of their role and become disengaged.

Instead of state representation, the RA will tentatively be the following in 2024:

A leadership team consisting of a:

- 1. Chairperson -voted in by an open AOTA members. The Chairperson will also be a voting member of the AOTA Board.
- 2. Vice Chairperson-slated (tentatively appointed); however, if more than one person is endorsed by petition of AOTA members (number TBD), there will be an election.
- 3. Agenda Chairperson slated as well.

AND

4. 12 to 25 members of the RA will be appointed by the leadership team and the Volunteer Development Committee in 2024. Priority is to represent diversity, skill set, and geographic location.

There was some "discussion" about increasing the input of State presidents to mitigate the lack of geographic representation during online and in person meetings. Still, I could not find anything in writing yet as everything needs to be approved by the Board.

Major takeaways:

As of 2024, there will NOT be a Nevada Representative for AOTA. The new RA (which will be renamed) is planned to be smaller, appointed, diverse, skilled, and efficient.
