ACTIVIST FACES JAIL FOR 'DEFAMATION ON TWITTER'

Bahraini women's rights activist Ghada Jamsheer was arrested on 15 September on 10 charges of "defamation via her Twitter account". Her detention order has been extended several times and her next hearing, which relates to one of the charges, is scheduled for 24 November. She is a prisoner of conscience.

BRITISH-IRANIAN ACTIVIST ON HUNGER STRIKE

British-Iranian woman Ghoncheh Ghavami has gone on her second hunger strike after learning she had been sentenced to one year's imprisonment in Iran and banned from foreign travel for two years for protesting for the right of women to attend sport events in Iran. Her verdict has not been formally communicated to her lawyer, which prevents her from filing an appeal. Ghoncheh Ghavami is a prisoner of conscience who must be released immediately and unconditionally.

MISSING EDITOR REPORTED IN ILL-HEALTH

According to an anonymous source newspaper editor Sergei Dolgov, who has been missing since his abduction by armed men in June, in Mariupol, eastern Ukraine, is held in a military base and suffering from serious health issues. His wife fears for his life.

JOURNALISTS' CASE TO BE DECIDED ON 3 NOVEMBER

Gambian journalists Musa Sheriff and Sainey M.K. Marenah will have their case decided by a magistrate on 3 November. They could be jailed for up to two years for the legitimate exercise of their right to freedom of expression. They would be prisoners of conscience.

LAWYERS SENTENCED OVER 'OFFENSIVE' TWEETS

A special court sentenced three Saudi Arabian lawyers to between five and eight years in prison over tweets deemed offensive to the Ministry of Justice. If imprisoned Amnesty International will consider them prisoners of conscience.

JOURNALISTS ACQUITTED AND DISCHARGED

On 10 November, Gambian journalists Musa Sheriff and Sainey M.K. Marenah were acquitted and discharged on the two counts of “publication of false news with intent to cause fear and alarm to the public” and “conspiracy to commit felony”. They had been on trial for more than 10 months. The magistrate of the Banjul Magistrate Court of The Gambia ruled that “the prosecution have failed to prove the essential ingredients of the offense on both counts” and decided to acquit and discharge journalists Musa Sheriff and Sainey M.K. Marenah. This ruling ends a 10-month long trial which caused distress to the two men and their families.

Following the ruling, both men announced they will continue their journalistic work and expressed gratitude to their supporters.

Sainey M.K. Marenah said "Words can't express how I feel, but I am happy. I am walking home a free man. I must commend Amnesty International and other international partners for their support. Their campaigns calling for our release and for charges against us to be dropped really bear fruits."

IMPRISONED ACTIVIST MUST BE RELEASED IMMEDIATELY

On 31 October, the Supreme Court of the Chechen Republic ruled that the term of Ruslan Kutaev's imprisonment must be reduced by two months but did not quash his conviction. Ruslan Kutaev is a prisoner of conscience and must be released immediately and unconditionally.

NO HOUSES YET FOR ALL EVICTED FAMILIES

The forced eviction of an informal settlement near Bobigny, on the outskirts of Paris, has left about 180 people homeless. Sixty are temporarily living in two social care centers in Paris after having slept several days in a gymnasium. The others were not given any temporary shelter.

ZAINAB AL-KHAWAJA RELEASED, AWAITS VERDICTS

Bahraini activist Zainab Al-Khawaja was released on 19 November after more than a month in detention for ripping up a picture of the King in court. The verdict in this case is expected on 4 December. The verdicts in a further three cases against her will be issued on 9 December. Zainab Al-Khawaja was released on 19 November 2014 following a court order. Zainab Al-Khawaja, who is due to give birth by caesarean section on 3 December, was leaving a doctor appointment she was taken to when she received the news. Zainab Al-Khawaja had been arrested on 14 October for tearing up a picture of the King while appearing before the High Criminal Court of Appeal in the capital, Manama, in relation to two separate cases. A Lower Criminal Court will issue its verdict on this on 4 December.

The High Criminal Court is scheduled to issue its verdicts on 9 December in three cases against Zainab Al-Khawaja. Two of these cases relate to “destroying government property” after she ripped up a picture of Bahrain’s King while she was detained in ‘Issa Town Detention Centre for Women on 4 and 6 May 2012 and the third case is on the charge of “insulting a police officer”. If her convictions are upheld and she is returned to prison, Amnesty International will consider her a prisoner of conscience. Although she has been released, the authorities still need to drop the outstanding charges against her.

No further action is requested from the UA network. Amnesty International will keep monitoring the situation and will take further campaigning action when necessary. Many thanks to all who sent appeals. This is the first update of UA 259/14. Further information:

DAVID TAM BARYOH FREED ON BAIL

Sierra Leonean journalist David Tam Baryoh, was released on bail on 14 November, after 11 days detained without charge in a maximum security prison. He now has to report to the police every Monday. He is a prisoner of conscience, arrested solely for exercising his right to freedom of expression.

FIRST ARRESTS SINCE NEW HOMOPHOBIC LAW

A law introducing possible life sentences for the offense of “aggravated homosexuality” was enacted on 9 October in Gambia. In the last two weeks, the National Intelligence Agency (NIA) and the Presidential Guards have arrested at least four men, a 17-year-old boy and three women on suspicion of “homosexuality”. Another six women have reportedly been arrested since 18 November. They could face a life sentence. Amnesty International considers people detained solely on the basis of their sexual orientation or gender identity to be prisoners of conscience.

‘MULTIMEDIA MONK’ FACES BASELESS CHARGES

The Venerable Loun Sovath, a Cambodian Buddhist monk and human rights defender known as the “multimedia monk” faces trial on baseless charges of incitement. If convicted he could be sentenced to up to two years’ imprisonment and a heavy fine. If imprisoned, he would be considered a prisoner of conscience.
