I. Call to Order

The January Business & Calendar Meeting of CEC District 13 was called to order by **President Cynthia McKnight**. Members and attendees were welcomed, and appreciation was extended to the principal and staff of **MS 915** for hosting the meeting.

A **land acknowledgment** was shared, recognizing that Brooklyn and New York City are located on Indigenous land. The council also acknowledged **Martin Luther King Jr. Day** and January recognitions.

II. Roll Call / Attendance

CEC Members Present:

III. School Construction Authority (SCA) Presentation

The School Construction Authority presented the **FY 2025–2029 Capital Plan** overview.

Capital Plan Highlights:

- Total five-year capital plan: **\$20.5 billion** citywide
- **\$6.98 billion** allocated for new school capacity
- **\$1.40 billion** for school electrification to reduce greenhouse gas emissions
- **\$1.25 billion** for technology upgrades
- **\$800 million** for accessibility improvements
- **\$150 million** for cafeteria enhancements
- **\$40 million** for physical education space upgrades

Capital Improvement Projects (CIP):

- Projects prioritized using the **Building Condition Assessment Survey (BCAS)**
- Focus on buildings rated **4–5** in architectural, mechanical, or electrical condition
- Includes roofs, heating systems, flood mitigation, safety upgrades, playgrounds, gyms, and auditoriums

Accessibility:

- Determined by DOE’s Office of Accessibility Programming (OAP)
- Accessibility solutions vary by building (ramps, elevators, bathroom upgrades)

Resolution A (Reso-A) Funding:

- School-specific projects funded by City Council, Borough President, or grants
- Encouragement for schools to engage elected officials for targeted enhancements

MWLBE Participation:

- SCA reaffirmed commitment to Minority- and Women-Owned Business Enterprises
- District 13 currently includes **3 MWLBE firms across 5 projects** totaling **\$1.31M**

CEC Capital Requests:

- CEC Capital Request forms due **January 17, 2025** for February amendments
 - Requests submitted after the deadline will still be considered

IV. District-Specific Facilities Discussion

Council members raised concerns regarding:

- Aging electrical systems in several District 13 schools
- Cafeteria modernization needs (salad bars, seating, water fountains)
- Playground safety, drainage issues, and sinkholes

SCA and Division of School Facilities (DSF) clarified:

- Safety concerns should be escalated first through custodial engineers and DSF
 - Urgent conditions may be escalated to SCA as **life-safety issues**
 - Ongoing discussions acknowledged regarding **PS 307 playground conditions**

V. Building Equity Together (BET) Presentation

Representatives presented **Building Equity Together (formerly FIRE – From Integration to Anti-Racism)**, a six-session parent and caregiver training series.

Program highlights:

- Builds cross-community relationships and leadership
- Focuses on equity, anti-racism, and inclusive school engagement
- Topics include outreach, meeting facilitation, language justice, and interrupting bias
- Sessions run **February–May 2025**, primarily on Wednesday evenings

Council members discussed sustaining equity work amid shifting political climates and emphasized the importance of community organizing and policy advocacy.

VI. Superintendent's Report

Superintendent **Meghan Dunn** shared updates and introduced district initiatives.

Facilities & Funding Opportunities:

- District presentation scheduled for **January 27** for principals, PTA presidents, and parent leaders
- Information on external funding opportunities, including a **\$25,000 Two Trees Foundation grant**

District 13 AIM – Math Assessment & Instructional Support:

- Presentation by district math leadership and SOLVED partners
- AIM assessments administered to grades **3–5** to track math progress
- Data dashboards used to inform professional learning and coaching
- Math coaching models include individualized school coaching and grade-level cohorts
- Saturday collaborative sessions support teachers in analyzing data and addressing misconceptions

District leadership emphasized an **asset-based approach** to instruction and ongoing efforts to move students toward proficiency.

VII. Council Announcements & Updates

- **Chancellor's Town Hall:** January 30, 6:30–7:30 PM at **PS 3**; community attendance strongly encouraged
 - Appreciation expressed to **Brooklyn Bank** and **PS 44 Principal Cotton** for holiday support and toy distribution
 - Schools asked to notify CEC13 when applying for elected-official funding to support coordinated advocacy
