## **Phone Script for Out-of-Network Coverage – Schema Therapy**

Hello, my name is \_\_\_\_, and I'm calling about my insurance benefits. I'd like to speak with someone regarding an out-of-network coverage request for a medically necessary, evidence-based psychotherapy treatment.

The treatment is Schema Therapy at Upstate Integrative Mind Counseling in South Carolina. It provides specialized, structured care for longstanding emotional and interpersonal difficulties. I'd like to explain why I'm requesting out-of-network coverage and provide some supporting information.
