The price was a series of compromises, for example over *capital gains tax*, that reduced technical efficiency.

There were, inevitably, some concessions, and one of the most notable was over the rate at which the *capital gains tax* was to be charged.

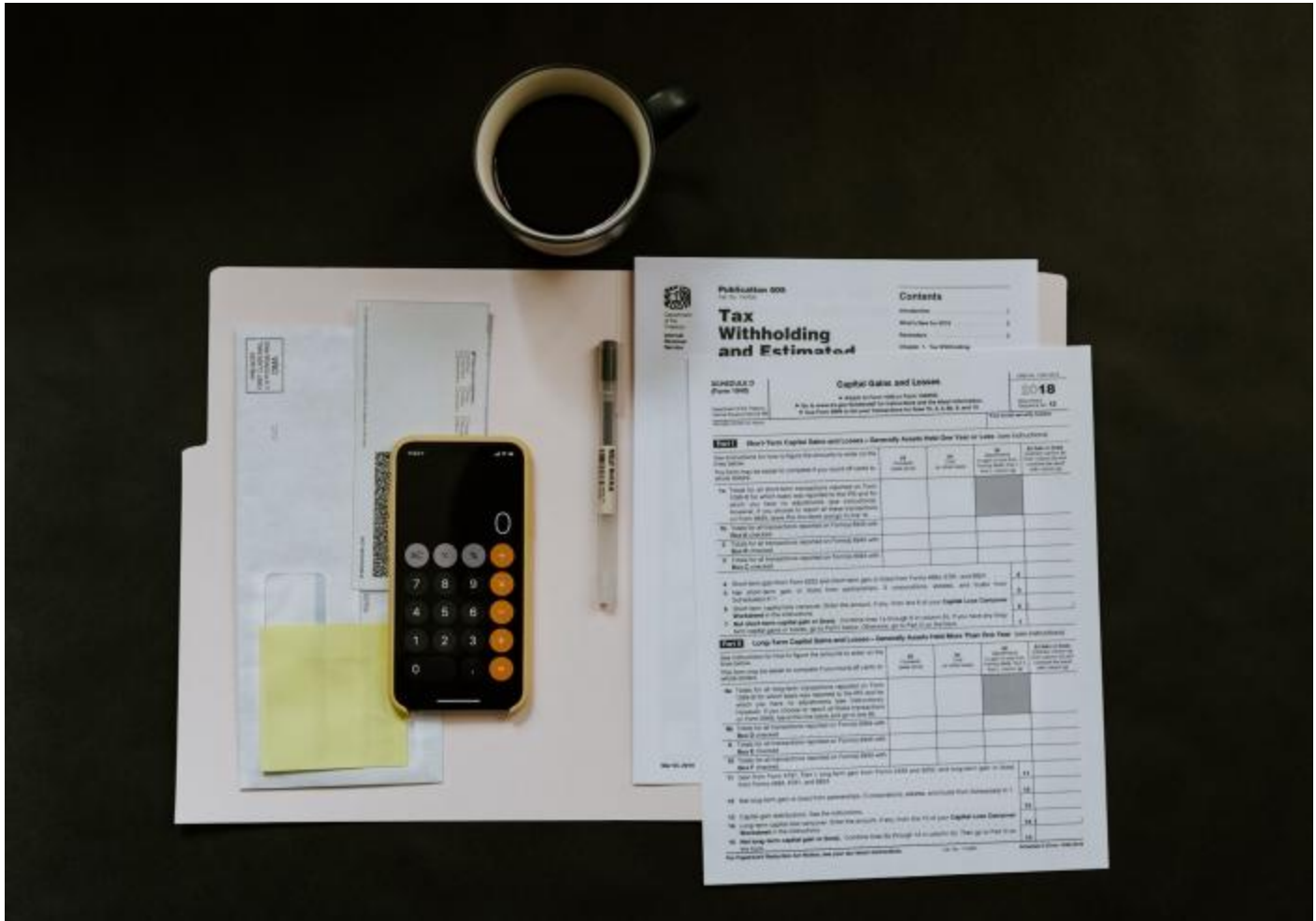
