C. Faculty Policy Review Team

Senior Councils will have a process for proposing changes/additions to the RFP at a later time, which will be subject to an approval process.
- ii. Four faculty and six administrators on PFRT are charged with creating the replacement for the RFP

  - a) split the document into parts: 1) teaching and learning and 2) everything else (which will go into a general employee manual)
