Abstract

The abstract text is written with a font size of 10 pt, and the Cambria typeface and the spacing between lines are one space. Article abstract are written in English, abstract should be written in English. 1. Introduction

The introduction should be succinct, with no subheadings. Limited figures may be included only if they are truly introductory, and contain no new results.

2. Materials and Methods

The materials and methods section should contain sufficient detail so that all procedures can be repeated. It may be divided into headed subsections if several methods are described.

3. Results and Discussion

This section may be divided by subheadings. It should provide a concise and precise description of the experimental results, their interpretation, as well as the experimental conclusions that can be drawn.

3.3. Advice on Figures

At the point of submission, authors may provide all figures embedded within the manuscript at a convenient break near where they are first referenced. All figures should be cited in the paper in consecutive order. Where possible, figures should be displayed on a white background. All figures must have an accompanying caption, which includes a title and, preferably, a brief description (see **Figure 1**).
