

Treaty of A.R.C.

Enacted: July 15th, 2021

Brief Overview

The 'Treaty of A.R.C.' marks the end of the Legends Of Reach Occupation that began July 27th, 2020. This Occupation began during the Sentinel war after Sentinel posted proof of LoR allowing ddosers into their clan, knowingly or otherwise, as well as former LoR members placing high ranking members of United Nordic Reich and Soldiers Of Retribution on 'X Resolver'. The Occupation served as a way to keep the coalition united as one front. The LoR High Council decided to rebel against the Occupation and remove SoR and UNR personnel from their Discord server.

On August 13th, 2020, a second Occupation was agreed to with the hopes of creating better relations, this backfired and LoR once again removed UNR and SoR personnel from their Discord server. From this point on LoR had been seen as a 'Rebel State' of UNR and SOR.

Another attempt at a peaceful resolution took place on March 27th, 2021. UNR and SOR met with LoR and gave them these terms: post an apology publicly, three (3) events with both UNR and SOR, and access to the LoR Discord Server Audit Log for two (2) hours. A forty-eight (48) hour grace period was given to LoR to internally discuss and decide on their decision. This decision was never given even after repeated attempts to contact LoR.

Current Agreement

On July 7th, 2021, it was agreed that LoR would no longer be considered a 'Rebel State' of UNR and SOR and neutral relations would be started if the following actions take place:

- ❖ An official Apology from LoR will be drafted including the following points:

- Acknowledge and admit to the mistake of associating with the ddosing organization known as 'Cweam Team'.
 - Apologize for breaking both Occupation Documents by removing SOR and UNR personnel from the LoR Discord Server.
 - Apologize for the toxicity as well as the public and private slander towards UNR and SOR.
 - Acknowledge SOR's and LoR's close alliance/relationship before the formation of A.R.C.
 - Acknowledge being a 'Rebel State' of SOR and UNR due to breaking the Occupation Document.
 - Acknowledge the effort and time SOR and UNR put in to resolve this conflict.
 - Thank UNR Eisen for defending LoR's name for over eight (8) hours after Sentinel released proof of LoR associating themselves with ddosers.
 - ❖ Complete five (5) Official events with both UNR and SOR which totals ten (10) events. This must be done by August 26th, 2021, exactly six (6) weeks.
 - UNR - Two (2) Raids, one (1) defense and one (1) attack, the ownership of the map will be given to the victor, the loser will relinquish all rights and ownership.
 - UNR - One (1) '4v4 Set', best of five (5) games using 343 maps and game modes.
 - UNR - One (1) Frontline, using UNR map and gamemode.
 - UNR - One (1) Team Tactical Set, best of five (5) games, maps to be decided at the event, UNR Gamemode.
 - SOR - One (1) Raid, SOR defense.
 - SOR - Two (2) Warzone Warlords, best of three (3) games each.
 - SOR - One (1) Tank Battle, SOR version.
 - SOR - One (1) Team Tactical, SOR version.
 - ❖ If the above points are not completed properly, LoR will remain a 'Rebel State' and *must* fight a conventional war to completion against UNR and SOR. A conventional war being a proper ROE is established and events are completed against one another with rights to the maps at stake.
