To the Great People of the Atlantic Commonwealth,

It is with great honor to announce that I am officially running for the State Assemblyman in the upcoming Atlantic Commonwealth election. For far too long, the Atlantic Commonwealth has been stuck with choosing between two parties, two candidates, and two different agendas. In this upcoming election, the people of the Atlantic Commonwealth will have the choice between the Republicans, the Democrats, or myself, an independent from the upstate New York area.

In this election, I am running on a moderate populist agenda, focusing on improving our children's education while ensuring their safety, improving the benefits of having children within the Atlantic Commonwealth, encouraging green energy and nuclear energy without breaking the bank, protecting our lands from aggressive purchasing by foreign hostile nations such as the People's Republic of China, improving upon our state parks and hunting laws to promote the beauty and traditions of our state, and most importantly, improving the livelihood of all Atlantic citizens. While, the members of the Republican Party and the Democratic Party campaign on polar opposite agendas, I will be campaigning to serve the people. The agenda of my term will be the service of the people, not party interests.

While I may be new to the political stage in the Atlantic Commonwealth, I have already committed to proposing half a dozen bills covering different topics of my plans for the Atlantic Commonwealth. I would like to speak on behalf of a few of them. On January 15th of this year, I submitted A.B. 131, the Whole Milk in Atlantic Commonwealth Schools Act. Under this bill, parents and students will have the choice to have once again whole milk produced in the Atlantic Commonwealth with their breakfast and lunch. Whole Milk is an important source of calcium and essential nutrients for our children. Whole Milk being reintroduced to school lunches benefits our students and helps ensure the sustainability of our dairy farms, as we have lost one too many over the past decade.

In addition to A.B. 131, on January 23rd of this year, I submitted A.B. 134, the "Officer in Every School Act." Under A.B. 134, every county Sheriff's Office and local municipal police department will be required to hire, train, and administer a minimum of one School Resource Officer per school within their jurisdiction or county. As school violence increases in the country, the only solution to the problem has been to violate the United States Constitution by slowly stripping fundamental rights from our citizens. The solution is not the continuing assault on our rights, but rather providing the necessary tools and resources for our schools to be safe. With additional funding to law enforcement for establishing these School Resource Officers, it is my goal that this bill will see an officer patrolling every school by 2025.

Lastly, on January 17th of this year, I submitted A.B. 132, the "Foreign Purchases of Atlantic Commonwealth Land Prohibition Act." Under this bill, the Governor of the Atlantic Commonwealth would be granted the power to take the necessary action, as the Governor sees fit to seize all land and real estate from hostile foreign peoples, countries, and entities. The cost of living, specifically rent, has increased dramatically over the past five years to all-time highs. This rent increase has been directly linked to 1/3rd of the institutional investment in single-family rental homes owned by foreign nationals, most have no interest in the prosperity of the Atlantic Commonwealth or the United States. In the mid-western United States, Chinese Nationals loyal to the People's Republic of China and the evil Chinese Communist Party have been buying fertile farmlands in record numbers, controlling over 192,000 acres. These actions made by the People's Republic of China and nations like them are a direct threat to our nation's sovereignty and our nation's most important resource, food. Soon, our food prices will go up, as the sole controller of these lands seeks to undermine our nation. A.B. 132 will seek to prevent such.

As a God-fearing Christian, father, husband, and loyal member of the community, I believe that the people can enact the actual change we wish to see within our state and our country. It is time to put behind us the party lines and the division we have faced for long enough.

I hope to have your vote in this upcoming state election. May God bless you all and the Atlantic Commonwealth.
