COVID Policy

EAGxSingapore 2022

Last updated: August 26, 2022

Summary: We require attendees to be **doubly vaccinated**, and encourage folks to get a booster shot if they can. Additionally, attendees will be asked, but not required, to take a rapid test before coming to the event. **Mask-wearing is optional but recommended for indoor and outdoor settings** for persons who are 6 years old and above. Surgical masks and Antigen Rapid Test (ART) kits will be available on-site if you need them.

This protocol may be updated to reflect the latest government and local state policies.

To create these guidelines we have considered venue rules, the Singapore government and WHO guidelines.

It is possible that our guidance may change between now and the event. Please check back regularly and consider whether travel insurance or other contingencies might be useful to your planning.

If you feel uncomfortable coming to EAGxSingapore due to concerns about contracting or spreading COVID (or for any other reason), you can get a full refund on your ticket at any time. If you want to cancel and need assistance, feel free to contact the team at singapore@eaglobalx.org.

Vaccination

We require attendees to be fully vaccinated with WHO EUL vaccines. You must have proof of vaccination with a full course of an approved vaccine.

- You must have had your final dose of the vaccine at least 14 days before you attend the event. The day you had your final dose does not count as one of the 14 days.
- Proof of natural immunity will not be accepted as an alternative to proof of vaccination.
- Children born on or after 1 Jan 2010 (i.e. aged 12 and below by year of birth) will not require vaccination.

We strongly encourage you to get a booster shot, if it is available to you. Do take note that to stay in Singapore beyond 30 days and continue to enjoy vaccinated privileges, they must meet our domestic requirements to be considered fully vaccinated. This includes the three-dose requirement for Sinovac and Sinopharm, and the booster requirement.

Proof of Vaccination

You must carry vaccination evidence and produce this evidence if requested to do so. There are different ways you can show proof of your COVID-19 vaccinations including:

- A local <u>Covid-19 digital certificate</u>
- An International Covid-19 digital certificate

Travel Advice

As of 1 April 2022, test requirements for **vaccinated travellers** to Singapore are no longer required — and you do not need to quarantine on arrival (see here for more details).

Other countries may have rules about what you need to do to leave the country to travel to Singapore, or what you may need to do to return to your country of origin. There are no restrictions imposed on departures from Singapore. However, travellers must abide by the travel requirements imposed by their overseas destination. Onsite Protocols

- Attendees who are sick or exhibiting symptoms of COVID will be asked to stay
 home and will be offered a full refund. If you are testing positive for COVID, do
 not attend the event.
- Attendees will not be required to provide proof of a negative test on entry, but we
 encourage all attendees to take a lateral flow test beforehand (within 48 hours of
 entry).
- All of CEA's vendors and contractors must adhere to the current COVID guidelines set out by the local government. We are doing our best to ensure that all vendors and contractors will be vaccinated.
- We plan to allow minors to attend the conference, including children who are too young to be vaccinated. We estimate that fewer than 10 children below vaccination age will be present.

If You Test Positive for COVID

If you test positive for COVID at any point during or shortly after EAGxSingapore:

• Please leave the venue immediately and return to your hotel or other accommodation. If you have travelled to Singapore for the conference, we will

- reimburse you for any extra travel or accommodation costs that arise should you be stuck in town due to contracting COVID (assuming you are unable to easily return home while positive).
- Participants who are well but have self-tested positive on an Antigen Rapid Test
 (ART) or were assessed by a doctor to have mild symptoms can only attend after
 testing negative on an ART self-test at the end of a 72 hours self-isolation period.
- Mask-wearing is optional but recommended for indoor and outdoor settings for persons who are 6 years old and above.
- Surgical masks, hand sanitiser and Antigen Rapid Test (ART) kits will be available on-site if you need them.
- We encourage you to reach out to any attendees you had meetings with to let them know you have tested positive as we are not planning to do any direct person to person contact tracing ourselves.
