# Terms of Use

These Terms of Use (collectively the «Terms») set forth the legally binding terms and conditions which are applicable to your use AI Speedometer: Speed Test GPS from Ghulam Fareed. In this policy, Ghulam Fareed may also refer to «We» or «Us».

Please be reminded that the Terms constitute an agreement between you and Us. Therefore, we encourage you to carefully familiarize yourself with the Terms. License
