Introduction

At Gaiwan Ceramics, we are committed to protecting your privacy and ensuring the security of your personal information. This Privacy Policy outlines how we collect, use, disclose, and safeguard your information in compliance with applicable privacy laws.

www.gaiwanceramics.com (each a "Website," and collectively the "Websites") is owned and operated by Little Joys LLC, dba Gaiwan Ceramics ("Gaiwan Ceramics")

Gaiwan Ceramics recognizes and respects the importance of maintaining your privacy, and as a result, has established this Privacy Policy ("Privacy Policy"). Throughout the Privacy Policy, the terms "we," "us," and "our" refer to Gaiwan Ceramics and the terms "you" and "your" refer to any visitor to one or more of the Websites. This Privacy Policy applies to information we collect on the Websites, and does not govern information collected from you in any other manner.

This Privacy Policy is intended to help you understand the types of information we may collect from you or that you may provide when you visit one or more of the Websites, and describes our practices for collecting, using, maintaining, protecting and disclosing such information.

In viewing and using each of the Websites, you understand that we may use your Personally Identifiable Information (as defined below) subject to the terms of this Privacy Policy, and you consent to (i) the terms of this Privacy Policy and the Terms & Conditions (located at <u>Terms and Conditions</u>) and (ii) to the collection and use of Personally Identifiable Information and other information by us pursuant to the terms of this Privacy Policy.

Website Intended Audience

Our Websites are intended for individuals eighteen (18) years of age or older. We do not knowingly collect personal information from individuals under 18. If you are under 18, you are prohibited from: (i) using or providing any information on the Websites or through any of the features available on the Websites, and (ii) providing any personal information to us, including but not limited to your name, address, telephone number, e-mail address, or any screen name or username you may use.

If we become aware that we have collected or received personal information from an individual under 18 without verified parental consent, we will promptly delete that information. If you believe that we may have collected information from or about an individual under 18, please contact us at contact@gaiwanceramics.com.

Please note that individuals under 18 years of age may register for classes offered by Gaiwan Ceramics, provided that registration and a waiver are completed in person at one of our studios by a parent or legal guardian.

Information Collection

When you access or use one or more of our Websites, we may collect information from you.

We collect the following types of information:

- **Personal Information**: Name, address, email, phone number, and payment details provided during registration or transactions.
- Usage Data: Information about your interactions with our website, including IP addresses, browser types, and access times.
- **Membership Data**: Details about your membership or participation in classes, workshops, or other studio programs.
- Photos and Artwork: Images of participants, artwork, or events captured in the studio with consent.

Additionally, third-party service providers such as Wix may provide us with information about you, subject to the terms of this Privacy Policy. This information may include, but is not limited to, personally identifiable information such as your name, email address, postal address, and telephone number ("Personally Identifiable Information"), as well as other information related to you that does not identify you individually.

Providing Personally Identifiable Information is voluntary. By submitting such information through one or more of our Websites, you confirm your agreement to the terms outlined in this Privacy Policy, provide your express consent for the collection, use, and processing of your Personally Identifiable Information in accordance with this Privacy Policy, and agree to abide by the Terms of Use located at Terms and Conditions (the "Terms and Conditions"). If you choose not to provide certain information, you may be unable to access specific activities, features, or transactions available on or through the Websites.

When you visit the Websites, we automatically collect certain information about your device. This may include details such as your web browser type, IP address, time zone, and cookies installed on your device. Additionally, as you navigate the Websites, we collect information about the individual web pages or products you view, the websites or search terms that directed you to the Websites, and how you interact with the Websites. This automatically collected information is referred to as "Device Information."

Cookies and Tracking Technologies

"Cookies" are data files that are placed on your device or computer and often include a unique anonymous identifier. We use cookies to enhance your experience on our Website. If you would prefer not to have such cookies stored on your computer, you may modify your browser settings to warn you every time a cookie is sent, to disable most cookies, or manually remove cookies that have been placed on your computer. "Log files" track actions occurring on the Websites, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.

"Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Websites.

Information Usage

Your information is used for the following purposes:

- To process memberships, payments, and reservations.
- To communicate important updates, class schedules, or promotional offers.
- To improve our services and tailor your experience in the studio.
- To comply with legal obligations or resolve disputes.

We may collect Personally Identifiable Information from you so that we can: (i) contact you to respond to inquiries related to purchasing our services, including workshops, events, ceramics studio passes, and Resident Ceramics as well as other services and our products, and in connection with the processing, fulfillment, and completion of purchases; (ii) contact you to respond to inquiries related to the Websites or our services; (iii) provide you with information or advertising relating to our products or services; (iv) screen our orders for potential risk or fraud; (v) provide you with access to specialized portions of the Websites (your "Account"); (vi) store information about your preferences, allowing us to customize your Account according to your individual interests; (vii) customize and enhance the services we offer and (viii) communicate with you to provide you with relevant information about us, including special offers, promotions, discounts and newsletters.

We collect Personally Identifiable Information solely for the purposes of providing these services, but may collect non-personal information in order to operate, maintain, and improve the Websites and our services. In all of these cases, we will collect Personally Identifiable Information from you only if you voluntarily submit such information to us or to Wix.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally we use aggregate tracking information to improve and optimize our Websites (for example, by generating analytics about how our customers browse and interact with the Websites, and to assess the success of our marketing and advertising campaigns).

Additionally, we may use IP address information to count and track aggregate visits to the Websites, to help diagnose problems with our server, and to administer the Websites. We do not link IP addresses to anything personally identifiable, so while a particular user's session can be tracked, the user remains completely anonymous.

We may share your information in the following circumstances:

- **Legal Requirements**: When required to comply with legal obligations or protect the rights and safety of the studio or its users.
- Marketing Partners: With your consent, for promotional collaborations or advertisements.

Except as provided in this Privacy Policy, or as otherwise permitted or required under law, we reasonably attempt to ensure that we do not intentionally disclose any Personally Identifiable Information about you as an individual user to any third party without having first received your permission (through your opting in or otherwise agreeing to the disclosure of such information).

We will release information, which may include your Personally Identifiable Information as required by applicable laws or regulations to comply with any legal valid inquiry or process such as a subpoena, search warrant, statute or court order or any other lawful requests for information we receive. We will also release specific information, which may include Personally Identifiable Information, in special cases, such as if there is an attempted breach of the security of the Websites or a physical or property threat to you or others. We may also transfer user information, including Personally Identifiable Information, in connection with a corporate merger, consolidation, the sale of related assets or corporate division or other fundamental corporate change.

We may employ other companies and individuals to perform functions on our behalf such as postal mail and email communications, customer lists management, data analysis, marketing services, credit card processing, and customer relationship management. These companies and individuals have access to personal information needed to perform their functions, but they are not permitted to use such information for other purposes without our permission. For example, we use Wix to power our online store and to allow you to book classes and process payments for classes located at www.gaiwanceramics.com,. To obtain information regarding how these third-parties treat your personal information, please refer to their respective privacy policies.

In addition, on occasion, we may collect Personally Identifiable Information from you in connection with optional contests, special offers or promotions. We will share such information with necessary third parties for the purpose of carrying out the contest, special offer or promotion. Your participation in the contest, special offer or promotion constitutes your consent to such disclosure and use of such Personally Identifiable Information.

We may share your Personally Identifiable Information in order to enforce or apply our Terms of Use and other agreements, including for billing and collection purposes and/or if we believe disclosure is necessary or appropriate to protect our, our customers', or others' rights, property, or safety.

We may share with our partners aggregated statistical data that includes users' demographic information but does not identify them. We reserve the right to provide any and all such aggregated and non-individually identifiable data to third parties.

SMS Consent or phone numbers are not shared for the purpose of SMS with third parties or affiliates.

Online Purchases

When you purchase a product through the Website, Wix will process your payment. Introduction

These terms and conditions ("Terms" or "Terms of Use") govern your access to and use of the Websites, as well as the content, functionality, goods, and services offered through them. Throughout these Terms, the terms "we," "us," and "our" refer to Gaiwan Ceramics, and the terms "you" and "your" refer to any visitor or user of the Websites.
