*Result:* The Result section should summarize findings directly related to the stated purposes of the study. If the project is ongoing and no results are available at the time of submission, please include projected results.

*Conclusion:* The Conclusions section must explicitly state the extent to which the stated purposes of the article have been met. In the case of an ongoing study, please discuss the potential implications (both theoretical and clinical) of the findings.

### **INTRODUCTION (1<sup>st</sup> Heading)**

The introduction should briefly place the study in a broad context and highlight why it is important. The introduction contains the background of the problem, research objectives, research benefits, and theoretical studies and ends with a hypothesis (if any). The maximum number of introduction pages is two pages or 20% of the 12 manuscript pages (the maximum number of pages for each article title). The background of the problem is the phenomenon behind the background or urgency to conduct research. Writing problems and research objectives are written in a narrative manner accompanied by theoretical studies or previous research that supports this research (state of the art). Theoretical studies or previous research is a description of the dynamics of the development of the field of science under study supported by theoretical arguments sourced from primary and up-to-date information so that the exposure shows the novelty of this research compared to previous research.

Writing the source of information for the theoretical study in the text must be clear by writing the author's name and citation of the source, which is in the form of the year of publication and the page where the text is located. For example: research results show that more than 70% of

students are unable to recognize authentic problems (Syahputra, 2023). The citation format uses the APA style 7<sup>th</sup> edition. If the citation is a direct quote, it is also necessary to include the directly cited page. The page indicator if the reference source is in a foreign language uses the symbol (p.) or (pp.) if more than one page. If the reference source is in Indonesian, the page indicator uses the abbreviation pp.

The elements in the research method are variable identification, research subjects, research instruments, and research methods, as well as statistical analysis techniques used to process research data. The research method is an explanation of the research process carried out by the researcher, to encourage and provide opportunities for other researchers to make improvements and developments to future research. The maximum number of pages is two pages or 20% of the total number of manuscript pages and avoid using theoretical definitions quoted from books in the exposure in the research methods section.

## **RESULT (1<sup>st</sup> Heading)**

Research results present research findings in the form of descriptive statistics, assumption tests, and hypothesis tests that are analyzed critically and scientifically. Research results can be supplemented with tables or figures and should prioritize exposure in the form of text. The maximum number of pages of research results is two pages or 20% of the total number of manuscript pages.

All tables and figures written in the manuscript must be adjusted to the order of 1 column or full size of one paper, to make it easier for reviewers to discern the meaning of the image.

The discussion substantially presents the results of the analysis and comparisons with previous findings based on a review of relevant, current, and primary literature. Comparisons that tend to lead to differences with the results of previous research have the potential for the development of science and technology. The maximum number of pages is four to five pages from the total number of manuscript pages of 12 pages.

## **CONCLUSION (1<sup>st</sup> Heading)**

The conclusion should clearly explain the results obtained, the advantages and disadvantages, and the possibility of further development. The conclusion is the answer to the research objectives and not a summary of the research results. Conclusions are presented in a concise, clear, and concise manner based on the results and discussion. The conclusion is written in paragraph form (not numerical), contains research findings as a synthesis between the results of data analysis and discussion results, and emphasizes new things that contribute to the development of science and technology. The maximum number of pages is one page out of 12 pages.

The reference library is a list of references or references that contain sources of information used or referred to in the article. Every source cited in the body of the text must be listed in the reference library. Vice versa, what is written in the reference library is the reading sources used in the body of the text. The style of writing the reference library uses the American Psychology Association (APA) model.
