The paper is formatted into single columns with single spacing and Top vertical alignment. The page setup for Journal of Industrial Engineering (JIE): Top and inside = 3.05cm, Bottom and outside = 2.03cm, Gutter = 0 cm. The paper size is A4 with portrait and mirror margin. The layout is Different odd and even with Header =1.25cm and Footer =0.76cm. To make sure that the paper is properly formatted to the requirement is to use this document as a template and copy paste your content into this document.

2. Methods

In Research Methodology section, it explains the conducted research in detail. The author must outline the material and the methods used in the research, including the subject/material studied, the tools used, the design of the experiment, the sampling technique, the variable to be measured, the data collection technique, analysis, and statistical models used. Successive quotes in parentheses [1].

3. Result and Discussion

Tables and figures should be numbered sequentially using Arabic numeral. All tables and figures should be named and centered. The caption of a table should appear at the top of table in Trebuchet MS 9 pt. The caption of a figure should be appearing at the bottom of the figure in Trebuchet MS 9 pt. 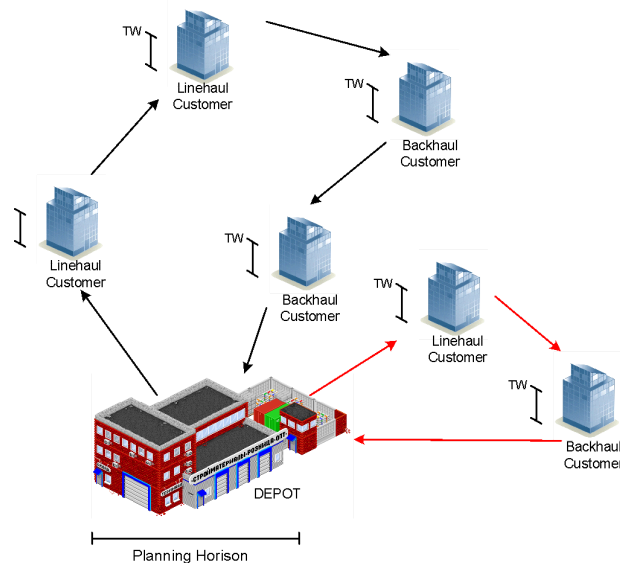


Figure 1. System architecture for VRPBMTTW

4. Citing References

A citations and references follow the APA 6th or 7th Edition format. The references should be listed in the **alphabetical order** of the author names and in the order of the publication years within the same author's works

The minimal reference used was 20 reference dates (at least 10 years of writing articles, unless the discussion is limited) Content writing is not the responsibility of the editor, and the editor reserves the right to make changes and correct grammar in every script that is loaded.

The references and citations should use Reference Manager, such as Mendeley, Zotero, etc.

Each reference should be written in the order of the authors, the publication year, the title or source.

Journal names, names of conferences, proceedings, and book titles should be italicized and should have the first character of each word uppercase, except for the conjunctions and articles.

The article title should be written between apostrophes, e.g., "The Example of...." and should have the first character of each word uppercase, except for the conjunctions and articles. The volume, series and pages are written consecutively.

The three authors or more authors of a reference should be written as (Author Surname, Author Surname, & Author Surname, Year), for instance, (Brinkworth, G. D., Noakes, M., Buckley, J. D., Keogh, J. B., & Clifton, P. M., 2009). at the end of a sentence, or Brinkworth, G. D., Noakes, M., Buckley, J. D., Keogh, J. B., & Clifton, P. M. (2009).in a sentence. It is recommended to avoid referring a Web source since the availability is not secured. If there is an official document source, for instance, a journal paper, for the same document, please refer the official document. However, you may sparingly use Web sources. In the case, when available, the title, the author name, and the year should be clarified in addition to the detailed address.

5. Conclusion

This sections should summarize the key findings without repeating all the details. This section should also state whether the research objectives has been achieved or not. It is suggested to write conclusions in paragraph description rather than bulleted lists.
