 - TODO: take statutes to the trade registry
- **Andreas** proposed that for paid bugfixes we approve any new developers added to the bug fixers on a case by case basis.
- There was a proposal from Giovanni Manghi to do monthly bug fixing but the PSC felt we do not have the funds to support this yet - will keep it on the roadmap for future.

Other information:

- Finances:
 - Still waiting for PayPal approval to have our own paypal account - should be smoother once the Trade Registry process is done.
- Meeting budgets:
 - Lene submitted a funding request to OSGEO board
 - Anita will help Lene get the funding request into a state that is likely to be accepted (there is only 5000 USD in the budget)
 - **DONE:** OSGEO approved 3,500.00 USD in sponsorship and 1,500USD in risk share.
 - Danish user group is contributing 25,000 Danish Kroner
- Redmine migration:
 - Richard and Juergen will move the server over to a hetzner / server in Essen hackfest - **DONE** - Big thank you to Jürgen and Richard
 - We discussed the possibility of doing a mass ticket closure for old tickets. Paolo felt strongly that we should not do a mass closure since many of the tickets are still valid.
 - **TODO:** PSC proposed that we will promote the new faster ticket platform and do some general promotion to get the old tickets closed. **Paolo** will take the lead on

promoting the tracker and bug fixing in general this in collaboration with Giovanni and other interested parties. Paolo proposes that we try to find maintainers for different ticket categories.

- **Lene:** Still needs people to sign up with workshop proposals.
- **Tim:** To help Lene with writing up some marketing materials.
