The Senate of University "Isa Boletini" in Mitrovica, after examining the request prot.no. 1555, dated 04.07.2022, submitted by prof. ass. dr. Bahtir Hyseni, a professor at the Faculty of Food Technology of University "Isa Boletini" in Mitrovica, to be allowed for free the period from August 1, 2022 to January 31, 2022, for focused research at a foreign university, specifically at public university of Ohio - USA. Based on article 161, paragraph 1, of the Statute of University "Isa Boletini" in Mitrovica, in the meeting held on 07.07.2022, took this:

### **DECISION**

- I. Prof. ass. dr. Bahtir Hyseni, a professor at the Faculty of Food Technology of University "Isa Boletini" in Mitrovica, is allowed to take a free period of 6 months, with payment, during the academic year 2022/23, for scientific research at public university of Ohio USA.
- II. The aforementioned as in point I of this decision, the period of scientific research focused on the field of biotechnology, through Fulbright Schorarship, will use from 01 August 2022 to 31 January 2023, according to request prot.no. 1555, dated 04.07.2022.
- III. Based on Article 161, paragraph 1, of the Statute of the UIBM, during the free period defined as in Article II of this decision, the aforementioned will be entitled to the full salary (without other functional allowances).
- IV. The Academic Unit, in cooperation with the relevant department, during the period of free use for scientific research by the aforementioned, must ensure free replacement for the subjects taught by Prof. ass. dr. Bahtir Hyseni, or the subject to be held as a block of lectures in one semester (Article 132, paragraph 3 of the Statute of UIBM).
- V. Prof. ass. Dr. Bahtir Hyseni is obliged to bring the report on the results achieved during the period of scientific research.
- VI. This decision enters into force immediately.

## Reasoning

UIBM's Senate, in the meeting held on 07.07.2022, examined the request no. prot. 1555, dated 04.07.2022, submitted by prof. ass. dr. Bahtir Hyseni, professor at the Faculty of Food Technology of University "Isa Boletini" in Mitrovica, to be allowed for free,the period from 01 August 2022 to 31 January 2022, for focused research at a foreign university, namely at public university of Ohio – USA, for the purpose of post-doctorate scientific research, that will serve him for advancement in biotechnology sciences.
