

## Jackbox Games 'New Year's Eve Redemption Giveaway' Promotion Rules

1. Eligibility: No purchase necessary to enter or win the giveaway. The Jackbox Games New Year's Eve Redemption Giveaway promotion is open to legal residents of the 50 United States and D.C., who are at least eighteen (18) years of age as of 12/15/21, except employees of Jackbox Games ("Sponsor") and its affiliates, partners, and advertising and promotion agencies, and anyone else involved in the development or execution of this Contest (collectively the foregoing entities are the "Contest Entities"), and the immediate families or household members of each. There will be one hundred (100) winners selected from all eligible participants selected at random. The contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law or regulations.

2. How to Enter: Fill out [this form](#). Entries must include proof of the entrant's residence in one of the five following cities: Glendale, AZ, Newark, NJ, Anchorage, AK, Fremont, CA, or North Las Vegas, NV. In order to show proof of residence, entrants must provide an image of one of the following: Photo in front of favorite local bar and/or restaurant, Photo in front of 'welcome to X' city sign, Photo in front of local library, Photo with local city landmark, or a Photo of local newspaper. In addition, entrants will be asked to describe the photo and how it represents their city of residence.

To be eligible for the Contest, all entries must be received between 1PM CT on 12/15/21 to 12/29/21 at 11:59PM CT ("Promotion Period"). Limit: Each participant ("Entrant") may enter one (1) time during the Promotion Period.

3. Prize:

One hundred (100) Grand Prizes: The Grand Prize winners will each be awarded one (1) free Steam code for *The Jackbox Party Pack 8*. Prize is non-transferable and no substitution by winners or cash equivalent is allowed. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Winner is solely responsible for the payment of all federal, state and local taxes and all other expenses or costs relating to the prize not expressly set forth above.

4. Selection of Winners: One hundred (100) Grand Prize winners will be selected at random from all eligible entries. Judges' decisions are final and binding in all matters relating to this Contest. Winners will be selected after the Promotion Period has ended. Potential winners will be notified via the email address from which their entry was received on or about 12/30/21 and will be given instructions on how to claim the prize. Potential winners must respond to the initial notification within 48 hours after delivery. Potential winners subsequently may be required to sign and return an affidavit of eligibility and liability release (and, where permitted, a publicity release) within an additional five-day period. Failure to comply with any requirements on a timely basis may result in disqualification and award of prize to an alternate winner. Odds of winning depend on the number of eligible entries received. Prizes will be fulfilled within approximately 8-10 weeks after the conclusion of the Contest.

By participating in the Contest, you agree to be bound by these official rules, including all eligibility requirements. Sponsor reserves the right to: (i) permanently disqualify from any contest it sponsors any person it believes has intentionally violated these official rules; and (ii) suspend, modify or terminate the Contest if Sponsor believes, in its sole discretion, that malfunction, error,
