  The voice feature really is a great way to get an authentic response
  from a student which should reflect their understanding of that
  particular question.
- Does this assessment allow for teachers to provide constructive feedback to students?

I didn't see a comment feature built directly into the assessment, but Schoology does seem to have a myriad of ways in which to communicate with students, so yes, I think this is covered.

- Does this assessment inform instruction?
   It should. If you have proof understanding, or a lack thereof, you can adjust instruction.
- Does this assessment offer (an) opportunity for **students to learn from each other**?

I did not see how students would interact with one another with this assessment, so collaboration seems limited here.

Is this an equitable assessment for learning?
 As far as affordances in terms of accommodations, this does seem to have an equitability built in to the features available for students.

- Screencast time length and audio/video quality.
   The video was well done, and met time requirements with no loss of information. Audio and visual were very good quality as well.
