Definitions

For the purpose of this Privacy Policy:

Application refers to the "Days Until" App, developed by DreamSense.

You indicates the individual using or interacting with the Application, or the company, or any legal entity on behalf of whom such an individual uses or accesses the Application, as applicable.

Collection and Use of Your Personal Data

Types of Data Collected

Usage Data

Usage Data is auto-collected during your interaction with the Application. This may include information such as your device's Internet Protocol address (IP address), browser type and version, the pages of our Application that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers, and other diagnostic data.

Use of Your Personal Data

The Application does not store or share any personal data. This means we do not store your name, email address, or other personal details. We only use the personal data that you voluntarily provide within the Application. Apart from the Usage Data mentioned above for Application enhancement, the Application does not collect any personal data during your use.

Retention of Your Personal Data

The Application does not hold any personally identifiable data.

Security of Your Personal Data
