On 1/18/22, all but one city councilmember, Antonio Lewis, voted **in favor** of a resolution to create a new "Buckhead Public Safety Task Force." The resolution was sponsored by Mary Norwood—the same Mary Norwood who wrote an affidavit in support of overturning the Georgia election results to give the election to Trump! You can read more about why this was such a bad idea here.



We are disappointed that so many council members voted in favor of this Resolution—and it's important that we communicate this to them so that they are accountable to us going forward!

We're not trying to attack these councilmembers, but we do want to let them know that we're disappointed and that we're watching! Some sample talking points (but make the language your own!):

- As a resident of your district, I was concerned to see that one of your first votes as a councilmember was for a Buckhead Public Safety Task Force. Buckhead doesn't need more city resources, especially when their crime rates are actually some of the lowest in the city.
- I encourage you to oppose similar efforts going forward. Councilmember Norwood wrote an affidavit in support of overturning Georgia's election results to give the election to

- Trump, so it's concerning to see progressive members of council collaborating with her rather than calling her out for these anti-democratic actions.
- I voted for you to be a bold progressive on council, so I was disappointed to see several of the progressive members tip-toeing around Buckhead interests so early I hope you'll take a firm stand against these attempts in the future!
