



## Here's how to unmask and identify I.C.E. agents\* by passing "An Act Ensuring Law Enforcement Identification and Public Trust" this session! (MA HD.4886)

**\*When they're masked and have no warrants or badges, we can't be certain they *are* agents.**

Taxpayers, voters and residents of MA are seeing unprecedented abuse of power by masked federal agents. It's time to demand Beacon Hill rein them in.

Hundreds of incidents of federal agents concealing their faces have already been videoed by our neighbors. These masked 'agents,' who also refuse to wear badges, terrorize our streets, shopping centers and parks. And soon, there will be 10,000 more ICE agents on our streets, thanks to Trump's OBBB (One Big Bill of Betrayal) which made ICE the most funded law enforcement agency in the history of our country.

But there's a solution in Massachusetts.

The **Unmask I.C.E. Act** ([HD.4886](#)) would prohibit ALL law enforcement officers who operate in MA from wearing masks and require them to have a name or badge number on their uniforms. Take these actions to help pass HD. 4886.

<p>Action Summary</p> <p>Details on each action are below.</p>	<ul style="list-style-type: none"><li>• READ - The <a href="#">background info</a> below.</li><li>• (1) Call the <b>House Committee on Rules Chair</b> and <b>Vice Chair</b> and urge them to hold a committee hearing and move HD. 4886 “favorably out to the House floor for consideration.”</li><li>• (2) Call the bill’s Sponsor, <b>Representative James Hawkins</b> to ask how you can help move the bill forward and spread the word! Make the same call to <i>your</i> congressperson if they are on the <a href="#">List of Petitioners</a> (aka Cosponsors) for the petition presented by Rep. Hawkins.</li><li>• BONUS:<ul style="list-style-type: none"><li>○ Track the bill docket to watch progress through committees and votes. ## Background Information

### ***Our actions are working! -***

7/17/25 - *Fifteen days* after releasing the below background information in the 7/2/25 dispatch of The CAD, Representative Jim Hawkins and others presented House Docket (HD).4886, "An Act Ensuring Law Enforcement Identification and Public Trust" and it was immediately referred on to the MA House Rules Committee. Massachusetts *and* California now both have legislation underway to **unmask I.C.E.** and other law enforcement.

Then, through [Change.org](https://www.change.org), Cape Cod Coalition for Safe Communities created a petition to support House Docket 4886. It only takes a moment to sign on!


