In addition to creating his own organization, Shirika La BAMBUTI, whose work he coordinates in the provinces of North Kivu, South Kivu, and Maniema, Joseph has been director or coordinator of several local and provincial organizations defending human and Indigenous Peoples' rights. As such, he has represented indigenous peoples in international meetings of the UN, the Convention on Biological Diversity, and the World Bank.
