Washington Conservation Action works to protect Washington's air, water, land, and democracy. To defeat Initiative I-2117, they are focusing on increasing voter turnout among younger and Latino voters across the state, particularly in Washington's 3rd Congressional District. This effort includes site-based and door-to-door engagement in key communities. Collaborating with community partners, they will conduct site-based persuasion and voter registration at community colleges, provide in-language outreach to Latino voters, and engage suburban neighborhoods through door-to-door contact. By utilizing a shared voter file with partners,

Washington Conservation Action will ensure real-time data updates to maximize efficiency and impact.
