1.0 Welcome/Call to Order

4.0 Purpose of the Meeting.

• Michael Brennan stated that the purpose of the meeting was to provide all Athletic Directors the opportunity to express themselves and to create proposals. Michael Brennan stated, "We value Athletic Directors and the work that each of you perform. We know that you are well aware of athletics and are the experts at your school." Dr. Dahlem supported this and stated, "Before we meet with principals it is important that we hear from our Athletic Directors." Michael Brennan expressed, "Today we need your help providing most likely three Football Only proposals and three All Other Sports Proposals."

• Dr. Dahlem presented the difference between a Conference vs. League. He stated, "A conference has only one criterion, competitive equity. A League must follow all three criteria: equity, geography, and enrollment."

- e. All Other Sports counterproposals (does not include Football) will be presented and

discussed.

f. All Other Sports vote to choose the top three. (Does not include Football)

g. If FOC is opposed, All Sports (including Football) Relief Proposal presentations and

discussion.

- h. All Sports (including Football) counterproposal presentations and discussion.
 - i. All Sports (including Football) Relief Proposal vote to choose the top three proposals.
 - Orange High School presented Proposal #1. Athletic Directors were invited to the microphone to speak for and against this Football Only Conference Proposal. No one came forward to speak.
 - Los Amigos High School presented Proposal # 2. Athletic Directors were invited to the microphone to speak for or against this Football Only Conference Proposal.

- Michael Brennan reviewed Bylaw 25 (Voting)

- After no further discussion, Michael Brennan asked for a motion to reduce the number of proposals from five to three. Villa Park High School motioned to move from five proposals to three proposals. El Modena High School seconded the motion. The motion was unanimously approved (hand vote).
