

## **Benefits of Membership in the Conservation Measures Partnership**

Why should your organization join the Conservation Measures Partnership (CMP)? CMP membership provides numerous benefits including:

1. **Improved conservation outcomes** - provides access to experienced practitioners which strengthens implementation of projects and supports improved outcomes.

2. **Credibility with donors** - signals institutional commitment to best practices, including monitoring, evaluation, and learning which makes an organization more attractive to donors. Also, several foundations are members of CMP, including the Gordon and Betty Moore Foundation, Margaret A. Cargill Philanthropies, Walton Family Foundation, [and others](#), therefore membership provides opportunities for members to learn and improve conservation practice together.

3. **Leadership in the conservation sector** - lead a movement that is gaining traction around the world.

4. **Influence** - influence the broader conservation community, and have an outside impact.

5. **Networking** - Provides opportunities for connection and intellectual exchange with strong and influential conservation organizations including the World Wildlife Fund, The Nature Conservancy, the Wildlife Conservation Society, and [many others](#).

6. **Learning** - Provides opportunities to learn from organizations facing similar challenges related to project design, project management, monitoring, evaluation, and learning.

7. **Guidance and tools** - facilitates access to training materials and software to support conservation projects.

8. **Funding** - CMP members have access to small grants to advance strategic CMP initiatives. Members can also apply for need-based travel grants to support attendance at CMP events.
