Undesignated Anomaly No. 6601:

The Echo Spider

Special Containment Procedures:

UA-6601 is currently contained in the large testing chamber found in the Research Wing. Formal containment procedures require further research and evaluation.

UA-6601 should not have contact, of any kind, with another SCP or anomalous entity without approval from appropriate leadership. Research and NTF personnel



should be present for any deliberate or accidental cross-testing with UA-6601.

Description: UA-6601 is the temporary designation given to a male Mexican Red Knee tarantula (Brachypelma hamorii). UA-6601 is observed to roughly be the size of a fully grown adult human male, specific measurements are pending. UA-6601 is observed to behave abnormally when compared to spiders found across the United States. Due to its large size, it was expected that UA-6601 would show some form of aggression to human-sized prey, however there has been no observed signs of aggression (1). UA-6601's spider webs also form unusually, observations show no bridging strands anywhere in the middle of their webs (2). UA-6601 has glossy, black eyes. UA-6601's silk is noted to have an unusually high level of tensile strength, formal testing pending.

UA-6601 is observed to "echo" the anomalous abilities of other entities that come into physical contact with it. See Addendums <u>UA-6601-A</u> and <u>UA-6601-B</u>.





UA-6601 is observed to respond to thaumaturgical stimuli. UA-6601 was noted to have particular "interest" in MTF Xi-8 operatives, which supported containment efforts.

Discovery: UA-6601 was discovered on 12/28/2024 around 1830 PST outside of the Site-66 safe zone in the West forest. Multiple initial reports came from MTF Xi-8 and MTF Nu-7 personnel; Dr. Jarvis Hardman was dispatched with an MTF Epsilon-11 escort. Prior to the researcher being dispatched, UA-6601 was engaged by MTF Xi-8 and MTF Nu-7 personnel. UA-6601 sustained multiple minor injuries (bullet wound grazes) to its thorax and legs. Upon Dr. Hardman's arrival, UA-6601 was observed slightly bleeding hemolymph from the points of injury, however, it was not a lethal amount. UA-6601 took shelter on a tree, making varying hissing noises to the responding team. UA-6601's physical appearance, besides their injury, looked like an extremely starved spider. UA-6601's abdomen was unusually small, especially given its large size. Dr. Hardman further observed an MTF Xi-8 Operative attempting communication (through indescribable means) with UA-6601, however, their attempts were met with hissing. At this point, Dr. Hardman noted UA-6601's particular "fondness/interest" with MTF Xi-8. When a sample of their web was collected, researcher noted that an unusual aura radiated from the cup, similar to the MTF Xi-8 Operative attempting to interact with UA-6601. This specific sample will hereafter be referred to **UA-6601-001**.

MTF Xi-8 slowly returned inside the safe zone, garage, then later down the elevators. UA-6601 was observed following the MTF Xi-8 operatives from a safe distance, almost as if they were stalking them. Once UA-6601 was inside Foundation walls, it was directed by the MTF Xi-8 operatives through non-verbal pointing inside of the elevators. UA-6601 crawled around the entrance zone, eventually forming a web near the checkpoint connecting the EZ and LCZ.





Addendum UA-6601.A: Encounter between UA-6601 and SCP-106

The initial encounter between UA-6601 and SCP-106 was not formally documented. However, the following are observations noted near the tail end of the encounters effects on UA-6601.



Dr. Jarvis Hardman exited the

medical bay and found UA-6601 covered in a black, tar-like substance which was identified to be the same corrosion produced by SCP-106. UA-6601's abdomen was also larger than previously observed, as if it ate a full course meal (what it exactly ate is unknown, but we can speculate). Dr. Hardman quickly inspected the strands of web thrown across the hallway, noting that they were quickly corroding and began snapping on their own. This observation is especially strange because UA-6601's "normal" strands of web were observed to have an extremely high tensile strength. Also, UA-6601 did not appear physically or behaviorally distressed while covered in SCP-106's corrosion.



A paramedic and general security were found observing UA-6601. The paramedic carelessly ran through the web, burning away at their clothes and skins. However, they initially seemed unfazed. The paramedic approached UA-6601 with their hand reached out, speaking to it as if it were trying to calm it like a puppy. UA-6601 quickly snatched the paramedic's hand, beginning a "tug of war" where the paramedic tried to get their hand back (see left).


UA-6601 pulled the paramedic into the ground; it is believed UA-6601 dragged the

paramedic into a pocket dimension. However, further testing is required to confirm if the pocket dimension belongs to SCP-106 or if it is independently made by UA-6601.

Eventually, the paramedic and UA-6601 returned from this pocket dimension through the ceiling. The paramedic appeared to be lightly covered in this corrosive substance, they hobbled to the side, sat down, and



began rambling to themselves in a psychotic breakdown. A few moments later, the paramedic screamed at UA-6601 demanding to be dragged back into the pocket dimension. It is unsure if this was due to their altered mental status or if this is an unknown side effect of UA-6601. The paramedic was promptly dragged back into the pocket dimension. UA-6601 later entered the medical bay, the corrosion slowly disappearing from their body - as if it were being absorbed by UA-6601 - and formed a new spider web in a corner. As they finished absorbing the corrosive substance, the paramedic was spit out by UA-6601 completely covered in corrosion. UA-6601 was observed with a surprised reaction, as if it didn't mean to spit out the paramedic.

Addendum UA-6601.B: Encounter between UA-6601 and SCP-999

There are no supporting photographs for this encounter.

After the events described in Addendum UA-6601.A, SCP-999 appeared in the medical bay which piqued the interest of UA-6601. UA-6601 came down from the ceiling and tried wrapping SCP-999 in its web, however, SCP-999 made physical contact with UA-6601 which resulted in an immediate behavior change. SCP-999 slowly absorbed UA-6601's legs and thorax, resulting in UA-6601's entire body turning the color orange.

MTF Epsilon-11 personnel then lured SCP-999, with UA-6601 absorbed, with candy towards the Research Wing's testing chamber. UA-6601 was successfully contained






inside the testing chamber then SCP-999 was lured out. UA-6601, formed a new web inside the testing chamber and slowly returned to its normal appearance.

As SCP-999 left the testing chamber, UA-6601 appeared to keep a constant eye on SCP-999 through the walls, despite the walls obstructing its view. Dr. Hardman observed the orange bands/stripes on UA-6601's body seemed to appear brighter, likely due to the continued proximity of SCP-999. Dr. Hardman, while in front of UA-6601, held up the specimen UA-6601-001 to gauge a response. The webs inside the container appeared slightly different and the unusual aura radiating from the cup seemed to have faded somewhat.




