**CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA)  
INFORMED CONSENT, ASSUMPTION OF RISK, WAIVER / RELEASE  
TERMS AND CONDITIONS**

THE FOLLOWING RULES SHALL GOVERN THE RIGHTS, PRIVILEGES AND OBLIGATIONS OF A MEMBER OF CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) (THE "MEMBER").

**I. DOJANG:** CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) (the "Company"), whose principal objective is to provide wellness through sports and fitness for the Members, has appointed a Management Team (the "Management") which shall be responsible for the daily operation of CALSMA.

**II. MEMBERSHIP**

**2.1 Age Requirement:** An applicant below eighteen (18) years old is required to obtain consent from his/or parent/guardian. Parent / Guardian must be the one to submit the application of enrollment on behalf of the student who is a minor.

2.2. Application: The management reserves the right to reject any membership enrollment without obligation to advise the applicant of the reason for such rejection.

2.3 Acceptance: Upon submission of the membership fees and payment of all required dues, the member shall be entitled to all the rights and privileges exercisable by the type of program, and bound by the Dojang rules.

2.4 Non-Transferability: Membership is personal to the Member and shall be non-assignable and non-transferable. A Member shall not allow anyone to use his/her Membership privileges.

2.5 Registration: The Member must check in through the attendance app every time he/she enters the Dojang.

2.6 Termination: Until Management receives written notice/ email of termination of Membership, a Member automatically continues his/her Membership payments even after the expiration of his/her Membership term. The member may email us at [admin@calsma.com](mailto:admin@calsma.com).

2.7 Failure to Renew: A renewal link will be emailed to members before their program expiration date. If renewal is not completed by the expiration date, management reserves the right to apply additional fees or adjust membership rates to the current pricing.

2.8 Grandfathered Rates: The grandfathered rate at renewal has been offered as a courtesy by management and is not guaranteed. Management reserves the right to discontinue or modify this rate at any time and for any member, with a minimum of 30 days' notice if the rate is set to increase. Continued eligibility for the grandfathered rate is at the sole discretion of management.

### **III. FEES AND DUES:**

Members shall pay the following:

3.1 MEMBERSHIP FEES: A member shall pay the Membership Fee as specified by the Management. The initial sign up fee, if there is one, is non-refundable and shall become due immediately upon the acceptance of the enrollee as the Member. The rates indicated at the time of enrollment are subject to change without prior notice. Membership fees cover the specific sessions you signed up for and do not include additional products or other services such as belt tests,

special events, other fitness programs, tournaments, special coaching fees, sparring gear, merchandise, apparel...etc.

**3.2 DUES and DEADLINES:** A member shall pay the Membership Dues in advance by means of automatic debit of his/her credit or ATM card. The prorated fees/ amount, if applicable, will be due on the first day of class. The \$50 non-refundable membership sign-up fee, if applicable, is due immediately during sign up.

A \$10 Late Fee will be charged per month for delinquent payments. If the Bank rejects the credit card, then the Member shall promptly pay the membership dues in cash or immediately inform and provide the new credit card number. Any denied payments will be subjected to a \$25 denied payment charge.

Administrative fees may be charged in addition to any fees and purchases. Such fees may be merchant fees that are charged by credit card companies and the processing bank or for shipping and handling of gears / apparels ordered.

Delinquent Payments of more than three (3) months will be sent to a Collection Agency. Management reserves the right to charge additional fees for delayed payment of the membership dues.

**3.3 DUES ASSESSMENT:** The Monthly Dues may be increased, subject to thirty (30) days written notice to the member.

#### **IV. PRE-TERMINATION OF MEMBERSHIP & ADDITIONAL TERMS & CONDITIONS**

4.1 Depending on a type of membership program, a member may pre-terminate his/her Membership by giving written notice to the Management at least thirty (30) days before the first day of the effective month. Pre-termination may incur penalties or requirements to finish the contract term.

#### **Contract: MONTH to MONTH**

- May cancel at any time, no cancellation penalty
- Must inform management 30 days prior to cancellation through written notice (email:admin@calsma.com)

### **Contract: ONE YEAR GOAL - PAID IN FULL | PREPAID**

- Non-refundable when pre-terminated
- Must inform management 30 days prior to cancellation through written notice (email: [admin@calsma.com](mailto:admin@calsma.com))

### **Contract: ONE YEAR GOAL – 12 month INSTALLMENT**

- Must continue to pay installment monthly dues until the end of contract term when pre-terminated.

Calculation: monthly due amount x remaining months = penalty amount

- Must inform management 30 days prior to cancellation through written notice (email: [admin@calsma.com](mailto:admin@calsma.com))

Please note:

This package requires a full membership payment to be completed in equal monthly installments over a set period. The total cost is divided equally, and the full payment must be made within the designated timeframe starting from the membership start date.

### **Contract: TRANSFERRED FROM More Than Medals (Taekwondo)**

(ref: MTM Terms and Conditions)

A Member who pre-terminates his/her Membership before the expiration of the Minimum Membership Period (contract) shall pay an amount equivalent to the total Monthly Dues payable until the end of Membership Period.

Calculation:

- o monthly due amount x remaining months = penalty amount
- o prepaid 1 year membership is non-refundable

This package requires a full membership payment to be completed in equal

monthly installments over a set period. The total cost is divided equally, and the full payment must be made within the designated timeframe starting from the membership start date.

### **Contract: TAEKWONDO PRIVATE CLASSES**

Please review the terms and conditions for each category below:

#### **PRIVATE CLASS: ONE CLASS | Private ONE on ONE Class (40 Minute Class)**

##### **TERMS & CONDITIONS:**

- A one-time non-refundable \$50 sign up fee / membership fee is required per student
- All sessions must be paid in full on the day of registration (with credit card / ACH on file)
- Please confirm the days of class appointments with the Master, Coach or Instructor first prior to registration
- Sign Up fee is non-refundable even if all classes have been canceled.
- Class cancellation policy: must inform the Master, Coach or Instructor at least 48 hours prior to class date.
- Any class canceled by the member within the 48 hours prior to scheduled class forfeits the class day credit.

#### **Semi-PRIVATE CLASS: ONE CLASS | Semi-Private GROUP Class (40 Minute Class)**

Exclusive Private Group Classes are great for a small group of friends or family (maximum of 6 students per class) who would like to train and learn martial arts together.

##### **TERMS AND CONDITIONS:**

- Must have a **minimum of two and a maximum six students** (usually a set of friends, siblings or family members).
- All students must sign up together at the same time or must complete registration prior to the first class session.
- If the student count drops to only one student, the class is now considered a One on One class and will change the rates based on One on One private class. Please see details in regards to Private One on One Classes.
- If a new student would like to sign up when the group classes have already completed its first session, the new student will need to request for the registration link to be added as a group class student. (pls email at [admin@calsma.com](mailto:admin@calsma.com)). The student must communicate to the group directly and obtain consent to join their group class prior to signing up.
- Please contact Master, Coach or instructor for availability ([admin@calsma.com](mailto:admin@calsma.com))

Please note:

- A one-time non-refundable \$50 sign up fee / membership fee is required per student
- All sessions must be paid in full with an automatic payment (with credit card / ACH on file) on the day of training.
- Semi Private Lessons require a confirmed scheduled date and time / appointment at least 1 week before the class.
- Please note that the Sign-Up fees are non-refundable, even in the event of class cancellations initiated by the students. Additionally, Membership/Class Fees will be charged if a class is canceled by the member/student within 48 hours prior to the scheduled class.
- There isn't a provision for a "makeup class" for students who miss the Exclusive Private Group Class. However, they have the option to convert the missed group class into a personalized One-on-One private lesson, albeit with a rate adjustment

**TERMS AND CONDITIONS**

- This plan is for students who would like a monthly automatic payment for 4 private lessons a month
- Please confirm the days of class appointments with the Master, Coach or Instructor first prior to registration
- Sign Up fee is non-refundable
- **Class cancellation policy:** must inform the Master, Coach or Instructor at least 48 hours prior to class date.
- Any class canceled by the member within the 48 hours prior to scheduled class forfeits the class day credit.
- Dobok/ uniform is not included in the package, please order your Dobok using this [LINK](#)
- Sparring Gear is not included in the package, if required, please order your gear using this [LINK](#)

### **CONTRACT: SPARRING COMPETITION CLASSES**

Please review the terms and conditions for each category below:

#### **MONTH TO MONTH: SPARRING COMPETITION CLASSES**

- May cancel at any time, no cancellation penalty
- Must inform management 30 days prior to cancellation through written notice (email:admin@calsma.com)

#### **3 MONTHS PACKAGE | \$420/ month: SPARRING COMPETITION CLASSES**

##### **Installment Payment Plan for 3 Months**

- Must continue to pay installment monthly dues until the end of contract term when pre-terminated.
- Penalty Calculation: monthly due amount x remaining months = penalty amount
- Must inform management 30 days prior to cancellation through written notice (email:admin@calsma.com)

**\*\*PLEASE NOTE\*\***

This package requires a full membership payment to be completed in equal monthly installments over a set period. The total cost is divided equally, and the full payment must be made within the designated timeframe starting from the membership start date.

For example, this package requires a three months membership payment which is a total of \$1,260.00 with the requirement to pay with uninterrupted installments for 3 months, which equals \$420 per month. This means that a full total payment of \$1,260.00 must be paid within a 3 month period from the membership start date.

### **ONE YEAR COMMITMENT | \$300 /month | Installment Payment Plan for 12 months**

#### **\*SPARRING TEAM MEMBER\***

- Must continue to pay installment monthly dues until the end of contract term when pre-terminated.
- Penalty Calculation: monthly due amount x remaining months = penalty amount
- Must inform management 30 days prior to cancellation through written notice (email:admin@calsma.com)

#### **\*\*PLEASE NOTE\*\***

This package requires a full membership payment to be completed in equal monthly installments over a set period. The total cost is divided equally, and the full payment must be made within the designated timeframe starting from the membership start date.

For example, this package requires a one year membership payment which is a total of \$3,600.00 with the requirement to pay with uninterrupted installments for 12 months (one year), which equals \$300 per month. This means that a full total payment of \$3,600.00 must be paid within a 12 month period from the membership start date.

### **TRIAL CLASSES**

Trial Classes are valid exclusively for group classes and cannot be applied to semi-private or private lessons. This offer is for one-time use only and cannot be repeated or combined with any other promotions.

#### **IVa. PRE-TERMINATION OF MEMBERSHIP:**

##### **Competition Team Classes**

4a.1 Depending on a type of package (/discounted packages), a member may pre-terminate his/her Membership by giving written notice to the Management at least thirty (30) days before the first day of the effective month. Pre-termination may incur penalties or requirements to finish the contract term.

4a.2. Understand that while California School of Martial Arts LLC will provide students with quality training, participation in the program does not guarantee that the student will become a champion. Progress and successes during tournaments and competitions will depend on dedication, effort and commitment to training as well as the skills of both CALSMA students and their opponents.

4.2 CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) shall have the right to automatically charge the credit card of the Member.

4.3 The Member may pre-terminate or put their membership on hold without penalty due to the following reasons:

- (a) The Member has moved 25 miles away from CALSMA (proper documentation is required such as utility bill or driver's license showing the new address)
- (b) Due to medical reasons (original signed physician's letter required)

#### **Membership Cancellation and Renewal Policy:**

California School of Martial Arts LLC (CALSMA) reserves the right to cancel any membership or decline to offer a renewal at any time, for any reason, without prior notice. This includes, but is not limited to, violations of CALSMA's policies, inappropriate behavior, or actions that compromise the safety, well-being, or integrity of the school, its staff, or other members.

By enrolling, members agree to adhere to CALSMA's policies and understand that continuation of membership is subject to the discretion of CALSMA management.

#### **V. TOURNAMENTS**

## Tournament Participation Agreement

Participation in tournaments is optional for most students but may be required under specific circumstances as part of the curriculum at California School of Martial Arts LLC (CALSMA). By choosing to join a tournament, you acknowledge and agree to the following terms:

### 5.1 Participation Requirements:

- **Black Belt Promotion:** Participation in at least one tournament is a mandatory requirement for students aiming to be promoted to black belt.
- **Sparring Team Members:** All members of the CALSMA Sparring Team are required to participate in designated tournaments as part of their team commitment.

### 5.2 Assumption of Risk and Liability Waiver:

You understand that participation in tournaments involves physical activity and competition that may result in injuries. By participating, you assume all risks associated with the tournament. CALSMA, its owners, masters, coaches, instructors, and staff are not liable for any injuries, accidents, or damages incurred during tournament participation or related activities.

### 5.3 Transportation and Accommodation:

Transportation to and from tournaments, as well as accommodation and meal arrangements, are the responsibility of the participant.

### 5.4 Coaching Fees:

Coaching fees are required for each tournament to cover the costs incurred by CALSMA, including but not limited to the accommodation, transportation, and meals for masters, coaches and instructors. These fees are not included in regular membership tuition and must be paid in advance of the tournament.

### 5.5 Use of Time:

The time of masters and instructors dedicated to tournament coaching is separate from the regular membership benefits. Coaching fees are necessary to compensate for their time and effort during the tournament.

## VI. SAFETY AND PHYSICAL CONDITION:

A Member warrants and represents that he/she is in good physical condition and that he/she knows of no medical or other reason why he/she is not capable of engaging in active or passive exercise, and that such exercise would not be detrimental to his/her health, safety, comfort or physical condition. A Member also represents that he/she suffers from no physical impairment that would prevent his/her use of the Dojang or adversely affect his/her decision to participate in any activity of the Dojang.

6.1 Members suffering from the infectious or contagious illness, disease, or ailments shall not enter nor use the Gym where there is a risk to the health, safety or physical condition of the other Members.

6.2 The Dojang reserves the right to refuse entry to any Member for safety, health, and security reasons and each Member agrees to hold CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) free and harmless from any and all claims, damages, or liability arising from such refusal.

6.3 Proper Equipment:

TAEKWONDO: All students at the Yellow Belt level and above are required to wear full sparring gear on designated sparring days. Using proper attire and **World Taekwondo Federation-approved gear** ensures safety during training and competition.

WTF approved gears are sold at the Dojang. If a student purchases sparring gear elsewhere, it is the responsibility of the student and parent to ensure the gear meets safety standards and is World Taekwondo Federation-approved. CALSMA is not liable for any injuries incurred when non-approved gear is worn during class

TAEKWONDO: All students must wear the proper, required uniform during class. Accepted Dobok / uniforms to be worn in class are from CALSMA and MTM only. CALSMA Dobok / uniform is required to be worn during competitions, tournaments and outside activities (*events, parades...etc*). No outside apparel are allowed to be worn during practices. Only CALSMA apparel are allowed.

BOXING:

All adult students participating in sparring or advanced training must wear full protective gear. USA BOXING and CALSMA approved boxing gear is available for purchase at the gym. If a student chooses to purchase equipment elsewhere, CALSMA is not liable for any injuries incurred when non-approved gear is worn during class.

#### 6.4 PARENT/ GUARDIAN ON BEHALF of a STUDENT who is a MINOR:

I, the undersigned, on my own behalf, and as the parent or legal guardian of the child(ren) listed on this application, in consideration of the request and permission of my son(s)/daughter(s) to participate in California School of Martial Arts LLC (CALSMA) programs, including, but not limited to Life Coaching Class and special events, Movie Nights and Camps, hereby assume full responsibility for all risks of injury or loss which may result from my and my son's/daughter's attendance and/or participation in these activities and hereby agree to indemnify, hold harmless, release and forever discharge California School of Martial Arts LLC (CALSMA) and its franchisees, as well as their owners, officers, agents and employees ('Releasees') and waive any and all claims, demands, losses, damages and liabilities whatsoever that I or my son(s)/daughter(s) sustain with respect to any accident, illness, injury or death of any person and persons, or damage to or loss or destruction of any property arising or resulting directly or indirectly from my son's/daughter's participation in the aforementioned program and occurring during said participation or any time subsequent thereto, whether caused by the active or passive negligence of the Releasees, or otherwise, to the fullest extent permitted by law. The terms of this release shall serve as a release, assumption of risk and waiver for me and my son(s)/daughter(s), heirs, executors and administrators and for all my family members. If any portion of this release, assumption of risk and waiver is held to be invalid under law, the remaining portion shall continue in full force and effect. I consent to my son(s)/daughter(s) participation in the California School of Martial Arts LLC (CALSMA) programs and understand that there are risks inherent in activities conducted by California School of Martial Arts LLC (CALSMA) including, but not limited to, paralyzing injuries, brain injuries, and death. With the full understanding of the facts, I state, that to the best of my knowledge, my son(s)/daughter(s) listed on this application has no medical, physical, mental or emotional health conditions or other impediment which would hinder or prevent his/her active participation in California School of Martial Arts LLC (CALSMA) programs. I further state as a parent or legal guardian of the child(ren) listed on this application, if I participate in any Parent and Child lesson program, Family Training Days and or any special events that I am in good physical condition. Please note, all policies are subject to change. Our web page will reflect our most recent policies: [www.calsma.com](http://www.calsma.com). I have read and understood, and I agree with the informed consent, release, assumption of risk, and waiver outlined above as it relates to me and my son(s)/daughter.

## **VII. GYM ETIQUETTE:**

A Member is required to abide by the following rules:

7.1 All Members are required to wear their CALSMA dobok or during training.

7.2 Food and/or drinks are prohibited in the mat area.

7.3 The entire Dojang is a Non-Smoking area. A person under the influence of alcohol, narcotics, and other mood-altering substances is prohibited in the Dojang.

7.4 Since CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) desires to foster a healthy environment for its Members, cussing, untoward behavior, and the like is strictly prohibited in the Dojang.

7.5 Short Message System (SMS) known as "texting" or use of mobile phones is prohibited while class is going on. Phone calls/SMS should be done outside of the training premises.

7.6 Members and students are not allowed to stay in the dojang hours beyond (after or prior) their scheduled class time. California School of Martial Arts, its owners, volunteers and staff will not be liable for students who overstay in the dojang. If the student has a sibling in a different class time, the sibling must be dropped off or picked up in accordance with their proper class times. If the sibling must stay and wait for another sibling's class to end, please make the proper plans for a parent or a guardian to be with your child at all times when they are no longer participating in class. Failure to comply will result in possible fees, penalties and or termination of their current membership.

### **7.7 Code of Conduct and Anti-Defamation Agreement**

California School of Martial Arts LLC (CALSMA) is committed to fostering a respectful, supportive, and professional environment for all members, parents, guardians, staff, and volunteers. To uphold this commitment, the following policy applies:

#### **1. Respectful Communication:**

Members, parents, and guardians are expected to communicate respectfully and constructively about any concerns regarding CALSMA, its

owners, staff, or volunteers.

**2. Complaint Resolution Process:**

If you have a concern or complaint, we encourage you to address it promptly and directly with Master Jun. Open dialogue is essential for resolving issues in a fair and timely manner.

**3. Prohibition of Defamation and Slander:**

The dissemination of false or malicious statements intended to harm the reputation of CALSMA, its owners, staff, or volunteers is prohibited. This includes, but is not limited to:

- Public or online statements that misrepresent facts about CALSMA or its community.
- False accusations or harmful rumors that negatively impact CALSMA's reputation.

**4. Consequences for Violations:**

Actions such as defamation or slander may result in disciplinary measures, including but not limited to the suspension or termination of membership. CALSMA reserves the right to take appropriate legal action if false or harmful statements cause significant damage to the business or its community.

**5. Freedom to Share Feedback:**

CALSMA values constructive feedback and encourages open discussions regarding areas for improvement. This policy does not restrict your ability to express honest opinions or valid concerns in good faith.

## **VIII. OTHER RELEVANT TERMS AND CONDITIONS**

8.1 Class schedules may occasionally be adjusted by management for holidays, martial arts tournaments, or special events. Any changes will be communicated in advance through general announcements or on our website. Please note that dojang closures for these reasons are already factored into membership plans and will not affect membership fees.

8.2 The names of members, along with any photographs or videos taken by staff and owners during California School of Martial Arts LLC (CALSMA) activities, may be used for promotional purposes. Members are permitted to take photographs or videos of their own child during training; however, they are strictly prohibited from recording or photographing other students. Additionally, members must not post images or videos of other children on social media without explicit permission from their parents or guardians. This policy is in place for privacy and security reasons.

8.3 Guests and Members not enrolled and not part of the class are prohibited from the training premises/ mat.

8.4 Members must inform the instructor/coach when they need to go out of the training area.

8.5 Parents, guardians, or guests should wait in the designated waiting areas. All other rooms (storage rooms, owner's lounge and private offices) are off limits to the public.

8.6 Lost property found in the Dojang will be held by the Management for a period of one month from discovery, after which CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) reserves the right to dispose of the items in any way it sees fit. No claims shall be entertained after this period. CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) is not responsible for items lost in the dojang.

8.7 Members and students are not allowed to stay in the dojang hours beyond (after or prior) their scheduled class time. California School of Martial Arts, its owners, volunteers and staff will not be liable for students who overstay in the dojang. If the student has a sibling in a different class time, the sibling must be dropped off or picked up in accordance with their proper class times. Failure to comply will result in possible fees, penalties and or termination of their current membership.

8.8 **For Private Lessons:** A one-time non-refundable \$50 sign up fee / membership fee is required per student. All sessions must be paid in full with an automatic payment (with credit card / ACH on file) on the day of training. Classes require a definite scheduled date and time / appointment at least 1 week before the class. Exclusive Private Group Lessons must have at least 2 students and maximum of 6 students and all students must sign up together at the same time. Sign Up fees remain non-refundable even if all the classes have been canceled by the students. Membership / Class Fees are charged if the class is canceled by

the member/student within 2 days prior to scheduled class. If the student count drops to one student, the class is now considered a One on One class and will change the rates based on One on One private class. If a new student would like to sign up when the group classes have already completed its first session, the student will need to register under the One on One rate as well as pay the sign up fee. Please reach out to us at [admin@calsma.com](mailto:admin@calsma.com) to confirm availability prior to signing up.

## **IX. INTELLECTUAL PROPERTY RIGHTS**

9.1 California School of Martial Arts LLC (CALSMA) and/or its licensors own all rights to the intellectual property and material contained in our website, marketing materials, photos, videos, films, company logos, slogans, and company name.

9.2 California School of Martial Arts LLC (CALSMA) logos may not be reproduced or used for personal clothing or materials without written consent from management or the owners.

## **PHOTOGRAPHY AND VIDEOGRAPHY WAIVER**

9.3 By participating in any California School of Martial Arts LLC (CALSMA) activities, you grant the school permission to use any photographs, videos, or recordings of yourself or your child(ren) taken during classes, events, or activities for promotional, educational, or informational purposes, including but not limited to social media, websites, and marketing materials.

9.4 If you do not wish for photos or videos of yourself or your child(ren) to be used, you must submit a written request to management prior to participation.

## **X. NO LIABILITY CLAUSE**

10.1 The Member holds CALIFORNIA SCHOOL OF MARTIAL ARTS LLC (CALSMA) (including its directors, employees, agents, coaches) free and harmless from any death, injury, loss or damage to his/her person or property arising from or in connection with his/her use of any of the services, programs and facilities of the Dojang.

10.2 Some features of the California School of Martial Arts LLC website or MyStudio app (available on iOS and Android) may require you to create an account with associated login credentials. Access to certain content, features, functionalities, or services may only be available to registered and logged-in users.

When creating an account, you agree to provide accurate, current, and complete information and to update your details as necessary to keep them current. You are responsible for maintaining the confidentiality of your login credentials and acknowledge that you are fully responsible for all activities that occur under your account, whether or not you authorized them.

If you suspect unauthorized use of your account or password, or if you become aware of any security breaches, you agree to notify California School of Martial Arts LLC immediately.

We reserve the right to deny account creation, suspend access, or terminate any account at our discretion. Additionally, we may modify or remove content, features, functionalities, or services available to account holders without prior notice or liability.
