#### 3. Action Items

# a. <u>Recommended Motion</u>: Approval of budget transfers from the 2022-2023 Operating Budget

Mr. Cascio MOVED that the Wethersfield Board of Education authorize a budget transfer from the 2022-2023 operating budget for the purpose of purchasing classroom technology infrastructure and student musical instruments.

**Background:** Mr. Emmett noted the district projects to finish the 2022-2023 school year under budget. The transfer of current operating funds will be applied to the purchase of requested classroom desktop computer units. These units are needed to replace current units whose operating systems will soon be obsolete. Funds will also be applied to the purchase of musical instruments for student use as this has not been funded in prior years.

# b. <u>Recommended Motion</u>: Approval of the 2023-2024 Wethersfield Public Schools Operating Budget

Mr. Cascio MOVED that the Wethersfield Board of Education approve the revised Operating Budget for the 2023-2024 school year in the amount of Sixty-One Million, Eight Hundred Sixty-Three Thousand, One Hundred Sixty-Six (\$61,863,166) Dollars, as allocated by the Wethersfield Town Council.
