- 1. Call to Order at 6:35 pm
 - a. Roll Call- All present except for Brenda Willis, MaryAnn Connors-Krikorian, Derick Anderson, Adam Burch, Jake Crowley arrived at 6:40. Shannon Hudson left at 7:00

Jen Lague, on behalf of the Nominating Committee, introduced potential board member, Craig Cerino. Craig is a parent of a student currently enrolled at Next.

Motion made by Katie Anderson to nominate Craig Cerino for a 1 year term as a Next Charter School Board member. Seconded by Jen Lague. Motion approved unanimously.

3. Student Presentation - Discussion

Joe Crawford introduced three first year students at Next. Each student shared why they had chosen Next, and how the transition has been for them. One student had been at GHH and had come to Next for numerous lunches, one had been at WRBMS and knew about Next, and the other, non Derry student, had followed Next from its beginning, and after being placed on the waitlist last year, had been offered a seat at Next. All agreed that the group was welcoming and the transition had been fairly easy. Katie Anderson, acknowledging that it was early in the year, asked the students to consider the concept of no fixed deadlines, submissions, and suggestions to better the work. And also to consider whether the result was better or the same as in a traditional school. When asked by Jen Lague what was planned for after Next, there were hopes for college, law enforcement, the military and possibly engineering.

Joe Crawford reported 65 students students enrolled at Next, 52 derry/13 non derry. Since the last Board meeting, one Derry student has moved.

charter student is now treated the same as a homeschool student. Joe Crawford believes that an MoU should be in place, regardless, and the Next board agreed, in order to ensure that Next Derry students are afforded the same opportunities as Pinkerton Derry students. Next pays tuition for all Next students to attend Pinkerton classes, including non-Derry students. Further discussion included the possibility of again approaching sending towns regarding tuition along with the possibility of requiring students to take non-Next courses within their district. Joe Crawford noted that town funding for charter schools is a discussion being held statewide.

c. Outreach efforts to middle schools

Joe Crawford is scheduling time for WRB and GHH middle school staff members to visit Next. He has also planned visits to middle school classrooms and to 8th grade lunch at GHH. There is an Information Night planned for October 26, 2017 at Next.

d. NECAP Science School Results

Results for NECAP test taken last year were received this week. This test is taken by students in their junior year, or third year of high school, and for Next, this test showed improvement from last year. When asked if there was any benefit to the school if teaching was concentrated on this test, Joe Crawford replied that were was not specifically, but it can be good comparison for the school as a whole.
