Summary and Methodology

Preparing phase:

NCSG members who will be presenting should study relevant sections of the Applicant Support Program

Handbook (https://newgtldprogram.icann.org/en/application-rounds/round2/asp/handbook), the New gTLD Application (you'll have to use the 2012 version as the new application is still being finalized), and the Registry Service Provider Handbook (https://newgtldprogram.icann.org/sites/default/files/documents/rsp-handbook-17oct24-en.pdf) to prepare, and, when relevant, create a presentation summarizing the most relevant information.

The objective is to build and share knowledge within the non-commercial community and improve the leadership of our members in this area, while also clarifying potential doubts that could be relevant to non-commercial organizations applying for the ASP and for a new gTLD.

Those members should prepare and lead the presentation on separate topics about the ASP, mostly drawing from the new Applicant Support Handbook which was greatly improved with NCSG comments https://newgtldprogram.icann.org/en/application-rounds/round2/asp/handbook, and moving now (in this 2nd session) to discussing key aspects of the New gTLD Application, and thinking how noncommercial applicants for New gTLDs can find the "right fit" for a Back-End Registry Service Provider (also called an "RSP").

Everyone who agrees to present will also provide slides to the person coordinating the effort ahead of time (at least 3 days) to lay out what they plan to focus on - and before in presenting technical policy, it is very helpful for the audience to see as well as hear the details, terms, concepts and frameworks.

NCSG members should reach out to organizations who are planning to apply for the ASP and New gTLD Program, and collect questions they already have, so those doubts can be shared and debated in the session.
