

## **Sunnking Charity Terms & Conditions**

## E-SCRAP FOR CAMP & RECYCLE 4 RONALD TERMS AND CONDITIONS

***Last Updated: 04/22/2025***

Welcome to the e-Scrap for Camp and Recycle for Ronald fundraising campaign (the “Event”), organized and operated by **Sunnking, Inc.** (“Sunnking”). These Terms and Conditions (“Terms”) govern Your participation in the Event. By registering for or otherwise participating in **e-Scrap for Camp** (“e4c”) and or **Recycle 4 Ronald** (“R4R”), you agree to be bound by these Terms.

### 1. DEFINITIONS

- 1.1 **Event:** Refers to the annual e-Scrap for Camp and Recycle 4 Ronald fundraising campaigns.
- 1.2 **Sunnking:** Sunnking, Inc., the organizer of the Event, responsible for providing collection supplies, arranging pickups, and recycling all accepted electronics.
- 1.3 **Participant:** Any business or organization registering for or participating in the Event.

### 2. ELIGIBILITY

#### 2.1 Business-Only Event:

This Event is open exclusively to businesses and organizations located in the Buffalo, Rochester, and Whitesboro (Utica)-area in New York State. It is **not** open to individual consumers or the public.

#### 2.2 Non-Public Collection:

Participants must not advertise their facilities or collection efforts as open to the public. Sunnking will not accommodate or recognize Participants who promote their location as a public drop-off site.

#### 2.3 Regional Timelines:

- **Rochester** registration begins on **February 28<sup>th</sup>, 2025** and closes **March 28<sup>th</sup>, 2025**.
- **Buffalo** registration begins on **May 15<sup>th</sup>, 2025** and closes **June 14<sup>th</sup>, 2025**.
- **Utica** registration begins in **July 2025**.

### 3. REGISTRATION & SUPPLY DELIVERY

#### 3.1 Registration:

- Participants must register via the e-Scrap for Camp website, Recycle 4 Ronald website, or as otherwise indicated by Sunnking.
- Registration deadlines and availability may vary by region and will be communicated by Sunnking.

#### 3.2 Delivery of Materials:

- A Sunnking representative will confirm drop-off and collection dates via email before the event start date—approximately 4-6 weeks after registration opens.
- Boxes and pallets (“Collection Supplies”) will be delivered at no cost. Supply drop-off and pick-up dates will be chosen by Sunnking to fit Sunnking’s schedule, roughly two weeks apart.
- Participants will be notified of the supply drop-off date and pick-up date **before** the program begins.

### 3.3 Facility Requirements:

- Participant facilities must have **dock access** or ground-level access without stairs to accommodate pallets and a pallet jack.
- Collection Supplies must be **kept dry and indoors** to preserve their integrity.
- Requires a doorway **greater than 42" wide** to accommodate your materials.

### 3.4 Choosing Pallet Count & Over-Collection:

- Due to the high demand of this Event, Participants should **carefully choose** their pallet count upon registration.
- **No additional pallets or boxes** will be delivered if the Participant collects more electronics than the capacity of the originally requested pallets or boxes.
- Sunnking will **only** be able to arrange **one pick-up** per Participant. No multiple pick-ups will be scheduled.

## 4. COLLECTION AND PICK-UP PROCESS

### 4.1 Collection Period:

- Participants may collect electronics from their employees, friends, and family for a maximum of two weeks, using the provided Collection Supplies.
- Participants agree **not** to advertise to the public.

### 4.2 Pick-Up Schedule:

- Sunnking will pick up the electronics at roughly two weeks after supplies are delivered on a date that best fits Sunnking's schedule.
- If a Participant needs to reschedule, Sunnking **cannot guarantee** a revised pick-up date. If rescheduling is necessary, pick-up may be delayed to the earliest available time slot **at the end of the campaign**.

### 4.3 Accepted Items:

- Only materials listed on Sunnking's Acceptable Materials list are eligible for recycling.
- **CRT televisions and monitors** will be collected but **will not** contribute to the final donation due to higher recycling costs.

### 4.4 Ownership and Liability:

- Upon Sunnking's pick-up of electronics, ownership transfers to Sunnking.
- Participants are responsible for ensuring that all electronic items are properly stored and handled prior to pick-up to prevent damage or safety hazards.

## 5. DONATION & REPORTING

### 5.1 Donation to Camp Good Days and Ronald McDonald House of WNY:

- Sunnking will donate a portion of the proceeds from the recycling of accepted electronics to Camp Good Days or the Ronald McDonald House Charities, typically around October 1<sup>st</sup>.
- A per-pound rate of \$0.03 will be donated for eligible electronics (excluding CRTs).

## 5.2 Reporting & Certificate:

- Sunnking will track the net weight of collected electronics for each Participant and provide a final report, including a **Certificate of Donation**, to the email address provided at registration.
- The timing and format of these reports are at Sunnking's discretion and are subject to change.

## 6. DATA SECURITY

### 6.1 Data Destruction:

- Sunnking employs a multi-pass process to ensure 100% of data is permanently removed from all hard drives and data-bearing devices.
- Sunnking adheres to industry standards and holds R2v3 Certification for responsible recycling and data destruction practices.

### 6.2 Participant Responsibilities:

- The Participant is responsible for removing any sensitive data or proprietary information from devices prior to collection, if desired.
- Sunnking assumes no liability for data left on devices that are not intact or are otherwise damaged before receiving them.

## 7. USE OF MARKETING MATERIALS

### 7.1 Sunnking-Provided Materials:

- Participants will receive promotional materials from Sunnking via email that can be used to encourage internal collection among employees, friends, and family.

### 7.2 Public Advertisements:

- Participants must **not** promote themselves as a public drop-off site. This includes, but is not limited to, newspaper ads, TV or radio spots, or social media posts advertising the location as open to the public.
- Sunnking reserves the right to revoke a Participant's registration or refuse pick-up if the Participant advertises a public collection event in violation of these Terms.

## 8. LIMITATION OF LIABILITY & INDEMNIFICATION

### 8.1 Limitation of Liability:

- To the fullest extent permitted by law, Sunnking shall not be liable for any direct, indirect, incidental, special, or consequential damages resulting from participation in the Event, including but not limited to damages for loss of profits, data, or goodwill.

### 8.2 Indemnification:

- By participating, Participant agrees to indemnify, defend, and hold harmless Sunnking, its employees, agents, affiliates, and subcontractors from any claims or liabilities arising out of or related to the Participant's involvement in the Event, including but not limited to any misrepresentations, safety incidents, or unauthorized advertisements.

## 9. CANCELLATION & TERMINATION

### 9.1 Cancellation by Participant:

- Participants may withdraw from the Event by providing written notice to Sunnking prior to their scheduled pick-up date.
- No penalties apply if the withdrawal occurs before Sunnking delivers the Collection Supplies.

### 9.2 Termination by Sunnking:

- Sunnking reserves the right to terminate or suspend any Participant's involvement in the Event for any reason, including breach of these Terms, without notice or liability.
- In the event of termination, Sunnking is not obligated to provide donation credit for any collected electronics.

## 10. MISCELLANEOUS

### 10.1 Modification of Terms:

- Sunnking may, at its discretion, update or revise these Terms at any time.

### 10.2 Governing Law:

- These Terms shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of law provisions.

### 10.3 Entire Agreement:

- These Terms constitute the entire agreement between the Participant and Sunnking concerning the Event and supersede any prior or contemporaneous agreements.

### 10.4 Severability:

- If any provision of these Terms is deemed invalid or unenforceable, such provision shall be severed, and the remainder of the Terms shall remain valid and enforceable.

### 10.5 No Waiver:

- Sunnking's failure to enforce any right or provision of these Terms shall not constitute a waiver of such right or provision.
