Dear Governor Cuomo:

We are writing to request that frontline workers at food pantries, food banks and grab-and go-sites statewide be added to Phase 1B of the COVID-19 vaccine priority list. As COVID-19 continues to ravage our communities, food insecurity has continued to soar in our communities. Before COVID-19, New York was facing an unprecedented hunger and homelessness crisis; now, the crisis has exploded in vulnerable communities in every corner of the State.

According to City Harvest, more than 1.5 million New Yorkers are struggling to feed themselves and their families, a 38% increase over pre-COVID-19 figures. And one in four children or more are experiencing food insecurity, a staggering 49% increase over pre-COVID-19 times.

In recognition of the vital and lifesaving work they perform, food pantry and food bank staff and volunteers were deemed essential during the height of the pandemic. And to their credit, despite the risk to themselves and their families, these dedicated and brave New Yorkers showed up for work each day to ensure that food-insecure New Yorkers could eat and feed their families. They have not, however, been deemed essential for the vaccine. This should be changed.

As a result of the around-the-clock nature of the need, food pantry and food bank workers have been hard-hit by the COVID-19 pandemic. When a staffer or volunteer at a food pantry or food bank tests positive for COVID-19, the entire facility must be closed for cleaning, to allow for the proper quarantine protocols to be followed and to ensure adequate staffing levels.

When grab-and-go sites or food pantries are forced to close, New Yorkers and their families will go hungry. That's why food pantry, food bank and grab-and-go site staff and volunteers must be added to Phase 1B of the vaccine priority list.

We look forward to your immediate attention to this issue of vital importance for vulnerable New Yorkers. Should you require anything further, please do not hesitate to reach out. Thank you.
