NOW, THEREFORE, BE IT RESOLVED, the Common Council of the City of Hornell hereby authorizes Mayor Shawn D. Hogan to sign the Lowe's Project Memorandum of Understanding with the Village of North Hornell.

ON THE QUESTION: See Appendix B. Mayor Hogan said negotiations on this Memorandum of Understanding were supplemental to the PILOT agreement in the above resolution. Some aldermen had been contacted before this meeting by residents questioning the agreement, the Mayor said, yet no one showed up in person, "which is disconcerting to say the least." Mayor Hogan reviewed stipulations of the agreement, including North Hornell to be serviced by the City street sweeper, extension of the sewer agreement until 2031, free access to the City Compost Facility, no charge for pavilions at

Veterans Memorial Park at James Street, and inclusion in the City's contract for garbage collection. "We don't give up anything financially," the Mayor said. City Attorney Pelych asked who would bill for garbage, and the Mayor said the City would. Alderman Koehler commended the Mayor for negotiating the agreement, and added that the Lowe's store will make Hornell even more of a shopping hub while creating jobs. Alderman Norton said the City often has been criticized by outlying communities for involvement in projects like Lowe's, but that the City brings businesses and desired residential services that neighboring communities enjoy. Alderman Sciotti contrasted this Memorandum of Understanding with the current water controversy in the Village of Arkport and said Arkport declined to join the City's water system. "It goes to show you, it's a lot easier to share and work together," Alderman Sciotti said.

#5 – AUTHORIZE MAYOR TO SIGN MARCHISELLI AID AGREEMENT FOR RIVER STREET BRIDGE – HN-07-47

By Carbone/Testani:

(Authorizing the implementation, and funding in the first instance 100 percent of the federal-aid and state "Marchiselli" Program-aid eligible costs, of a transportation federal-aid project, and appropriating funds therefore.)

WHEREAS, a Project for the City of Hornell, River Street Bridge Replacement (BIN 22218220) over the Canisteo River, P.I.N. 6753.78 ("the Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ration of 80 percent Federal funds and 20 percent non-federal funds; and

WHEREAS, the City of Hornell desires to advance the Project by making a commitment of 100 percent of the non-federal share of the costs of City of Hornell, River Street Bridge Replacement (BIN 22218220) over the Canisteo River, City of Hornell, Steuben County, P.I.N. 6753.78;

NOW, THEREFORE, the Common Council duly convened does hereby RESOLVE, that the Common Council hereby approves the above-subject project; and it is hereby further

RESOLVED, that the Common Council hereby authorizes the City of Hornell to pay in the first instance 100 percent of the federal and non-federal share of the cost of Preliminary Engineering, Design, and Right of Way Incidentals work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$3,450,000.00 is hereby appropriated from River Street Bridge Account No. H5120.21 and made available to cover the cost of participation in the above phase of the project; and it is further

RESOLVED, that the Mayor of the City of Hornell be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the City of Hornell with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid

and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

RESOLVED, this Resolution shall take effect immediately.
