Good day!

We want to report about a Youtube channel (taekooklives) which was made in November 2017 and has been posting analysis videos of the interactions of BTS members that has been brainwashing a lot of fans to have negative views about the members. They used official BTS contents in their videos and earned money from their youtube channel. They are mistranslating the member's words that are misleading their viewers. They are spreading rumors about the members which can cause serious damage on their images, one particular video implies that the other members are homophobic using a clip from Run BTS. Recently, they uploaded a video accusing Park Jimin of lying which caused antis to continuously drag him on the comment sections and on other platforms like Twitter and Facebook.

Their analysis videos portray all the members negatively, especially Park Jimin. They are sexualizing the members' interactions especially Kim Taehyung and Jeon Jungkook and implies a toxic relationship between them which is full of jealousy and fight while using Park Jimin as the third party. These videos with almost 48M views are causing serious damage to all the members involved as new fans and other people who watched the videos start to hate Park Jimin and are becoming antis. There are also a lot of insulting comments from their subscribers toward Park Jimin in the comment sections because of the malicious contents of the videos. Their community board which they allow question and answer sessions now a platform to further spread malicious rumors about the members, some are actually accusing them of mental health problems.

We believe these matters are enough for you to consider taking legal action against them in order to protect the members for further damage their youtube account will make. We also want all their social media channels (Youtube channel, Twitter, Tumbr and Blog) to be taken down especially their youtube channel which they use to continuously spread false narratives about the members. We will be waiting for your actions about this issue and we hope it will be immediate as this person has been doing this for a long time now.
